## 3 Luis A. Dominguez, Private Security Identification No. 039212

Presented by Carissa White, Compliance Specialist

Reason for Notice of Intent to Propose Civil Penalty

Department investigation revealed Luis A. Dominguez violated Oregon Administrative Rule (OAR) 259-060-0450(2)(i) and (j) as Executive Manager for First Alert Security LLC in 2019, 2020, and 2021.

The Department determined that the conduct presented to the Private Security Investigator Policy Committee (PSIPC) violates the Private Security Services Providers Act (Act) and corresponding administrative rules. Through the case review process, the PSIPC will review the below-identified violations and determine whether to make a recommendation to the Board on Public Safety Standards and Training (BPSST) on the disposition of this case:

Employing private security providers who have not completed the training and application process required under the Act and corresponding rules.

Dominguez employed individuals to provide private security services at Capital Cantina in Salem, Oregon, on July 10, 2021.

Failure to employ a licensed executive manager.

Dominguez failed to employ a licensed Executive Manager from September 13, 2019, until January 22, 2020.

## 5. Program Manager Update

### Training Update:

- The self-paced online manger course is now available for constituents. The online course and exam are accessible through Workday and links are available on the department's website.
- Program Instructor, Juli Ann Lindemann has restructured the unarmed instructor development course. As of March, program had a backlog of over 50 constituents wanting to take the course. Juli Ann and Carissa White increased the size of the unarmed IDC, and the backlog will be eliminated with the unarmed IDC scheduled for October.
- Program Instructor Juli Ann Lindemann is leading a group of industry professionals and agency staff in a workgroup review of the department's armed professional curriculum.
   The first workgroup meeting is scheduled for this week.

## Staffing Update:

• Michael Holsapple joined the private security program on August 1, 2022, as a Compliance Investigator. Michael fills a compliance position the department received with the passage of HB2527 (2021 Session) for the regulation of private security entities. Michael has been busy reviewing those new provisions that take effect January 1, 2024, and has reached out to constituents and partner agencies to discuss implementation. A workgroup interest application form was sent out to all licensed private security executive managers last week, and we are planning to start our HB2527 workgroup meetings in September.
