2. Policy Discussion on Background Investigation and Pre-employment Psychological Evaluation Standards for Telecommunicators and Emergency Medical Dispatchers Presented by Jennifer Howald, Administrative Rules Coordinator

In November 2022, the Telecommunications, Corrections and Police Policy Committees reviewed proposed rule changes that were developed based on the Department's interpretation that the checklist and questionnaire would become the minimum standard for all law enforcement units when hiring public safety officers. As a minimum standard for hiring a public safety officer, the checklist's requirement to include information about a

psychiatric or psychological evaluation of the applicant would then extend to all criminal justice public safety officer disciplines. To ensure the standards applied to all disciplines equally, the proposed rules included public and private safety agencies in addition to law enforcement units.

The proposed rule changes received a total of 17 public comments. After the public comment period, the Department returned to DOJ for additional guidance. As a result, it was determined that the Department meets the legal requirements of HB 2936 by creating and providing the checklist and the questionnaire forms.

On February 16, 2023, the Department asked all three policy committees to have a collective policy discussion to determine if the background checklist and the personal history questionnaire should be made available as resources or if they should be required as minimum standards. The Corrections Policy Committee and the Police Policy Committee voted to recommend requiring the background checklist and personal history questionnaire. The Telecommunications Policy Committee voted to return the issue back to the TPC for additional discussion.

The TPC reviewed the psychological evaluation standards and determined telecommunicators and emergency medical dispatchers should have a pre-employment psychological evaluation. The TPC recommended this standard become effective January 1, 2024. The TPC recommended that emergency medical dispatchers employed by private ambulance companies be exempt from this employment standard.

The TPC reviewed the background investigation requirement to complete a standardized personal history questionnaire. The TPC recommended that agencies hiring telecommunicators and emergency medical dispatchers retain the discretion to use the questionnaire of their choice.

The TPC reviewed the background investigation requirement to complete a background checklist. The TPC recommended that hiring agencies be required to use a background checklist based on the rule language that allows the agency to use either the checklist or an equivalent checklist.

Rebecca Long moved to recommend approval of OAR 259-008-0011 with the discussed revisions for the psychological evaluation standards, and approval of OAR 259-008-0015 with the amendment that the personal history question list is not a requirement for telecommunications or emergency medical dispatchers. Chelsea LaBar seconded the motion. The motion passed unanimously.
