Consent Items

1. Minutes

Secretary Read made a motion to approve the minutes for the June 10, 2025, and the July 9, 2025, Land Board meetings.

Treasurer Steiner seconded the motion.

The item was approved at 10:01 a.m. without objection.

ACTION ITEMS

2. Elliott State Research Forest Board Appointments

The Elliott State Research Forest Board of Directors guides the Department's management of the research forest. An ESRF Board that includes diverse perspectives and experiences is essential to successfully managing a public research forest for multiple benefits and ensuring transparency and accountability. The ESRF Board's roles and responsibilities are outlined in the ESRF Oversight Structure (see Appendix A) approved by the Land Board in April 2024

Director Lovell recommended the Land Board appoint the following candidates to the terms listed below, subject to a positive background check:

- Payton Smith Four-year term (ending October 2029)
- Haley Lutz Four-year term (ending October 2029)
- Ken Carloni Remainder of a three-year term (mid-term vacancy, ending October 2027)

One four-year term remains unfilled. DSL will hold this seat, and any future seats, vacant as it conducts the Tribal consultation process, as long as it maintains a quorum. Currently, Mike Wilson, the ESRF Board member serving in a one-year term position, provides a valuable non-Tribal Indigenous perspective on the ESRF Board. DSL intends to continue his service during the consultation until the vacancies are reopened.

Secretary Read stated that he appreciates the continued dedication of the group. Treasurer Steiner asked if there was a timeline for the Tribal consultation process.

Director Lovell stated that it is a top priority.

Governor Kotek stated that Tribes continue to show interest in the ESRF process and she looks forward to an update on the consultation process.

Secretary Read made a motion to approve the action item.

Treasurer Steiner seconded the motion.

The item was approved at 10:07 a.m. without objection.

INFORMATIONAL ITEMS

3. Common School Fund Annual Report

Director Lovell introduced Jamie McCreary and Louise Howard from Oregon State Treasury to present the report.

Treasury staff presented the annual report and provided the Board with a year-end summary for Fiscal Year 2025.

Secretary Read asked what the thinking was in moving the asset allocation in line with the pension fund and what the advantages and disadvantages are with that.

Ms. McCreary stated that with asset allocations, the typical timeframe is 3-5 years. They are looking at it every year but taking a deeper dive every 3-5 years.

Treasurer Steiner emphasized that the growth is really solid and has distributed almost a Billion dollars to schools over the last 15 years.

Director Lovell thanked DSL's Fiscal staff for their work as well.

4. Oregon Ocean Science Trust Annual Report 10:30 a.m.

Director Lovell introduced Laura Anderson, OOST Board Chair, Karina Nielsen, OOST Vice Chair and Lisa DeBruyckere, Oregon Sea Grant Director, to present the report.

The report gave an overview of the OOST and their accomplishments over the last couple of years.

Treasurer Steiner asked what role OOST has in offshore energy projects.

Ms. Anderson stated that OOST is a source of knowledge and information on ocean energy but does not make policy.

5. South Slough National Estuarine Research Reserve Annual Report 11:00 a.m.

Director Lovell introduced Patricia Fox, Reserve Manager and Chris Castelli, Deputy Director, to present the item which highlighted the accomplishments of the Reserve over the last year.

6. Southern Resident Orca Management Plan

Director Lovell introduced Nataliya Stranadko, Territorial Sea Specialist, to present the report.

On February 16, 2024, the Oregon Department of Fish and Wildlife Commission listed Southern Resident Orcas as endangered under the Oregon Endangered Species Act. The report gave an overview of the Department of State Lands' responsibilities that contribute to conservation of this species.

Secretary Read expressed his appreciation for the recognition in the memo of the need for Tribal consultation in this process.

Treasurer Steiner asked how this work intersects with the work on building up the Chinook salmon habitat and migration.

Deputy Director Bill Ryan came to the table and responded that the Essential Salmonid Habitat (ESH) is regulated by the Oregon Removal Fill Law. All areas designated ESH by ODFW data have a zero-movement threshold. The ESH map provides additional protection.
