5. Legislative Session Update – William Chapman 2:05 PM

- SB 5517 is the OEM budget bill including the 2025 SWIC/SIEC transfer and the 2026 OERS Watch transfer.
 - Status: Awaiting a work session in the Ways and Means Public Safety Subcommittee,
 - SB 5550 is a budget rebalance bill that includes this biennium's \$5 million for the disaster preparedness stockpile.
 - Status: Signed into law by Governor Kotek.
 - SB 5505 is a bonding bill with \$5 million for the next round of SPIRE
 - Status: Awaiting a work session in the Ways and Means Capital Construction Subcommittee. Note: HB 2753, on the same topic, is awaiting action in Ways and Means.
 - HB 3237 and HB 3259 were PSAP consolidation bills.
 - Status: Did not advance out of committee. Note: there is at least one bill with a relating clause that could be used for amendments that affect emergency management.
 - HB 2772 was a budget bill to appropriate money for analog alert encoders.
 - Status: Did not advance out of committee.
 - HB 3253 established review criteria for telecommunications towers to be applied by counties.
 - Status: Did not advance out of committee.
 - SB 826 is the SIEC/SWIC transfer policy bill.
 - Status: Awaiting a work session in the Ways and Means Public Safety Subcommittee
 - SB 234 is the OERS Transfer policy bill updating effective dates to 2026.
 - Status: Awaiting a work session in the Ways and Means Public Safety Subcommittee
