New Business

- Planning Process: 27-29 Legislative Session Seiji Shiratori, Oregon Department of Emergency Management
 - Special Session at the end of August and short session beginning in January 2026
 - o OEM-perspective: broadly successful session.
 - SWIC and SIEC formally part of OEM as of July 1
 - Next year, OERS Watch Center moving from OSP to OEM
- Spectrum Cyclone Aaron Fox
 - July exercise in Seattle support for 2026 FIFA World Cup
 - o Well-rounded mix of threats in digital environment that could impact first responders
 - o John Lee: Washington State SWIC
 - Zero funding outside of partner commitments and donations
 - o <u>www.TAK.gov/products</u>
- Real World Tsunami Event Discussion
 - No wireless emergency alert was sent from NWS in Oregon
 - o 154,000 individuals received some sort of contact from OR-Alert.
 - Tsunami Center and Weather Service: we should put together a template tsunami message within the system
 - Discussion of sirens risk profile is unique from WA and HI
 - Multiple-jurisdiction 9-1-1 interruption of service PSAPs lost ability to receive 9-1-1 calls: 3
 counties along the coast.
 - Preparing for double-emergencies
 - Seismic Network built out to generate earthquake early warning products.
 - Public confusion between Watch and Warning
 - No-notice events are opportunities to see where we excel and where there are gaps

Old Business

- Definition of Public Safety Communications Ecosystem Patence Winningham (Under Review)
 - SIEC was given form to provide review moving forward with getting a legal opinion. What does it mean to define public safety communication? More to come, no action needed at this time.
- Grants Update Patence Winningham
 - Still navigating Federal changes



- NOFO dropped last week, given 14 days to turn them around and submit
 - Seeking litigation in the terms and conditions
- EMPG next round NOFO is in the same pile, at the mercy of the terms and conditions and litigation.
- FY25 SHSP Updates: We hope to have SIEC serve as the EmCom grant review committee.
- Sensor buildouts for alerts and warning, OR Alert capabilities, replacement of EAS encoders
- Longterm planning for if litigation against the terms and conditions is unsuccessful. State agencies don't have a substitute for federal grants – will require creativity
 - EMPG Funding Formula Committee trying to revamp to mitigate potential bleeding of funding and capability at the local levels

- SPOC Report get from William
- Carrier Update
 - o FirstNet Public Safety Success Manager: Lily Campbell
 - FirstNet playbook agencies, organizations can incorporate it into their emergency plan
 - Verizon Wireless: mild in comparison. No current operations in WA or OR
 - Seeing many StarLink in the field



- OR County Fair: 15,000 per day, deployed satellite truck for vendors and attendees positive feedback from organizing council
- 5G network enhancement: network slicing concert in San Francisco with 75,000 people per day drone patrol leveraged network slicing.
- o T-Mobile: T-Satellite has been launched commercially
 - October: rolling out like-data component. Focused on first responder applications in the field: tracking assets, voice memos, direct connect mission critical apps – data is coming
 - US Cellular Merger: SW and Eastern Oregon (Wasco, Lake, Harney, Douglas County, etc.) growing assets
 - Network coverage: 350 sites under new build or capacity upgrade. Network slice is available in every county. Capital Investment through 2026
- o Broadband Committee need new chair, doesn't need to be a voting SIEC member

 - Priority Programming Guide for Interoperability
 - Fade of Communication Positions limited funding for contractors and training. Try to replace some of the classes. Need task books to be submitted.
