4. Meeting Notes, Decisions, Issues

- 1. Call to order for meeting to commence occurred at 1:36pm PST.
- 2. Welcome/Introductions & Quorum verification
 - a. Quorum was verified and initially declared that the council did not meet quorum, however later in to the meeting two mwmbers joined the meeting and quorum was met.
- 3. Council minutes (May 2018 SIEC meeting)
 - a. Minutes were not presented and no action was taken on those minutes.

4. SIEC Committee Reports.

- a. Bob Cozzie, provided a brief update referencing the executive committee activities.
- b. Bob Cozzie, providede a brief update referencing activities of the strategic planning committee. He stated that the main focus of the committee will be to work on revising/updating the state SCIP. Planning work will start soon to get the objectives that are included on the SCIP to be scopped to match the resources that could be brought to get majority of the objectives to completion. An exercise of right sizing goals and abjectives is needed.
- c. Ben Gherezgiher added that the state CIO's office will assist the SIEC team in this effort by providing more resources.
- d. Broadband Committee: members of the committee stated that a teleconference based meeting was held earlier this month and AT&T provided updates on progress of FirstNet.
- e. Technical Committee: Rick provided a brief update. No significant activities going on this quarter.

- f. Partnership Committee: Rob Reish presented a draft copy of the committee's charter and the membership provided input. He further provided an update on the strategy of operation of the committee, he provided a sample news letter that will be used as one of the means of communication and update to public safety practitioners statewide. Discussions continued and no objections were presented. The recommeded changes to the charter will be incoprporated and will be presented for approva/adoption by the council at a later date.
 - i. 2018 Radio conference updates were also provided and stated that planning effort is in progress and so far it is going as planned. The number of registered participants is more than exepected and the State CIO's office as one of the main sponsors will increase the event funding to accommodate the demand.

a. There was no significant activity report provided on this agenda item..

6. Statewide Interoperability Coordinator's Report.

a. The brief report that was provided here focused on the outcome of the NGA sponsored conference that was held in Portland late june 2018. A survey was designed to complete a recommeded environmental scan of the state's public safety communication implementations. However, a discussion was initiated that indicated the data that could be collected via the survey may already exisist from previous activities done. The discussion was tabled with understanding that further details regarding the need and the desired outcome to be clarified. However, the members present concurred that we need to follow up on the decisions that were reached during the conference.

7. Project Status Report – FirstNet/AT&T

- a. We had three members representing AT&T in the meeting and Paul Braunstien provided a brief update regrading FirstNet. Paul reported that significant progress was achieved this quarter, through combined efforts of AT&T team, State CIO's technical resourses, State procurement staff and state leadership. The NASPO addendum to make FirstNet services available to Oregon Firstresponders was completed.
- b. Project updates on buildout of the FirstNet network was provided to the SIEC broadband committee. Progress is being achieved as planned.

8. Radio Syatems Reports.

i. Region 35 update. Phase II of the system completed acceptance tests with Motorola.
