 - Call to order at 1:33 PST by Chair Duyck

 - Quorum was verified and confirmed for the meeting.

V. SIEC committee reports

- *Executive Committee*
- *Strategic Planning Committee*
 - Six ICTap requests.
 - Cyber security awareness for 911, telecommunicators in particular; incident tactical dispatch COM-U exercise. Combine all into one event for RADIO conference. William is the point of contact for that.
 - Discuss timeline for updating SCIP. Committee chairs will be working on that.
- *Broadband Committee*
 - Due to agenda, the broadband committee meeting was cancelled. They plan on working through SPOC report:
 - FirstNet Quarterly update: last month FirstNet and AT&T met to talk about buildout questions and what the challenges are.
 - 75% completion of Band 14 coverage, now at 1M+ connections.
 - RAN buildout – in 2019 went from 38 to 45 approved sites, in 2020 plan to add 23 more, 2021 add 18, 2022 add 3 more sites. It seems that we are back on schedule, but will see by 2020 if all are aligned and operating.
- *Technical Committee*
 - Met yesterday, representatives came from all major systems. Rick Iverson asks: What are your interoperability wants/needs? What mechanism do we use to teach people how to use the system?
 - Working on updating committee charter, in the near future
 - Had a recent incident which had 5 agencies involved with limited coverage, able to tie conventional resources and trunking to communicate to different departments
- *Partnership Committee*
 - New co-chair Tony DeBone
 - Partnership met last week and got acquainted with each other, went through charter and reviewed SCIP objectives, discussed communication ideas. Intending to work with William on to come up with these

communications. There will be a follow up meeting next month to prepare for the RADIO conference.

- RADIO Conference
 - Discussion on Interoperability communication. Planning a day and half of presentations and half day of COMU show and tell.
 - Want to have discussions about interoperability and what is available for people to use
 - LMR-LTE interoperability, COMU and 5g, and cyber security, etc...

IV. Council Action List

- Presentation – Shake Alert Network – Professor Toomey
 - Shake Alert and ALERTWildfire: building a federal network for hazards
 - Shake Alert is an earthquake early warning system, for the west coast, well-coordinated coalition of federal, state, and university partners in Oregon, Washington, and California.
 - The concept is earthquake detection, not prediction
 - Phase 1 – Oct. 2018 – Limited alerting
 - Phase 2 – Jan 2019 – test of public alerting
 - Phase 3 – Oct. 2019 – test of public alerting in California
 - Phase 4 – Oct. 2020 – test of public alerting in the Pacific North West

- 51% complete with the buildout of shake Alert in the northwest, wanting to complete buildout by 2023. Wanting to purchase and install 82 Shake alert sites.
- Telemetry pathways – wanting to build more microwave stations, working on moving from cell to FirstNet. The goal is to use fastest possible pathways, in a bad day is to have robust system that has redundancy built in.
- Vote – COMU Proposal Adoption
 - Timeline – all members of SIEC to read through and vote on the proposal, deadline of 14 days so that we don't lose momentum.
 - This will all be framed in an email with actions that need to be taken.

V. Open discussion, questions, public testimony

- DHS – did a little bit of work last week, William will talk about what they worked on, they are here to help with more than just technical assistance
- 2020 legislative HB4041 introduced that would have major impact on Emergency management and response organization. It would be great if public safety and interoperability is on the agenda if that bill passes to communicate with all of the organizations and councils
