- How Paid Leave Oregon and BOLI work together

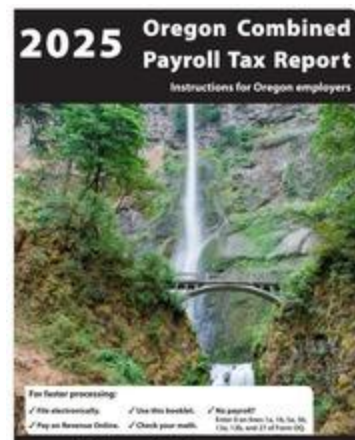

Remember that **you must report all wages, for each employee, for each program, every quarter.**



Helpful tips when filing a “no-payroll” report:



1. The most efficient way to file your no-payroll report is directly through your Frances Online account. If you do not have a Frances Online account, please call (503) 378-3981 to file your no-payroll report by phone.
2. If your business closes or you no longer have employees, send us a Business Change in Status Form to update your account if you haven't already. You can submit the form through your Frances Online account.
3. If you file your payroll reports through your Frances Online account, you do not need to send an additional duplicate paper copy.

Work Share allows employers to reduce work hours for their employees by providing partial unemployment insurance benefits that supplement their workers' reduced wages. Work Opportunity Tax Credit (WOTC)



Spring into big tax savings with new hires!

Including the WOTC program as part of your hiring process can earn you **\$1,500 to \$9,600 in tax credits** for **each** eligible new hire. As an added bonus, there is an IRS request form to hold the credit **up to 20 years** if you don't need the tax credit right away.

In Oregon, new hires from 10 identified groups can qualify a business for the [Work](#)

Opportunity Tax Credit. Employers receive tax credits for hiring people who face barriers to employment. People from those identified groups get an improved chance of returning to the workforce due to the employer's tax credit incentives. This is a win-win for the employer who gains both a new employee and added tax savings, as well as the job seeker who gets a new job.
