Draft - Residential Reach Code

Three options:

- 1. "Prescriptive" (previous Reach integrated into 2023 ORSC.)
- 2. ERI Path (from last Reach): Update the ERI figures.
- 3. Energy Star (v3.2 national.)

Prescriptive

- Improvement relative to 2023 (regulated loads)
 - Integrate 2023 ORSC with 2021 Reach Code
 - New items from 2023 ORSC as starting point
- Add Additional measures or "Paths" (packages) that align with Incentives (ETO, BPA)?
- Home size/affordability?
- Other Topics?



ERI Path - 2023 BASE ORSC Compliance Path

- Setting the ERI Targets
 - Cross check with equivalency to REM/rate or other ERI software.
- BCD to use REM/Rate modeling
 - Figure relative to prescriptive? ENERGY STAR V3.2 National? 2026 ORSC target?
- Backstops?
 - Envelope
 - Air Sealing/Testing
- Renewables: ERI with renewable energy
 - Maximum PV/Renewable level
 - Encourage Market Transformation without discouraging
 - Storage to allow greater PV?

- National Version 3.2, Rev. 12
- ERI Target based on:
- 2021 IECC Envelope: R-60 attic & Continuous Insulation walls
 - R-10 slab edge/4-ft. (Change from OR/WA v3.2)
- U-0.27 Windows
- High efficiency HVAC and water heating; Ducts-inside
- Certification/Raters & Energy Star appliances
