Topic: Data Center Overview, Economic Development, and Workforce Issues

Purpose of this Process: the Governor has asked the Data Center Advisory Committee to identify ways to better balance the need for new economic opportunities with smart policy choices that will support our clean energy goals and ensure affordable and reliable electricity for all Oregonians. The Committee will conduct an open and public process to understand challenges and opportunities in key policy areas related to the siting of data centers in our state and then recommend actions that the State of Oregon can take” (from Committee Charge). As such, the Committee’s goal is to use these public sessions to gather and share credible information from subject matter experts, based on firsthand experiences, real-world data, and diverse perspectives regarding Data Centers in Oregon.
