A. Consent Calendar – Approval of minutes; Council Secretary Report; and other routine Council business.

B. [5:30 p.m.] Golden Hills Wind Project, Public Hearing on the Draft Proposed Order on Request for Amendment 5 of the Site Certificate (Hearing) – Maxwell Woods, Senior Policy Advisor. The hearing will begin after Council receives a brief overview from staff. The purpose of the hearing is for members of the public to provide verbal comments to Council members on Request for Amendment 5 and the Draft Proposed Order on Request for Amendment 5. Request for Amendment 5 seeks Council approval of the following modifications: approval for larger wind turbines and flexibility in turbine model selection during final design; larger meteorological towers; and changes in temporary access road width. The draft proposed order includes the Department's recommendation that Council approve, with existing and recommended conditions, an amended site certificate. The comment period on the draft proposed order and amendment request closes at the end of the hearing.

C. Golden Hills Wind Project, Draft Proposed Order on Request for Amendment 5 (Information Item) – Sarah Esterson, Senior Siting Analyst. The Council will receive a presentation and review the Draft Proposed Order on Request for Amendment 5. The Council will not permit comments on any issue that may be the basis for a contested case. The public comment period closes on August 23, 2018.
