



RFA1– Proposed Modifications

- 50 megawatt (MW) photovoltaic solar unit on approximately 315 acres;
- 34.5 kilovolt (kV) interconnection transmission line;
- Five interconnection transmission line routing options and three interconnection options;
- Use of temporary construction laydown and parking areas;
- Removal of reference to Unit 2, Unit 2 associated components, and Unit 2 related and supporting facilities;
- Amendment of the site boundary
- Amend Water Pollution Control Facilities Permit
- Amendment and removal of several site certificate conditions.





Note: Portions of the Carty Site Boundary Expansion Areas are overlapping with Boardman Site Boundary Areas.







