

## Shepherds Flat Central Request for Amendment 3: Draft Proposed Order

**Certificate Holder:** South Hurlburt Wind, LLC, a wholly owned subsidiary of Caithness Energy, LLC, a subsidiary of Caithness Equities Corporation.

**Approved Facility:** Operational wind energy generation facility with 116 wind turbines and a generating capacity of 290 megawatts. The facility is located within a site boundary of approximately 11,769 acres in Gilliam and Morrow counties.

**Proposed Amendment:** Remove and replace turbine blades and nacelles (repower) to 114 of the 116 existing wind turbines, lowering minimum aboveground blade tip clearance from 25 to 21.5 meters.<sup>1</sup>

**Proposed Location:** Gilliam County and Morrow County (within existing approved site boundary)

**Staff Recommendation:** Approval of Request for Amendment 3 of Site Certificate

## **Summary**

To issue an amended site certificate, the Energy Facility Siting Council (EFSC or the Council) must find that a request for amendment to the site certificate demonstrates that the facility, with proposed changes, satisfies, or with conditions can satisfy, each of the applicable EFSC Siting Standards set forth in Oregon Administrative Rule (OAR) Chapter 345, Divisions 22 through 24, as well as all other Oregon statutes and administrative rules applicable to the facility with proposed changes.

The amendment request is being reviewed under the Type B review process (OAR Chapter 345 Division 27). As staff to EFSC, the Oregon Department of Energy (ODOE or the Department) reviewed Request for Amendment 3 to the Shepherds Flat Central site certificate, in consultation with specifically identified state and local reviewing agencies. The proposed amendment would allow the certificate holder to modify turbine components and install longer turbine blades on the existing towers (proposed RFA3 facility repower). Based upon its review of the amendment request, the Department recommends Council issue a second amended site certificate for the facility, subject to the existing operational and recommended new pre-construction and construction conditions set forth in this order. The analysis and recommendations contained in this draft proposed order are not a final determination.

A public comment period is now open on the draft proposed order and complete amendment request. The comment deadline for written comments to be submitted to the Department is January 20, 2020 by 5:00 p.m. PST. Section II.B., *Amendment Review Process* of the draft proposed order contains additional information regarding the site certificate amendment review process. The public notice associated with the release of this draft proposed order also contains additional information regarding the comment period and next steps in the EFSC review process.

1 **I. INTRODUCTION**

2  
3 The Oregon Department of Energy (Department or ODOE) issues this draft proposed order, in  
4 accordance with Oregon Revised Statute (ORS) 469.405(1) and Oregon Administrative Rule  
5 (OAR) 345-027-0365, based on its review of Request for Amendment 3 (RFA3) to the Shepherds  
6 Flat Central site certificate, as well as comments and recommendations received by specific  
7 state agencies and local governments during review of the preliminary amendment request.  
8 The certificate holder for the facility is South Hurlburt Wind, LLC (certificate holder), a wholly  
9 owned subsidiary of Caithness Energy, LLC, a subsidiary of Caithness Equities Corporation.

10  
11 The certificate holder requests that the Council approve changes to the site certificate to:

- 12
- 13 • Upgrade (or repower) the existing facility wind turbines by replacing blades for longer  
14 and lighter blades and associated machinery on the existing turbine towers;<sup>2</sup>
  - 15 • Construct temporary access road, temporary access road improvement and laydown  
16 areas; and,
  - 17 • Amend a site certificate condition (Existing Condition 26).<sup>3</sup>
- 18

19 Based upon review of this amendment request, in conjunction with comments and  
20 recommendations received by state agencies and local government entities, the Department  
21 recommends that the Council approve and grant an amendment to the Shepherds Flat Central  
22 site certificate subject to the existing operational and recommended new pre-construction and  
23 construction conditions set forth in this order.

14 **I.B. Description of the Approved Facility and Facility Location**

15


16 Shepherds Flat Central is a wind energy facility with approximately 116 wind turbines and a  
17 maximum generating capacity of 290 megawatts. The facility includes a 34.5 kV electrical  
18 collection system, a collector substation, a 230 kV interconnection transmission line, two  
19 meteorological towers, a field workshop, supervisory control and data acquisition system, and  
20 access roads.

21

22 As presented in Figure 1: *Facility Regional Location* below, the facility is located within a site  
23 boundary of approximately 11,769 acres, south of Interstate Highway 84, between State  
24 Highway 19 and 74 in Gilliam and Morrow Counties.

1 **I.C. Procedural History**  
2

3 The Council approved a site certificate for the Shepherds Flat Wind Facility on July 25, 2008,  
4 authorizing construction and operation of a 909 MW wind energy generation facility. The  
5 Council issued the First Amended Site Certificate on March 12, 2010, authorizing an expansion  
6 of the site boundary to accommodate an alternative route for the transmission line, and also  
7 divided and transferred the Shepherds Flat Wind Facility into three independent facilities -  
8 Shepherds Flat North, Shepherds Flat Central, and Shepherds Flat South. The Council issued a  
9 Second Amended Site Certificate on October 25, 2019, authorizing the repowering of two wind  
10 turbines (T-368 and T-370) based on a proposed Operations and Maintenance (O&M)  
11 demonstration activity.

12  
13 The procedural history of Request for Amendment 3 (RFA3 or amendment request) is described  
14 in Section II.C. *Amendment Review Process* of this order.  
15

16 **II. AMENDMENT PROCESS**  
17

18 **II.A. Requested Amendment**  
19

20 *Wind Turbine Repower*  
21

22 The certificate holder requests Council approval to upgrade (or repower) 114 of the existing  
23 116 wind turbines to current technology by replacing existing blades for longer turbine blades  
24 and associated wind turbine components on existing turbine towers (as noted, two turbines,  
25 368 and 370, have previously been repowered, as approved by Council under RFA2). Wind  
26 turbine repowering would require trucks, small cranes or telehandlers, and a track mounted  
27 crane. The trucks would both deliver the new wind turbine components to the existing wind  
28 turbine pad sites, and transport the old components offsite for proper disposal or recycling at a  
29 licensed facility.

30  
31 Once the new wind turbines components are delivered via truck to each pad site, smaller  
32 cranes or telehandlers would unload and stage the components. A track mounted crane would  
33 then mobilize to the turbine pad area, setting up on the access road adjacent the turbine, and  
34 would lower the old rotor down to the pad site for disassembly, followed by the old gearbox.  
35 Once disassembled, the old components would be staged for truck removal. The track mounted  
36 crane would then lift the new gearbox and rotor into place. Once, complete, the track mounted  
37 crane would advance to the next wind turbine, and the process would repeat.  
38

39 The proposed RFA3 facility repower would not: increase the site boundary, result in permanent  
40 disturbance, or increase maximum blade tip height from the maximum authorized in the site  
41 certificate. The Department notes that the longer turbine blades would increase the blade-tip

1 height and rotor diameter of the turbines within the parameters allowed by the site certificate.<sup>4</sup>  
2 The proposed RFA3 facility repower would allow each wind turbine to generate more electricity  
3 without increasing the permanent footprint of the facility, and the certificate holder states that  
4 the peak generating capacity of the facility would remain the same (290 MW). Replacing old  
5 turbine components with modern, more technologically advanced equipment would increase  
6 the capacity and efficiency of the facility by allowing the turbines to process low velocity winds  
7 that they currently cannot do as effectively.

8  
9 *Temporary Disturbance Impacts*

10  
11 The proposed RFA3 facility repower would include temporary laydown areas used to stage and  
12 store construction equipment, improvements to existing access roads and turbine pad areas,  
13 and temporary turnaround areas, resulting in approximately 150 acres of temporary  
14 disturbance.<sup>5</sup>

15  
16 *Amendment to a Site Certificate Condition*

17  
18 As a result of the proposed RFA3 facility repower, the certificate holder requests to amend  
19 Condition 26, to decrease the minimum blade tip clearance from 25 to 21.5 meters.

20  
21 **II.B. Recommended Amended Site Certificate Format**

22  
23 The existing site certificate, as amended in March 2010 and in October 2019, contains three  
24 separate sections of conditions; the first section applying generally to the facility during design,  
25 construction, operation and retirement (Mandatory Conditions, Site Specific Conditions, and  
26 Construction and Operation Rules for Facilities), the second section that applies specifically to  
27 the Shepherds Flat Central facility, and the third section which contains new conditions that  
28 were specifically imposed for the RFA2 facility modifications. To minimize duplicity in the site  
29 certificate, the Department recommends that Council delete the OAR rule reference that  
30 prefaces each of the conditions in the first section of site certificate conditions.

31  
32 Based on the potential impacts from the proposed RFA3 facility repower, and for clarification  
33 during condition compliance, the Department recommends that Council impose specific  
34 conditions that would apply prior to and during construction of the proposed RFA3 facility  
35 modifications. Previously imposed operational and retirement conditions would continue to  
36 apply to the facility, with proposed changes, in their entirety. The recommended new pre-  
37 construction and construction conditions are presented in Section V of the draft amended site  
38 certificate, provided as Attachment A to this order.

1 **II.C. Amendment Review Process**  
2

3 Council rules describe the processes for transfers, Type A, Type B, and Type C review of a  
4 request for amendment at OAR 345-027-0351. The Type A review is the standard or “default”  
5 site certificate amendment process for changes that require an amendment. Type C review  
6 process is associated with construction-related changes. The key procedural difference  
7 between the Type A and Type B review is that the Type A review includes a public hearing on  
8 the draft proposed order and an opportunity for a contested case proceeding. The primary  
9 timing differences between Type A and Type B review are the maximum allowed timelines for  
10 the Department’s determination of completeness of the preliminary request for amendment,  
11 as well as the issuance of the draft proposed order, and proposed order. It is important to note  
12 that Council rules authorize the Department to adjust the timelines for these specific  
13 procedural requirements, if necessary.  
14

15 A certificate holder may submit an amendment determination request to the Department for a  
16 written determination of whether a request for amendment justifies review under the Type B  
17 review process. The certificate holder has the burden of justifying the appropriateness of the  
18 Type B review process as described in OAR 345-027-0351(3). The Department may consider,  
19 but is not limited to, the factors identified in OAR 345-027-0357(8) when determining whether  
20 to process an amendment request under Type B review.  
21

22 On May 21, 2019, the certificate holder submitted a Type B Review amendment determination  
23 request (Type B Review ADR), requesting the Department’s review and determination of  
24 whether, based on evaluation of the OAR 345-027-0357(8) factors, the amendment request  
25 could be reviewed under the Type B review process. On June 17, 2019 the Department  
26 responded to the certificate holder that there was insufficient supporting evidence or analysis  
27 to justify a Type B Review. On October 7, 2019, the certificate holder submitted its preliminary  
28 request for amendment 3 (pRFA3). On October 23, 2019, the Department determined that  
29 Request for Amendment 3 of the Shepherds Flat Central Site Certificate justifies Type B review,  
30 based on the low level of complexity, the limited level of interest in the proposed changes  
31 anticipated by the Department, and the low likelihood of significant adverse impacts or  
32 additional mitigation from the proposed change.  
33

34 Pursuant to OAR 345-027-0363(2), on October 28, 2019, the Department determined pRFA3 to  
35 be incomplete and issued requests for additional information.<sup>6</sup> The certificate holder provided  
36 responses to the information request on November 8, 2019. After reviewing the responses to  
37 its information request, on December 26, 2019, the Department determined the RFA to be  
38 complete. Under OAR 345-027-0363(5), an RFA is complete when the Department finds that a  
39 certificate holder has submitted information adequate for the Council to make findings or  
40 impose conditions for all applicable laws and Council standards. The certificate holder  
41 submitted a complete RFA3 on December 31, 2019, which was then posted on December 31,

1 2019 to the Department’s project website with an announcement notifying the public that the  
2 complete RFA had been received and is available for viewing.

3  
4 Reviewing Agency Comments on Preliminary Request for Amendment 3

5  
6 As presented in Attachment B of this order, the Department received comments on pRFA3  
7 from:

- 8 • Oregon Department of Fish and Wildlife (ODFW)
- 9 • Oregon Department of Aviation (ODA)
- 10 • Gilliam County Planning Department

11  
12 **II.D. Council Review Process**

13  
14 On December 31, 2019, the Department issued this draft proposed order, and a notice of  
15 comment period on RFA3 and the draft proposed order (notice). The notice was distributed to  
16 all persons on the Council’s general mailing list, to the special mailing list established for the  
17 facility, to an updated list of property owners supplied by the certificate holder, and to a list of  
18 reviewing agencies as defined in OAR 345-001-0010(52).

19  
20 To raise an issue on the record of the draft proposed order, a person must raise the issue in a  
21 written comment submitted after the date of the notice of the draft proposed order received  
22 by the Department before the written comment deadline. The Council will not accept or  
23 consider public comments on RFA3 or on the draft proposed order after the written comment  
24 deadline, listed above, that closes the record on the draft proposed order. After the  
25 Department considers all comments received before the comment deadline for the draft  
26 proposed order, but not more than 21 days after the comment deadline, the Department will  
27 issue a proposed order. The proposed order shall recommend approval, modification, or denial  
28 of the second amended site certificate. Upon issuance of the proposed order, the Department  
29 will issue a notice of the proposed order.

30  
31 The Council, may adopt, modify or reject the proposed order based on the considerations  
32 described in OAR 345-027-0375. In a written final order, the Council shall either grant or deny  
33 issuance of an amended site certificate. In making a decision to grant or deny issuance of an  
34 amended site certificate, the Council shall apply the applicable laws and Council standards  
35 required under OAR 345-027-0375 and in effect on the dates described in OAR 345-027-0375  
36 (3). The Council’s final order is subject to judicial review by the Oregon Supreme Court as  
37 provided in ORS 469.403.

38  
39 **II.E. Applicable Division 27 Rule Requirements**

40  
41 A site certificate amendment is necessary under OAR 345-027-0350(4) because the certificate  
42 holder requests to design, construct, and operate the facility in a manner different from the  
43 description in the site certificate, and the proposed change would impair the certificate holder’s

1 ability to comply with a site certificate condition, and would require new conditions or  
2 modification to existing conditions in the site certificate.

3  
4 The Type B amendment review process (consisting of rules 345-027-0359, -0360, -0363, -0365, -  
5 0368, -0372, and -0375) shall apply to the Council’s review of a request for amendment that the  
6 Department or the Council approves for Type B review under 345-027-0357.  
7  
8

9 **III. REVIEW OF THE REQUESTED AMENDMENT**

10  
11 Under ORS 469.310, the Council is charged with ensuring that the “siting, construction and  
12 operation of energy facilities shall be accomplished in a manner consistent with protection of  
13 the public health and safety.” ORS 469.401(2) further provides that the Council must include in  
14 the amended site certificate “conditions for the protection of the public health and safety, for  
15 the time for completion of construction, and to ensure compliance with the standards, statutes  
16 and rules described in ORS 469.501 and ORS 469.503.” The Council implements this statutory  
17 framework by adopting findings of fact, conclusions of law, and conditions of approval  
18 concerning the amended facility’s compliance with the Council’s Standards for Siting Facilities  
19 at OAR 345, Divisions 22, 24, 26, and 27.  
20

21 This draft proposed order includes the Department’s initial analysis of whether the changes  
22 proposed in RFA3, meet each applicable Council Standard (with mitigation and subject to  
23 compliance with recommended conditions, as applicable), based on the information in the  
24 record. Following the written comment period on the draft proposed order, the Department  
25 will issue its proposed order, which will include the Department’s consideration of the  
26 comments and any additional evidence received on the record of the draft proposed order.  
27

28 **III.A. Standards Potentially Impacted by Request for Amendment 3**

29 RFA3, as described throughout this order, solely requests authorization for a proposed upgrade  
30 (or repower) to the facility’s wind turbines, where blade replacement and nacelle modification  
31 would occur. In RFA3, the certificate holder describes the number of equipment and personnel  
32 that would be required for the proposed RFA3 facility repower, and potential impacts  
33 associated with the repowering activities. Based on the Department’s review of the RFA and of  
34 the previously evaluated impacts and imposed conditions, the following standards could be  
35 impacted by RFA3 and as such, are evaluated in this order.  
36

37 **III.A.1 General Standard of Review: OAR 345-022-0000**

38  
39 *(1) To issue a site certificate for a proposed facility or to amend a site certificate, the*  
40 *Council shall determine that the preponderance of evidence on the record supports the*  
41 *following conclusions:*

42  
43 *(a) The facility complies with the requirements of the Oregon Energy Facility Siting*  
44 *statutes, ORS 469.300 to ORS 469.570 and 469.590 to 469.619, and the standards*

1           *adopted by the Council pursuant to ORS 469.501 or the overall public benefits of the*  
2           *facility outweigh the damage to the resources protected by the standards the facility*  
3           *does not meet as described in section (2);*

4  
5           *(b) Except as provided in OAR 345-022-0030 for land use compliance and except for*  
6           *those statutes and rules for which the decision on compliance has been delegated by*  
7           *the federal government to a state agency other than the Council, the facility*  
8           *complies with all other Oregon statutes and administrative rules identified in the*  
9           *project order, as amended, as applicable to the issuance of a site certificate for the*  
10           *proposed facility. If the Council finds that applicable Oregon statutes and rules, other*  
11           *than those involving federally delegated programs, would impose conflicting*  
12           *requirements, the Council shall resolve the conflict consistent with the public interest.*  
13           *In resolving the conflict, the Council cannot waive any applicable state statute.*

14           \* \* \*

15           *(4) In making determinations regarding compliance with statutes, rules and ordinances*  
16           *normally administered by other agencies or compliance with requirement of the Council*  
17           *statutes if other agencies have special expertise, the Department of Energy shall consult*  
18           *such other agencies during the notice of intent, site certificate application and site*  
19           *certificate amendment processes. Nothing in these rules is intended to interfere with the*  
20           *state's implementation of programs delegated to it by the federal government.*

21  
22           **Findings of Fact**

23  
24           OAR 345-022-0000 provides the Council's General Standard of Review and requires the Council  
25           to find that a preponderance of evidence on the record supports the conclusion that the  
26           proposed facility modifications comply with the requirements of EFSC statutes and the siting  
27           standards adopted by the Council and that the proposed facility modifications comply with all  
28           other Oregon statutes and administrative rules applicable to the issuance of an amended site  
29           certificate for the facility, with proposed changes. OAR 345-022-0000(2) and (3) apply to RFAs  
30           where a certificate holder has shown that the proposed facility modifications cannot meet  
31           Council standards or has shown that there is no reasonable way to meet the Council standards  
32           through mitigation or avoidance of the damage to protected resources; and, for those  
33           instances, establish criteria for the Council to evaluate in making a balancing determination. In  
34           RFA3, the certificate holder has not represented that the proposed amendments cannot meet  
35           an applicable Council standard. Therefore, OAR 345-022- 0000(2) and (3) would not apply to  
36           this review.

37  
38           The requirements of OAR 345-022-0000 are discussed in the sections that follow. The  
39           Department consulted with other state agencies, Morrow County Planning Department on  
40           Behalf of the Morrow County Board of Commissioners (Special Advisory Group), and the Gilliam  
41           County Planning Department on behalf of the Gilliam County Board of Commissioners (Special  
42           Advisory Group) during review of pRFA3 to aid in the evaluation of whether the proposed RFA3  
43           facility repower would maintain compliance with statutes, rules and ordinances otherwise  
44           administered by other agencies. Additionally, in many circumstances the Department and

1 Council rely upon these reviewing agencies' special expertise in evaluating compliance with the  
2 requirements of Council standards.

3  
4 *Mandatory and Site-Specific Conditions in Site Certificates [OAR 345-025-0006 and OAR 345-  
5 025-0010]*

6  
7 OAR 345-025-0006 lists certain mandatory conditions that the Council must adopt in every site  
8 certificate. Council rulemaking moved the mandatory conditions from Division 27 to Division  
9 25. Similarly, the site certificate conditions of OAR 345-025-0010 and -0015 were moved from  
10 Division 27 to Division 25 as a result of a subsequent Council rule change. As such, the  
11 Department recommends Council impose new mandatory conditions for the proposed RFA3  
12 facility modifications, using the language and citations consistent with the current Division 25  
13 rules, as presented in the draft amended site certificate and provided in Attachment A of this  
14 order.<sup>7</sup> The Department also recommends that the Council remove the rule reference from the  
15 beginning of each of the mandatory conditions to improve readability and avoid duplication.  
16 Additionally, the Department recommends minor edits to the site certificate to remove  
17 unnecessary and inaccurate references (e.g., references to "pipelines," when the facility is not a  
18 pipeline).

19  
20 Council previously imposed Condition 26 to align with OAR 345-025-0006(3)(a), which requires  
21 that the certificate holder design, construct, operate, and retire the facility substantially as  
22 described in the ASC. In this condition, Council previously established wind turbine dimension  
23 specifications associated with an impact evaluated under a Council standard, such as maximum  
24 blade tip height, and minimum aboveground blade tip clearance. As described in Section II.A.  
25 *Requested Amendment*, the certificate holder requests Council's approval to amend Condition  
26 26 to authorize a lower minimum aboveground blade tip clearance, from 25 to 21.5 meters.  
27 This is further evaluated below in Section III.A.10.1 *Public Health and Safety Standards for Wind  
28 Energy Facilities* of this order.

29  
30 *Certificate Expiration [OAR 345-027-0013]*

31  
32 A site certificate, or amended site certificate, becomes effective upon execution by the Council  
33 Chair and the certificate holder. A site certificate, or amended site certificate, expires if  
34 construction has not commenced on or before the construction commencement deadline, as  
35 established in the site certificate and statutorily required under ORS 469.401(2).

36  
37 The Department's recommendation for the imposition of construction deadlines in the  
38 amended site certificate should reflect a balance between any concern regarding potential  
39 circumstantial changes (regulatory and environmental) and the individual circumstances of the  
40 amendment request. In addition, the Department acknowledges that there are a number of

1 unforeseen factors that can delay a certificate holder’s commencement of construction and  
2 completion, including but not limited to financial, economic, or technological changes. The  
3 Department notes that while each amendment request is evaluated on its own facts, historic  
4 Council decisions on construction and commencement deadlines were reviewed to inform this  
5 analysis. In most instances of decisions on Application for Site Certificates (ASCs), Council has  
6 required construction commencement and completion of wind energy facilities within three  
7 and six years, respectively, after the effective date of the site certificate and in some instances  
8 the completion deadline is established based on date of construction commencement and not  
9 effective date of site certificate.

10  
11 In RFA3 Section 6.13 *Public Services*, the certificate holder explains that proposed RFA3 facility  
12 repower activities would be completed on a rolling schedule, and are assumed to be completed  
13 within a duration of 11 months. The Department recommends Council grant a construction  
14 commencement and completion deadline based upon three years following the amended site  
15 certificate execution date and an additional three years following date of construction  
16 commencement. This timeframe would provide sufficient time for satisfying preconstruction  
17 condition requirements established in the amended site certificate, allow sufficient time to  
18 obtain required permits not governed by the site certificate, and would be consistent with past  
19 Council requirements.<sup>8</sup>

20  
21 In accordance with OAR 345-025-0006(4), the Department recommends Council impose the  
22 following conditions:

23  
24 **Condition 108:** The certificate holder shall begin construction of the Shepherds Flat  
25 Central facility modifications, as approved in the Third Amended Site Certificate, within  
26 three years after the effective date of the amended site certificate [TBD]. The certificate  
27 holder shall notify the Department when construction of the of the facility modifications,  
28 as approved in Request for Amendment 3, commences. Under OAR 345-015-0085(8), the  
29 amended site certificate is effective upon execution by the Council Chair and the  
30 certificate holder.  
31 [Amendment 3]

32  
33 **Condition 109:** The certificate holder shall complete construction of the Shepherds Flat  
34 Central facility modifications, as approved in the Third Amended Site Certificate, within  
35 three years following the date of construction commencement [TBD]. The certificate  
36 holder shall promptly notify the Department of the date of completion of construction of  
37 the facility modifications, as approved in Request for Amendment 3.  
38 [Amendment 3]

1 *Construction and Operation Rules for Facilities [OAR Chapter 345, Division 26]*  
2

3 The Council has adopted rules at OAR Chapter 345, Division 26 to ensure that construction,  
4 operation, and retirement of facilities are accomplished in a manner consistent with the  
5 protection of the public health, safety, and welfare and protection of the environment. These  
6 rules include requirements for compliance plans, inspections, reporting and notification of  
7 incidents. Pursuant to OAR 345-026-0080, a certificate holder is obligated to report to the  
8 Department on facility status and operational experience.  
9

10 **Conclusions of Law**  
11

12 Based on the foregoing findings of fact and conclusions of law, and subject to compliance with  
13 the recommended conditions, the Department recommends that the Council find that the  
14 certificate holder would satisfy the requirements of OAR 345-022-0000.  
15

16 **III.A.2 Organizational Expertise: OAR 345-022-0010**  
17

18 *(1) To issue a site certificate, the Council must find that the applicant has the organizational*  
19 *expertise to construct, operate and retire the proposed facility in compliance with*  
20 *Council standards and conditions of the site certificate. To conclude that the applicant*  
21 *has this expertise, the Council must find that the applicant has demonstrated the ability*  
22 *to design, construct and operate the proposed facility in compliance with site certificate*  
23 *conditions and in a manner that protects public health and safety and has demonstrated*  
24 *the ability to restore the site to a useful, non-hazardous condition. The Council may*  
25 *consider the applicant’s experience, the applicant’s access to technical expertise and the*  
26 *applicant’s past performance in constructing, operating and retiring other facilities,*  
27 *including, but not limited to, the number and severity of regulatory citations issued to*  
28 *the applicant.*  
29

30 *(2) The Council may base its findings under section (1) on a rebuttable presumption that an*  
31 *applicant has organizational, managerial and technical expertise, if the applicant has an*  
32 *ISO 9000 or ISO 14000 certified program and proposes to design, construct and operate*  
33 *the facility according to that program.*  
34

35 *(3) If the applicant does not itself obtain a state or local government permit or approval for*  
36 *which the Council would ordinarily determine compliance but instead relies on a permit*  
37 *or approval issued to a third party, the Council, to issue a site certificate, must find that*  
38 *the third party has, or has a reasonable likelihood of obtaining, the necessary permit or*  
39 *approval, and that the applicant has, or has a reasonable likelihood of entering into, a*  
40 *contractual or other arrangement with the third party for access to the resource or*  
41 *service secured by that permit or approval.*  
42

43 *(4) If the applicant relies on a permit or approval issued to a third party and the third party*  
44 *does not have the necessary permit or approval at the time the Council issues the site*

1            *certificate, the Council may issue the site certificate subject to the condition that the*  
2            *applicant shall not commence construction or operation as appropriate until the third*  
3            *party has obtained the necessary permit or approval and the applicant has a contract or*  
4            *other arrangement for access to the resource or service secured by that permit or*  
5            *approval.*

6  
7            **Findings of Fact**

8  
9            Subsections (1) and (2) of the Council’s Organizational Expertise standard require that the  
10           *applicant (certificate holder) demonstrate its ability to design, construct operate and retire the*  
11           *facility with proposed changes in compliance with Council standards and all site certificate*  
12           *conditions, and in a manner that protects public health and safety, as well as its ability to*  
13           *restore the facility site to a useful, non-hazardous condition. The Council may consider the*  
14           *certificate holder’s experience and past performance in constructing, operating and retiring*  
15           *other facilities in determining compliance with the Council’s Organizational Expertise standard.*  
16           *Subsections (3) and (4) address third party permits.*

17  
18           *Compliance with Council Standards and Site Certificate Conditions*

19  
20           The Council may consider a certificate holder’s past performance, including but not limited to  
21           the quantity or severity of any regulatory citations in the construction or operation a facility,  
22           type of equipment, or process similar to the facility, in evaluating whether a proposed change  
23           may impact the certificate holder’s ability to design, construct and operate a facility, with  
24           proposed changes, in compliance with Council standards and site certificate conditions.<sup>9</sup>

25  
26           The certificate holder, South Hurlburt Wind, LLC, as a wholly owned subsidiary of Caithness  
27           Energy, LLC (Caithness), relies upon the organizational expertise and experience of its parent  
28           company, Caithness. In RFA3, the certificate holder explains that Caithness and its subsidiaries  
29           have not received any regulatory citations in the course of constructing and operating wind  
30           energy facilities. Furthermore, the certificate holder describes Caithness’ direct and relevant  
31           experience to perform upgrading/repowering tasks at the facility through its experience in wind  
32           farm site development, wind farm operation and maintenance (O&M) activities, and staff wind  
33           farm repower experience. Caithness has experience developing and selling wind assets which  
34           required much larger construction activities than repowering. Provided in RFA3, the certificate  
35           holder explains that the Shepherds Flat Management team has industry experience in full  
36           repower construction, including the replacement of all turbine components including towers  
37           with new components at other wind facilities. Additionally, because the facility is currently  
38           operational, activities including turbine component replacement (including blades and nacelles)  
39           occur as part of routine operations and maintenance.

40

1 Based on the compliance history of the certificate holder and its parent company, the  
2 Department recommends that Council finds that the proposed RFA3 facility repower would not  
3 impact the certificate holder’s ability to design, construct, operate and retire the facility in  
4 compliance with Council standards and site certificate conditions.

5

6 *Public Health and Safety*

7

8 The proposed RFA3 facility repower could result in health and safety risks from blade failure,  
9 structural and reliability concerns, ice throw, risks to public and private providers of air  
10 transportation and agricultural services. The evaluation of these risks is presented in Section  
11 III.A.8, *Public Services* and Section III.A.10.1, *Public Health and Safety Standards for Wind*  
12 *Facilities* of this order. Based on the reasoning and analysis provided in the sections described,  
13 the Department recommends that the Council find that the proposed RFA3 facility repower,  
14 including the change to minimum aboveground blade tip clearance would not impact the  
15 certificate holder’s ability to design, construct, and operate the facility in a manner that  
16 protects public health and safety.

17

18 *Ability to Restore the Site to a Useful, Non-Hazardous Condition*

19

20 As described in Table 4 of Section III.B, *Standards Not Likely to be Impacted by Request for*  
21 *Amendment 3*, the proposed RFA3 facility repower would not be expected to impact the  
22 certificate holder’s ability to restore the facility site to a useful, non-hazardous condition.

23

24 *ISO 900 or ISO 14000 Certified Program*

25

26 OAR 345-022-0010(2) is not applicable because the certificate holder has not proposed to  
27 design, construct or operate the amended facility according to an ISO 9000 or ISO 14000  
28 certified program.

29

30 *Third-Party Permits*

31

32 OAR 345-022-0010(3) addresses the requirements for potential third party permits. In RFA3,  
33 the certificate holder describes that the proposed RFA3 facility repower would not require  
34 any additional third-party permits that would normally be governed by the site certificate.

35

36 **Conclusions of Law**

37

38 Based on the evidence in the record, the Department recommends that the Council find that  
39 the certificate holder would continue to satisfy the requirements of the Council’s  
40 Organizational Expertise standard.

41

1        III.A.3 Structural Standard: OAR 345-022-0020

2  
3        *(1) Except for facilities described in sections (2) and (3), to issue a site certificate, the*  
4            *Council must find that:*

5  
6            *(a) The applicant, through appropriate site-specific study, has adequately*  
7            *characterized the seismic hazard risk of the site;*

8  
9            *(b) The applicant can design, engineer, and construct the facility to avoid dangers to*  
10           *human safety and the environment presented by seismic hazards affecting the*  
11           *site, as identified in subsection (1)(a);*

12  
13           *(c) The applicant, through appropriate site-specific study, has adequately*  
14           *characterized the potential geological and soils hazards of the site and its vicinity*  
15           *that could, in the absence of a seismic event, adversely affect, or be aggravated*  
16           *by, the construction and operation of the proposed facility; and*

17  
18           *(d) The applicant can design, engineer and construct the facility to avoid dangers to*  
19           *human safety and the environment presented by the hazards identified in*  
20           *subsection (c).*

21  
22        *(2) The Council may not impose the Structural Standard in section (1) to approve or deny*  
23           *an application for an energy facility that would produce power from wind, solar or*  
24           *geothermal energy. However, the Council may, to the extent it determines*  
25           *appropriate, apply the requirements of section (1) to impose conditions on a site*  
26           *certificate issued for such a facility.*

27  
28        *(3) The Council may not impose the Structural Standard in section (1) to deny an*  
29           *application for a special criteria facility under OAR 345-015-0310. However, the*  
30           *Council may, to the extent it determines appropriate, apply the requirements of*  
31           *section (1) to impose conditions on a site certificate issued for such a facility.*

32  
33        **Findings of Fact**

34  
35        As provided in section (1) above, the Structural Standard generally requires the Council to  
36        evaluate whether the applicant (certificate holder) has adequately characterized the potential  
37        seismic, geological and soil hazards of the site, and that the applicant (certificate holder) can  
38        design, engineer and construct the facility to avoid dangers to human safety from these  
39        hazards.<sup>10</sup> Pursuant to OAR 345-022-0020(2), the Council may issue a site certificate for a wind  
40        energy facility without making findings regarding compliance with the Structural Standard;

1 however, the Council may apply the requirements of the standard to impose site certificate  
2 conditions. The analysis area for the Structural Standard is the area within the site boundary.

3  
4 In accordance with the informational requirements established in OAR 345-021-0010(1)(g)(B),  
5 the certificate holder completed consultation with the Oregon Department of Geology and  
6 Mineral Industries (DOGAMI) on August 20, 2019 to discuss the scope of the repowering activity  
7 and appropriate level of seismic and non-seismic impact evaluation. During consultation,  
8 DOGAMI Resilience Engineer, Yumei Yang, P.E., requested information on how seismic ground  
9 motions that exceed the building code response spectrum would be addressed and requested  
10 disaster resilience and future climate change be addressed.<sup>11</sup>

11  
12 *Potential Seismic, Geological and Soil Hazards*

13  
14 In RFA2, in response to the DOGAMI consultation, the certificate holder conducted an American  
15 Society for Civil Engineers (ASCE) publication 7-16 analysis using the coordinates for turbines T-  
16 368 and T-370. The analysis shows that there was a slight decrease in the seismic ground  
17 acceleration factors ( $S_s$  and  $S_1$ ) for the facility, when compared to the analysis conducted under  
18 the parameters of ASCE publication 7-10. The certificate holder explains that although highly  
19 unlikely given the lack of recent activity, potential sources of long-period ground motions could  
20 include a significant event at or near recent faults associated with the Arlington-Shulter Butte  
21 faults and Columbia Hills structure as identified in the 2007 Seismic Hazard Assessment. The  
22 Seismic Hazard Assessment was conducted as part of the original ASC (Shannon & Wilson, Inc.  
23 2007). Given adequate seismic design, the potential impacts of long-period ground motions are  
24 not expected to impact the proposed RFA3 facility repower.

25  
26 *Design, Engineer and Construct Facility to Avoid Dangers to Human Safety from Seismic and*  
27 *Non-Seismic Hazards*

28  
29 The certificate holder has presented evidence in RFA3 that it can design, engineer, and  
30 construct the proposed RFA3 facility repower to avoid dangers to human safety and the  
31 environment in accordance with the Council's Structural Standard. The proposed repowering  
32 activity would include the removal and replacement of existing turbine blades with longer  
33 blades, and the replacement and modification to associated machinery including the rotor  
34 upgrade (replacing the hub casting), modification to existing nacelles roof, and an installation of  
35 a new gearbox and bedplate.

36  
37 In RFA2, the Council imposed site certificate Condition 105, requiring the certificate holder to  
38 implement an ongoing inspection, monitoring, and remediation program for the O&M  
39 demonstration activity at wind turbines 368 and 370. This condition was imposed based on the  
40 specific recommendations made in RRC's visual inspection report and as provided in RFA2  
41 Attachment 3 Foundation Analysis.

1  
2 The existing turbine foundation and tower would remain in place. To demonstrate that the  
3 proposed RFA3 facility repower would be designed, engineered and constructed to avoid  
4 dangers to human safety from seismic and non-seismic hazards, in Section 6.3 of RFA3, the  
5 certificate holder explains that a foundation uprate analysis will be conducted on turbines  
6 within the Facility, to review the original foundation calculations with the new loading  
7 documents to verify whether the existing turbine foundations can support the newly proposed  
8 loading. Moreover, the evaluation will be conducted by a licensed engineer using current code  
9 requirements and state-of-practice methods and will be provided to the Department and  
10 DOGAMI. The findings and analysis of the upgrade analysis will be reviewed by the Caithness  
11 engineering staff, from which any necessary mitigation and remediation measures, or  
12 operational timing recommendations may be identified. Based on potential mitigation and  
13 remediation measures, or timing recommendations as a result of the foundation uprate  
14 analysis, the Department recommends that the Council impose condition 110 as follows:

15  
16 **Recommended Condition 110:** Prior to Amendment #3 facility repower activities, the  
17 certificate holder shall provide the Department with the foundation uprate analysis on  
18 facility turbines. If the analysis results identify necessary mitigation and remediation  
19 measures, or operational timing recommendations, the certificate holder shall  
20 implement the identified measures and recommendations prior to beginning the  
21 repowering activities unless otherwise approved by the Department.

22 [Amendment #3]  
23

24 Council previously imposed Condition 62, which requires the certificate holder to have an  
25 operational safety-monitoring program and shall inspect all turbine and turbine tower  
26 components on a regular basis. The certificate holder shall maintain or repair turbine and  
27 turbine tower components as necessary to protect public safety. In RFA3, the certificate holder  
28 proposes an amendment to Condition 62, to require an inspection of all turbine and turbine  
29 tower components within 6 months of being repowered, in an effort to focus the operational  
30 inspection process and procedures on the applicable proposed RFA3 facility repower  
31 components. As such, the Department recommends that Council amend Condition 62 as  
32 provided below:

33  
34 **Recommended Amended Condition 62:** The certificate holder shall have an operational  
35 safety-monitoring program and shall inspect all turbine and turbine tower components  
36 on a regular basis. All turbine and turbine tower components will be inspected within 6  
37 months of being repowered. The certificate holder shall maintain or repair turbine and  
38 turbine tower components as necessary to protect public safety. [Amendment #3]  
39

#### 40 *Integration of Disaster Resilience Design*

41  
42 In RFA3, the certificate holder explains that although disaster resilience and climate change  
43 impacts were not addressed in the original ASC, the facility has been in operation for 8 years,  
44 and during that time, climate change has not impacted the facility. Disasters such as those

1 relating to greater-intensity rainfall events, fluctuations in typical annual snowpack (above or  
2 below normal), and warmer average annual temperatures, are not anticipated to have a  
3 major impact on the geologic, geotechnical, and seismic conditions at the Facility.  
4 Furthermore, sea level rise will not affect the Facility due to its location.  
5

6 Additionally, in RFA3, the certificate holder explains that GE Renewables, a contractor that  
7 performs O&M activities at the facility, maintains an Emergency Preparedness and Fire  
8 Prevention Plan that outlines the procedures to effectively respond to lightening and high  
9 winds, icing on blades or external equipment, cold weather work, and EMS coordination  
10 including on-site safety requirements and communication protocols. This Plan, which is  
11 updated on an annual basis was included as Attachment 5 of RFA3.  
12

13 Based upon compliance with both existing and proposed site certificate conditions, and  
14 because the proposed amendment would not result in the placement of facility components  
15 within geologic areas that have not been previously evaluated, the Department recommends  
16 that Council find that the proposed amendment would not affect the certificate holder's  
17 characterization of the site or seismic and non-seismic hazards, or its ability to design, engineer,  
18 and construct the facility to avoid dangers to human safety presented by seismic, geologic or  
19 soils hazards.  
20

### 21 **Conclusions of Law**

22

23 Based on the foregoing analysis, subject to compliance with existing and recommended  
24 conditions, and in compliance with OAR 345-022-0020(2), the Department recommends that  
25 the Council find that the certificate holder would satisfy the requirements of the Council's  
26 Structural Standard.  
27

#### 28 **III.A.4 Soil Protection: OAR 345-022-0022**

29

30 *To issue a site certificate, the Council must find that the design, construction and*  
31 *operation of the facility, taking into account mitigation, are not likely to result in a*  
32 *significant adverse impact to soils including, but not limited to, erosion and chemical*  
33 *factors such as salt deposition from cooling towers, land application of liquid effluent,*  
34 *and chemical spills.*  
35

### 36 **Findings of Fact**

37

38 The Soil Protection standard requires the Council to find that the design, construction, and  
39 operation of a proposed facility, or facility with proposed changes, is not likely to result in  
40 significant adverse impacts to soils.  
41

42 The analysis area for the Soil Protection standard, as defined in the project order, includes the  
43 area within the site boundary.  
44

1 *Potential Significant Adverse Impacts to Soil*

2

3 Potential impacts to soils within the analysis area (site boundary) could occur during  
4 construction and operation of the proposed RFA3 facility repower from spills or releases of  
5 chemicals or other liquid materials. The certificate holder explains that the RFA3 facility  
6 repower would temporarily impact approximately 150 acres, and that approximately 15 of the  
7 total 150 acres would require grading. In RFA3 Section 6.4 *Soil Protection*, the certificate holder  
8 explains that temporary disturbance would be minimized by utilizing previously disturbed  
9 areas, including roadways and turbine pads. To protect existing plant cover during construction,  
10 the certificate holder would avoid scraping vegetation from areas of temporary disturbance  
11 (per Condition 76). Additionally, existing best management practices (BMPs) would be  
12 implemented to control any dust that is generated by upgrading activities, such as applying  
13 water to roads and disturbed soil areas (Condition 75). Once the crane is removed from the  
14 site, the temporary, superficial disturbance would be revegetated according to Condition 77  
15 and 84, as is routinely done as part of O&M activities. The Revegetation Plan is included as  
16 Attachment D to this Order.

17

18 Traffic impacts would be minimized and managed by restricting facility modification activities to  
19 areas previously approved for both temporary and permanent impacts, utilize a rolling  
20 construction schedule and applying additional measures including the use of flaggers, as  
21 needed, on roads (recommended Condition 108). The certificate holder states that the  
22 approximate 150 acres of temporary impact is less than 40 percent of the maximum temporary  
23 impacts previously approved in the Amendment #1. Council previously imposed Condition 74,  
24 which would continue to apply to the proposed RFA3 facility repower and would ensure that  
25 truck traffic would be limited to designated existing and improved road surfaces to avoid soil  
26 compaction, to the extent practicable.

27

28 As mentioned above in Section II.A. *Requested Amendment*, the certificate holder states that if  
29 determined to be necessary, a National Pollutant Discharge Elimination System (NPDES) Storm  
30 Water Discharge General Permit 1200-C would be obtained from the Oregon Department of  
31 Environmental Quality (DEQ). The NPDES Storm Water Discharge Permit #1200-C would include  
32 an approved Erosion Sediment Control Plan (ESCP). Council previously imposed Condition 73,  
33 which would continue to apply to the proposed repowering activities of RFA3, and would  
34 ensure that a DEQ-issued 1200-C NPDES permit is obtained prior to construction and that  
35 erosion control measures are implemented in accordance with the ESCP, if determined to be  
36 necessary. To ensure that the requirements of Condition 73 apply to the repowering activities  
37 associated with RFA3, the Department recommends Council amend the condition as follows:

38

39 **Recommended Amended Condition 73:** The certificate holder shall conduct all  
40 construction work, including the repowering activities associated with Amendment #3, in  
41 compliance with an Erosion and Sediment Control Plan (ESCP) satisfactory to the Oregon  
42 Department of Environmental Quality and as required under the National Pollutant  
43 Discharge Elimination System (NPDES) Storm Water Discharge General Permit #1200-C.  
44 The certificate holder shall include in the ESCP any procedures necessary to meet local

1 erosion and sediment control requirements or storm water management requirements.

2 [Amendment #3]

3  
4 Potential impacts to soils from spills could occur during the repowering activities, however,  
5 previously imposed Condition 50 will continue to apply to the proposed RFA3 facility  
6 repowering, and would ensure that hazardous materials present on site, are handled in a  
7 manner that protects public health, safety, and the environment, and that applicable  
8 environmental laws and regulations are complied with. Previously imposed Condition 51,  
9 addressing the preparation for, and the response to spills and accidental releases of hazardous  
10 materials will also continue to apply to the repowering activities of RFA3.

11  
12 Based upon compliance with the existing site certificate conditions, the Council finds that the  
13 design, construction and operation of the proposed RFA3 facility repowering would not result in  
14 a significant adverse impact to soils.

15  
16 **Conclusions of Law**

17  
18 Based on the foregoing findings of fact and conclusions of law, and subject to compliance with  
19 existing site certificate conditions, the Department recommends the Council find that the  
20 proposed RFA3 repowering activities would comply with the Council's Soil Protection standard.

21  
22 III.A.5 Land Use: OAR 345-022-0030

23  
24 *(1) To issue a site certificate, the Council must find that the proposed facility complies with*  
25 *the statewide planning goals adopted by the Land Conservation and Development*  
26 *Commission.*

27  
28 *(2) The Council shall find that a proposed facility complies with section (1) if:*

29  
30 *(a) The applicant elects to obtain local land use approvals under ORS 469.504(1)(a) and*  
31 *the Council finds that the facility has received local land use approval under the*  
32 *acknowledged comprehensive plan and land use regulations of the affected local*  
33 *government; or*

34  
35 *(b) The applicant elects to obtain a Council determination under ORS 469.504(1)(b) and*  
36 *the Council determines that:*

37  
38 *(A) The proposed facility complies with applicable substantive criteria as described in*  
39 *section (3) and the facility complies with any Land Conservation and*  
40 *Development Commission administrative rules and goals and any land use*  
41 *statutes directly applicable to the facility under ORS 197.646(3);*

42  
43 *(B) For a proposed facility that does not comply with one or more of the applicable*  
44 *substantive criteria as described in section (3), the facility otherwise complies*

1                    *with the statewide planning goals or an exception to any applicable statewide*  
2                    *planning goal is justified under section (4); or*

3  
4                    (C) *For a proposed facility that the Council decides, under sections (3) or (6), to*  
5                    *evaluate against the statewide planning goals, the proposed facility complies*  
6                    *with the applicable statewide planning goals or that an exception to any*  
7                    *applicable statewide planning goal is justified under section (4).*

8                    \*\*\*

9                    **Findings of Fact**

10  
11                    The Land Use standard requires the Council to find that the proposed RFA3 facility repower  
12                    would continue to comply with local applicable substantive criteria, as well as the statewide  
13                    planning goals adopted by the Land Conservation and Development Commission (LCDC).<sup>12</sup>  
14                    Under ORS 469.504(1)(b)(A), the Council may find compliance with statewide planning goals if  
15                    the Council finds that the proposed RFA3 facility repower, “complies with applicable  
16                    substantive criteria from the affected local government’s acknowledged comprehensive plan  
17                    and land use regulations that are required by the statewide planning goals and in effect on the  
18                    date the application is submitted.” RFA3 was received on October 7, 2019.

19  
20                    The analysis area for potential land use impacts, as defined in the project order, is the area  
21                    within and extending ½-mile from the site boundary. The facility, as approved and with  
22                    proposed changes, is located within the land use jurisdictions of Gilliam County and Morrow  
23                    County. On behalf of and as authorized by the SAG, Gilliam and Morrow County Planning  
24                    Directors identified applicable substantive criteria to be considered during the ASC phase and  
25                    through subsequent amendment requests has identified changes in local code to be considered  
26                    applicable substantive criteria.<sup>13</sup>

27  
28                    **Facility Modifications**

29  
30                    In RFA3, the certificate holder requests Council approval to replace existing wind turbine blades  
31                    and nacelles, or repower, up to 114 of the existing 116 wind turbines, which would increase the  
32                    maximum blade tip height and lower the minimum aboveground blade tip clearance. The  
33                    proposed RFA3 facility repower would also result in approximately 150 acres of temporary  
34                    disturbance within the previously approved site boundary.

35  
36                    **Local Applicable Substantive Criteria**

37  
38                    Under OAR 345-022-0030(2), the Council must apply the applicable substantive criteria  
39                    recommended by the SAG. On August 25, 2006, during the review of the ASC, the Council

<sup>12</sup> The Council must apply the Land Use standard in conformance with the requirements of ORS 469.504.

<sup>13</sup> Under ORS 469.480(1), the Council must designate as a Special Advisory Group the governing body of any local government within whose jurisdiction the facility is proposed or proposed changes of a facility would be located.

1 Appointed the Gilliam County Court and the Morrow County Court (now Morrow County Board  
 2 of Commissioners) as special advisory groups for the Shepherds Flat Wind Facility application  
 3 review.<sup>14</sup>  
 4

5 The applicable substantive criteria for which the certificate holder must comply are established  
 6 in the Gilliam County Zoning and Land Development Ordinance (GCZO) and Gilliam County  
 7 Comprehensive Plan (GCCP), as updated and amended in 2017, as well as in the Morrow County  
 8 Zoning Ordinance (MCZO) and Morrow County Comprehensive Plan (MCCP). The application  
 9 criteria from GCZO and goals and policies from GCCP are presented below in Table 1, *Gilliam  
 10 County Applicable Substantive Criteria*, and the application criteria from MCZO and goals and  
 11 policies from the MCCP are presented below in Table 2, *Morrow County Applicable Substantive  
 12 Criteria*.

1 The Gilliam County applicable substantive criteria that are required for a new wind facility are  
2 presented in Table 1: *Gilliam County Applicable Substantive Criteria* above. The portion of the  
3 project within Gilliam County is located entirely within the Exclusive Farm Use zone (EFU). GCZO  
4 Article 4 establishes that wind facilities for the primary purpose of generating power for public  
5 use by sale are allowed subject to conditional use review, in addition to other referenced  
6 standards. GCZO Article 7 covers conditional uses, including wind energy facilities located on  
7 EFU-zoned land, such as the SFC facility.

8  
9 At the time of the original site certificate issuance and the first site certificate amendment, the  
10 Council approved the facility's conditional use permit, and Gilliam County subsequently issued a  
11 conditional use permit. Article 7, Section 7.020(T)(7)(c)(2) of the GCZO defines when an  
12 amendment to a conditional use permit for a wind energy facility is required. It is noted that  
13 the 2017 GCZO update includes specific code provisions that apply to wind energy facilities,  
14 including turbine setback requirements and other criteria that were not in effect at the time of  
15 the original site certificate authorization or the previous site certificate amendment approval.

16  
17 There are two areas of the GCZO Article 7 that could apply to potential amendments to existing  
18 conditional use permits. The first is the preamble language in Section 7.010:

19  
20 *A conditional use listed in this ordinance shall be permitted, altered or denied in*  
21 *accordance with the standards and procedures of this ordinance and this article by*  
22 *action of the Planning Commission or Planning Director. In the case of a use existing*  
23 *prior to the effective date of this ordinance, and classified in this ordinance as a*  
24 *Conditional Use, a change in use or in lot area or an alteration of a Conditional Use, a*  
25 *change in use or in lot area or an alteration of structure shall conform with the*  
26 *requirements for a Conditional Use.*

27  
28 The second area is GCZO Article 7, Section 7.020(T)(7)(c)(2) governing the decision as to when  
29 an existing conditional use permit is required to be amended:

30  
31 *An amendment to the conditional use permit shall be required if proposed facility*  
32 *changes would:*

- 33 a. *Increase the land area taken out of agricultural production by an additional 20*  
34 *acres or more;*  
35 b. *Increase the land area taken out of agricultural production sufficiently to trigger*  
36 *taking a Goal 3 exception;*  
37 c. *Require an expansion of the established facility boundaries;*  
38 d. *Increase the number of towers;*  
39 e. *Increase generator output by more than 25 percent relative to the generation*  
40 *capacity authorized by the initial permit due to the repowering or upgrading of*  
41 *power generation capacity.*

42  
43 Because GCZO Article 7, Section 7.020(T)(7)(c)(2) is the more specific language, it should be  
44 considered controlling, and the Department must only evaluate the criteria in subsections (a) –

1 (e) to determine whether or not an amendment to the Gilliam County conditional use permit is  
 2 required.

3

4 Based on the record of the request for amendment 3, the RFA3 activities would not:

- 5 • Increase the land area taken out of agricultural production;
- 6 • Require an expansion of the facility site boundary;
- 7 • Increase the number of turbine towers; or
- 8 • Increase generator output by more than 25 percent.

9

10 Based on the findings presented here, the Department recommends that Council find that the  
 11 RFA3 activities would not trigger any of the criteria listed in (a)-(e), and as such, the RFA3  
 12 activities (repowering) would not require an amended conditional use permit. The Department  
 13 therefore recommends that no further evaluation of Gilliam County’s applicable substantive  
 14 criteria must be conducted. Council previously imposed site certificate Condition 40, requiring  
 15 specific setback distances of facility components from residential properties, public roads, and  
 16 the lease area. This condition continues to apply to RFA3 activities.

17

18 **III.A.5.2 Morrow County**

19

20 Table 2, *Morrow County Applicable Substantive Criteria*, below, summarizes the applicable  
 21 substantive criteria that the Council previously evaluated and determined the certificate holder  
 22 satisfied as well as any differentiation in current applicable substantive criteria.

The Department reviewed the applicable substantive criteria as presented in Table 2: *Morrow County Applicable Substantive Criteria*. The portion of the project within Morrow County is located entirely within the Exclusive Farm Use zone (EFU). MCZO Article 3 establishes that wind facilities for the primary purpose of generating power for public use by sale are allowed subject to conditional use review, in addition to other referenced standards. MCZO Article 6 covers conditional uses, including wind energy facilities located on EFU-zoned land, such as the Shepherds Flat Central facility. As required, Morrow County previously issued a conditional use permit for the facility, based on the findings and direction of the Council. MCZO Section 6.010 states that “an alteration of a structure shall conform with the requirements for a conditional use.” The proposed RFA3 facility repower would result in alterations to existing wind turbines, including changes in maximum blade tip height, aboveground blade tip clearance and temporary disturbance, which the Department considers alterations of structures under Section 6.010.

Based on the Departments review of the amendment request, because the site boundary was previously approved and would not change, and RFA3 construction activities would be conducted on current or previously disturbed areas, and the site certificate contains a number of conditions and this order contains recommended new conditions that would apply to the facility as amended, the proposed RFA3 facility repower would not be expected to impact the certificate holder’s ability to satisfy requirements of the applicable substantive criteria listed above and would comply with the requirements for a conditional use, as required by MCZO Section 6.010. MCZO does not contain wind-facility specific setback requirements, though the requirements of site certificate Condition 40 continue to apply to the facility, as amended, in both Morrow and Gilliam Counties. In RFA3, the certificate holder asserts that the proposed RFA3 facility repower would comply with Condition 40.<sup>15</sup>

---

<sup>15</sup> In RFA3, the certificate holder affirms that based on a setback analysis for the repowered turbines, if repowered, one wind turbine will not be able to meet the setbacks and therefore will not be repowered.

1 The SFC facility is not located on high-value farmland soils. RFA3 activities would not be  
2 expected to negatively impact farming operations as the facility is already existing, and  
3 repowering construction will utilize existing roads and other previously-disturbed areas. Areas  
4 of temporary impact would be restored in accordance with recommended site certificate  
5 Condition 112 and the Revegetation Plan included as Attachment D. Recommended Condition  
6 113 would require a Weed Control plan to be developed and implemented in consultation with  
7 both Morrow and Gilliam County weed control departments. Recommended amended  
8 Condition 73 would require RFA3 activities be conducted in accordance with an Erosion and  
9 Sediment Control Plan as required by Oregon Department of Environmental Quality under the  
10 NPDES 1200-C permit. Finally, existing site certificate Conditions 36 and 37 continue to apply to  
11 the facility, as amended, and include requirements to consult with area landowners and lessees  
12 and implement measures to reduce or avoid adverse impacts to farm practices on surrounding  
13 lands, to avoid increases in farming costs, and to use the minimum land area necessary for safe  
14 facility construction and operation.

15  
16 Based on the findings presented here, and subject to compliance with existing and  
17 recommended new conditions, the Department recommends the Council find that RFA3 facility  
18 repowering would comply with applicable substantive criteria from Morrow and Gilliam  
19 Counties, and as such, the facility would comply with the Council’s Land Use standard.

20  
21 **Conclusions of Law**

22  
23 Based on the foregoing findings and the evidence in the record, and subject to compliance with  
24 recommended new and existing site certificate conditions, the Department recommends the  
25 Council find that the proposed RFA3 facility repower would continue to comply with the Land  
26 Use standard.

27  
28 **III.A.6 Fish and Wildlife Habitat: OAR 345-022-0060**

29  
30 *To issue a site certificate, the Council must find that the design, construction and*  
31 *operation of the facility, taking into account mitigation, are consistent with:*

- 32  
33 *(1) The general fish and wildlife habitat mitigation goals and standards of OAR 635-415-*  
34 *0025(1) through (6) in effect as of February 24, 2017\*\*\**

35  
36 **Findings of Fact**

37  
38 The EFSC Fish and Wildlife Habitat standard requires the Council to find that the design,  
39 construction and operation of a proposed facility, or facility with proposed changes, is  
40 consistent with the Oregon Department of Fish and Wildlife’s (ODFW) habitat mitigation policy,  
41 goals, and standards, as set forth in OAR 635-415-0025. The ODFW Habitat Mitigation Policy  
42 and EFSC Fish and Wildlife Habitat standard create requirements to mitigate impacts to fish and  
43 wildlife habitat, based on the quantity and quality of the habitat as well as the nature, extent,  
44 and duration of the potential impacts to the habitat. The policy also establishes a habitat

1 classification system based on value the habitat would provide to a species or group of species.  
2 There are six habitat categories; Category 1 being the most valuable and Category 6 the least  
3 valuable.

4  
5 The analysis area for the Fish and Wildlife Habitat standard includes the area within and  
6 extending ½-mile from the site boundary.

7  
8 *Habitat Types and Categories in the Analysis Area*  
9

10 To identify potential habitat category and types within the temporary work areas of the  
11 proposed RFA3 facility repower, the certificate holder relied upon a combination of 2010  
12 preconstruction habitat categorization data and aerial imagery. As further discussed below,  
13 habitat types and categories that may be impacted by RFA3 activities include: Category 2  
14 Grassland , and Shrub-steppe (Sagebrush); Category 3 Grassland, Previously Cultivated, and  
15 Shrub-steppe (Sagebrush and Rabbitbrush); Category 4 Grassland, Previously Cultivated, and  
16 Rock and Sand; Category 5 Previously Cultivated, Shrub-steppe (broom snakeweed); and  
17 Category 6 Dryland Wheat and Roads, and parking.

18  
19 *Potential Habitat Impacts*  
20

21 As described above in Section II.A. *Requested Amendment* of this order, the proposed RFA3  
22 facility repower would include temporary laydown areas used to stage and store construction  
23 equipment, improvements to existing access roads and turbine pad areas, and temporary  
24 turnaround areas, resulting in approximately 150 acres of temporary disturbance. Based on the  
25 habitat categories (3, 4 and 5) and types (Grassland, Shrub-steppe, Rock and Sand) described  
26 above, potential habitat impacts would include temporary and temporal habitat loss. Impacts  
27 to Category 6 habitat do not require compensatory mitigation under the Council’s Fish and  
28 Wildlife Habitat standard.

29  
30 In Section 6.8.1 of RFA3, the certificate holder explains that temporary disturbance to  
31 vegetation would be limited to areas previously disturbed during facility construction.  
32 Furthermore, the certificate holder indicates that the temporary disturbance resulting from the  
33 proposed RFA3 facility repower would be smaller (less) in area than the areas previously  
34 disturbed during construction.

35  
36 As presented in Table 3, *Estimated Acreage of the Proposed RFA3 Facility Repower (by Category*  
37 *and Subtype)* below, the repowering activities would temporarily disturb approximately 15.4,  
38 51.1, 28.7, 2, and 52.9 acres of Category 2, 3, 4 , 5, and 6 respectively, resulting in temporary  
39 and temporal habitat impacts.<sup>16</sup>  
40

<sup>16</sup> The Department notes that the proposed RFA3 facility repower would not permanently impact any habitat during construction or operation of the repowered turbines.

 2 Temporal loss refers to loss of habitat function and values from the time an impact occurs to  
 3 the time when the restored habitat provides a pre-impact level of habitat function. Habitat  
 4 types identified within the site boundary with a sagebrush steppe component are reasonably  
 5 expected to require a longer restoration timeframe (5+ years) and therefore, the temporary  
 6 impacts to approximately 5.9 acres to shrub steppe – sage steppe would be expected to result  
 7 in temporal loss.

8  
 9 If not appropriately controlled, invasive weeds can become established. Council previously  
 10 imposed Condition 38, requiring the certificate holder implement a weed control plan during  
 11 facility construction and operation. However, based on a consultation with Gilliam County  
 12 Weedmaster Don Ferrar, the approximate 11-month schedule the certificate holder anticipates  
 13 the facility repower to take, and the understanding that there are specific methods that provide  
 14 a higher rate of successful weed control following disturbance impacts near roadways, which  
 15 are the predominant expected disturbance impacts from RFA3, the Department recommends  
 16 Council impose a new condition requiring a specific Weed Control Plan be developed, in  
 17 consultation with the Department and both the Gilliam County Weed Control Department and  
 18 the Morrow County Weed Control Department, that addresses agency consultation, weed

1 identification, application methods, appropriate control methods monitoring and reporting. The  
2 Departments recommended Condition is as follows:

3  
4 **Recommended Condition 111:** Prior to Amendment #3 facility repower activities, the  
5 certificate holder shall coordinate with the Gilliam County Weed Department and the  
6 Morrow County Weed Control Department, and submit to the Department, a Roadway  
7 Weed Control Plan. The Department shall review and approve the plan, in consultation  
8 with the Gilliam County Weed Department and the Morrow County Weed Control  
9 Department. The Roadway Weed Control Plan shall include, as pertinent, but not be  
10 limited to, identification of county-listed weeds of economic concern, methods for  
11 evaluating weeds within impact area, results of weed assessment, control methods  
12 specific to roadway weed control and timing, agency consultation protocol, and process  
13 for evaluating success of weed control.  
14 [Amendment #3]

15  
16 *Proposed Habitat Mitigation (Temporary and Temporal Loss)*

17  
18 The certificate holder proposes to mitigate temporary habitat impacts through revegetation  
19 and noxious weed control. Council previously imposed Condition 38 and 84 requiring that the  
20 certificate holder implement plans to control the introduction and spread of noxious weeds and  
21 revegetate temporarily disturbed areas. However, because this temporary disturbance would  
22 be at different stages than weed control and revegetation activities implemented under the  
23 existing plans, the Department recommends Council impose new conditions to allow the  
24 certificate holder and Department the ability to implement and track measures that apply  
25 specifically to the proposed RFA3 facility repower disturbance areas. The Department  
26 recommends Council impose Condition 111, requiring that, prior to RFA3 facility repower  
27 activities, the certificate holder submit a Roadway Weed Control Plan, for review by the  
28 Department, in consultation with the Gilliam County and Morrow County Weed Control  
29 Departments. The Department's recommended condition related to revegetation is presented  
30 below:

31  
32 **Recommended Condition 112:** The certificate holder shall:

33 (a) Prior to RFA3 facility repower activities:

- 34 i. Provide an updated habitat assessment of areas of disturbance, based on a  
35 protocol approved by the Department in consultation with ODFW.  
36 ii. Identify monitoring and reference sites, including sites within each habitat  
37 category and subtype impacted, and the methodology utilized for selecting the  
38 number of monitoring and reference sites should be included.  
39 iii. Consult with the Department, ODFW and Gilliam County Weed Control  
40 Department and Morrow County Weed Control Department on timing and  
41 methods for revegetation and weed control.

42 (b) Following completion of RFA3 facility repower activities:

- 43 i. Restore areas temporarily disturbed by RFA3 facility repower activities  
44 according to the methods and monitoring procedures described in the

1 Revegetation Plan that is incorporated in the Final Order on Amendment 3 for  
2 Shepherds Flat Central as Attachment D and as amended from time to time.

3 ii. Consult annually with the Department, ODFW, Gilliam and Morrow County  
4 Weed Control Departments on timing and methods for revegetation and weed  
5 control.

6 [Amendment #3]

7  
8 Based on compliance with the recommended new conditions, the Department recommends the  
9 Council find that the certificate holder would meet the habitat mitigation goals for temporary  
10 habitat impacts.

11  
12 The certificate holder's existing Habitat Mitigation Plan (HMP) addresses temporal habitat  
13 impacts (i.e. loss of habitat function and values from the time an impact occurs to the time  
14 when the restored habitat provides a pre-impact level of habitat function) in the form of a  
15 permanent conservation easement on a habitat mitigation area (HMA). Specifically, for  
16 temporal habitat impacts, the certificate holder has included in its HMA 0.5 acre for every 1  
17 acre of Category 3 Shrub-steppe sage habitat temporarily disturbed (a 0.5:1 ratio). Because the  
18 areas of temporary disturbance are within previously disturbed areas, the temporal habitat  
19 impacts that would occur as a result of the proposed RFA3 facility repower have been  
20 accounted for in the HMA and are addressed in the existing HMP. Based on compliance with  
21 the existing HMP, the Department recommends the Council find that the certificate holder  
22 would meet the habitat mitigation goals for temporal habitat impacts.

23  
24 *Potential Impact to State-Sensitive Species*

25  
26 The certificate holder conducted a desktop review to identify State Sensitive species with the  
27 potential to occur within the analysis area based on species range and existing habitat. The  
28 desktop review evaluated ODFW's 2016 Sensitive Species List. Based on this desktop review,  
29 the certificate holder identified suitable habitat within the analysis area for: 18 State-sensitive  
30 species (including 1 reptile, 10 birds, and 5 bat species). Of these State-sensitive species,  
31 presence was confirmed for the following: 10 birds and 2 bats.

32  
33 The certificate holder identifies that increased activity during the proposed RFA3 facility  
34 repower could result in potential impacts to state-sensitive species during nesting season,  
35 including ferruginous hawk and Swainson's hawk. To minimize potential disturbance impacts to  
36 state-sensitive species, the Department recommends Council impose the following condition:

37  
38 **Recommended Condition 113:** The certificate holder shall:

39 (a) Prior to RFA3 facility repower activities, the certificate holder shall conduct a pre-  
40 construction raptor nest survey, using a protocol approved by the Oregon Department  
41 of Fish and Wildlife (ODFW) to determine whether there are any active nests of state  
42 sensitive species within 0.5 miles of any areas that would be disturbed.

43 (b) During RFA3 repower activities, if active raptor nests were identified within 0.5-mile of  
44 RFA3 repower activities per (a) of this condition or become active during the sensitive

1 season, per (c) below, the certificate holder shall avoid construction activities within  
2 0.25 mile buffer in areas around active nests of the following species during the  
3 sensitive period, as provided in this condition:  
4

<u>Species</u>	<u>Sensitive Period</u>	<u>Early Release Date</u>
<u>Swainson's hawk</u>	<u>April 1 to August 15</u>	<u>May 31</u>
<u>Ferruginous hawk</u>	<u>March 15 to August 15</u>	<u>May 31</u>
<u>Burrowing owl</u>	<u>April 1 to August 15</u>	<u>July 15</u>

5  
6 (c) During RFA3 repower activities, if a nest becomes occupied by any of these species  
7 after the beginning of the sensitive period, the certificate holder will flag the  
8 boundaries of a 0.25-mile buffer area around the nest and shall instruct construction  
9 personnel to avoid disturbance of the area.

10 (d) During RFA3 repower activities, if active nest sites are observed per (b) or (c) of this  
11 condition, the certificate holder shall hire a qualified independent professional  
12 biologist to observe the active nest sites during the sensitive period for signs of  
13 disturbance and to notify the Department of any non-compliance with this condition. If  
14 the biologist observes nest site abandonment or other adverse impact to nesting  
15 activity, the certificate holder shall implement appropriate mitigation, in consultation  
16 with ODFW and subject to the approval of the Department, unless the adverse impact  
17 is clearly shown to have a cause other than construction activity. The certificate holder  
18 may begin or resume construction activities within a buffer area before the ending day  
19 of the sensitive period if any known nest site is not occupied by the early release date.  
20 If a nest site is occupied, then the certificate holder may begin or resume construction  
21 before the ending day of the sensitive period with the approval of ODFW, after the  
22 young are fledged. The certificate holder shall use a protocol approved by ODFW to  
23 determine when the young are fledged (the young are independent of the core nest  
24 site).

25 [Amendment 3]  
26

27 For each repowered wind turbine, permanent changes, not previously evaluated, would include  
28 a lower minimum aboveground blade tip clearance from 25 to 21.5 meters, and increasing the  
29 overall rotor diameter and rotor swept area from 100 to 127 meters. The maximum blade tip  
30 height of 150 meters, as approved by Council in the *Final Order*, would not change as a result of  
31 the proposed RFA3 facility repower. In RFA3, the certificate holder describes that potential  
32 impacts from these dimension changes could be an increase in bird and bat fatality from  
33 collision risk, however they assert that the primary impact from the repowering activities would  
34 be direct fatality from collision with, or crushing by heavy equipment. The certificate holder  
35 indicates that based on studies conducted in 2007 through 2016, the effect of turbine size on  
36 bird and bat collision risk remains unclear. Based on review of the studies referenced in RFA3,  
37 the Department agrees that a change in minimum aboveground blade tip clearance and rotor  
38 diameter does not represent a direct correlation in bird and bat fatality risk. Nonetheless, in  
39 response to ODFW recommendations that a bird and bat fatality monitoring study be

1 conducted for two years, following completion of the facility repowering activities, the  
2 Department recommends Council impose Condition 114 as follows.

3  
4 **Recommended Condition 114:** Following completion of RFA3 facility repower activities,  
5 the certificate holder shall conduct two years of avian and bat fatality monitoring, as  
6 described in the *Wildlife Monitoring and Mitigation Plan*, or based on protocol otherwise  
7 approved by the Department in consultation with ODFW, provided as Attachment E of the  
8 Final Order on Amendment 3.  
9 [Amendment #3]

### 10 11 **Conclusions of Law**

12  
13 Based on the foregoing findings of fact and conclusions, and subject to compliance with existing  
14 site certificate conditions, the Department recommends the Council find that the proposed RFA3  
15 facility repower would comply with the Council’s Fish and Wildlife Habitat standard.

#### 16 17 III.A.7 Public Services: OAR 345-022-0110

18  
19 *(1) Except for facilities described in sections (2) and (3), to issue a site certificate, the*  
20 *Council must find that the construction and operation of the facility, taking into account*  
21 *mitigation, are not likely to result in significant adverse impact to the ability of public*  
22 *and private providers within the analysis area described in the project order to provide:*  
23 *sewers and sewage treatment, water, storm water drainage, solid waste management,*  
24 *housing, traffic safety, police and fire protection, health care and schools.*

25  
26 *(2) The Council may issue a site certificate for a facility that would produce power from*  
27 *wind, solar or geothermal energy without making the findings described in section (1).*  
28 *However, the Council may apply the requirements of section (1) to impose conditions on*  
29 *a site certificate issued for such a facility.*

30 \*\*\*

### 31 32 **Finding of Fact**

33  
34 The Council’s Public Services standard requires the Council to find that the facility is not likely to  
35 result in significant adverse impacts on the ability of public and private service providers to  
36 supply sewer and sewage treatment, water, stormwater drainage, solid waste management,  
37 housing, traffic safety, police and fire protection, health care, and schools. Pursuant to OAR  
38 345-022-0110(2), the Council may issue a site certificate for a facility that would produce power  
39 from wind or solar energy without making findings regarding the Public Services standard;  
40 however, the Council may impose site certificate conditions based upon the requirements of  
41 the standard.

42  
43 The analysis area for potential impacts to public services is the area within and extending 10-  
44 miles from the site boundary. The evaluation of impacts to public services, provided below, is

1 an evaluation of only construction related impacts resulting from the proposed RFA3 facility  
2 repower. Operational impacts will be the same as the original review and are not reiterated in  
3 this order.

4  
5 As described in RFA3, the proposed facility repowering will be completed on a rolling schedule,  
6 where wind turbines will be upgraded over an approximately 11-month time frame with  
7 typically 8-12 turbines off-line being upgraded at a time. It will take approximately 2 weeks to  
8 upgrade each turbine. There will be four crane crews including crane operation and tower work  
9 crews. There will also be other upgrade support crews. It is estimated that there will be  
10 approximately 30 workers on-site at one time. The equipment used for upgrading will generally  
11 consist of cranes, semi-trucks and regular sized pick-up/operational trucks.

12  
13 *Sewer and Sewage Treatment; Stormwater Drainage*

14  
15 During construction of the proposed repowered turbines, on-site work crew will use existing  
16 sanitary facilities as well as portable toilet facilities, as needed. The disposal of these facilities  
17 will be managed similar to previously evaluated methods and addressed within existing site  
18 certificate conditions. Construction and operation of the proposed RFA3 facility repowering will  
19 not require use of public sewers or sewage treatment, nor require use of public or private  
20 stormwater drainage facilities. Therefore, construction and operation would not impact public  
21 and private providers of sewer, sewage treatment or stormwater drainage.

22  
23 *Water*

24  
25 Construction activities associated with the RFA3 repowering would require water for dust  
26 control. The certificate holder indicates in Section 6.19 of RFA3 that the repowering activities  
27 would not alter the certificate holder's ability to obtain water from the City of Arlington, nor  
28 would the repowering affect the ability to comply with existing Condition 78, limiting water use  
29 from the facility's onsite well to 5,000 gallon per day. Provided as Attachment 6 in RFA3, email  
30 correspondence between the City Recorder from the City of Arlington and the certificate  
31 holder, confirms the City of Arlington's continued ability to provide water to the facility,  
32 including the proposed repowering. Based on the minimal increase in construction-related  
33 water use, the Department recommends that Council find that construction of the proposed  
34 facility repowering of RFA3 would continue to not likely result in significant adverse impacts on  
35 the ability of public or private providers of water to deliver services.

36  
37 The proposed repowering activities of RFA3 would not result in changes to operational water  
38 use, which is limited to facility-specific wells that do not result in impacts on the ability of public  
39 or private providers of water to deliver services.

40  
41 *Solid Waste Management*

42  
43 Construction activities associated with the RFA3 facility repowering will generate solid waste,  
44 including non-hazardous packaging associated with equipment, removed wind turbine blades,

1 and erosion control materials (i.e. straw bales and silt fencing) which will be removed and  
2 recycled or taken to landfill in compliance with federal, state and local regulations. In RFA3, the  
3 Certificate Holder states that currently turbine blades and other materials used for Facility  
4 maintenance are taken to the Columbia Ridge Landfill. Additionally, the certificate holder  
5 explains that the Columbia Ridge Landfill has adequate capacity to accommodate construction-  
6 related debris and is not expected to reach full capacity for more than 100 years.

7  
8 The Council previously imposed several conditions addressing solid waste management,  
9 including conditions that require the certificate holder to develop and implement a solid waste  
10 management plan for the construction and operation of the facility (Condition 101 and 102).  
11 Existing Conditions 50, 51, and 100 provide guidance for the disposal of hazardous materials,  
12 spill response and accidental releases of hazardous materials, and the discharge of sanitary  
13 wastewater, and will continue to apply to the facility repowering activities of RFA3. In addition,  
14 as described in Section III.A.9, *Waste Minimization*, the Department recommends Council  
15 include a new site certificate condition to encourage recycling of the removed wind turbine  
16 blades and other components to the extent practicable. Based on the findings presented here,  
17 the Department recommends that the Council find that the construction and operation of the  
18 proposed RFA3 facility repowering would not be likely to result in a significant adverse impact  
19 on the ability of public and private providers of solid waste management to deliver services.  
20

### 21 *Traffic Safety*

22  
23 Construction of the proposed RFA3 facility repower would result in increased trip generation  
24 on local and state roads (I-84, OR 74 and OR 19) for approximately 11-months. In RFA3, the  
25 certificate holder estimates that proposed RFA3 facility repower activities would require  
26 approximately 30 temporary workers, 20 trucks, and 28 semi-trucks per day, which the  
27 Department estimates equates to a maximum trip rate increase of 156 trips per day on local  
28 and state roads.<sup>17</sup>

29  
30 During construction, trucks used to transport wind turbine blades and other heavy  
31 construction equipment (i.e. cranes) would likely require oversize load/overweight permits  
32 from Oregon Department of Transportation (ODOT) and Morrow and Gilliam County Road  
33 Departments. In addition to haul and heavy load permits, the certificate holder commits to  
34 consultation with Morrow and Gilliam County Road Department prior to transport of new  
35 wind turbine blades and gearboxes to establish roads to be used, traffic control measures, and  
36 roadway improvement necessary before and after completion of the proposed activity.<sup>18</sup>

1 Existing site certificate Condition 67 requires that the certificate holder coordinate with the  
2 Morrow and Gilliam County road departments in order to document and repair any damage  
3 to county roads based on facility construction. The Department recommends that Council  
4 reaffirm that Condition 67 applies to RFA3 activities, and also that Council make minor edits to  
5 the condition to account for the Department’s role in site certificate condition compliance.  
6

7 **Recommended Amended Condition 67:** The certificate holder shall cooperate with the  
8 Gilliam County Road Department and the Morrow County Public Works Department to  
9 ensure that any unusual damage or wear to county roads that is caused by construction  
10 of the facility is repaired by the certificate holder. Submittal to the Department of an  
11 executed Road Use Agreement with Gilliam County and Morrow County shall constitute  
12 evidence of compliance with this condition. Upon completion of construction, the  
13 certificate holder shall restore county roads to pre-construction condition or better, to  
14 the satisfaction of the applicable county departments. If required by Morrow County or  
15 Gilliam County, the certificate holder shall post bonds to ensure funds are available to  
16 repair and maintain roads affected by the proposed facility.

17 [Amendment #3]  
18

19 *Housing, Police, Fire, Schools, and Healthcare*  
20

21 In Section 6.13 of the RFA, the certificate holder explains that although the Shepherds Flat  
22 Central facility is already constructed and operational, the proposed repowering would result in  
23 a short-term and temporary influx of workers. The certificate holder estimates that the  
24 repowering activities would have a duration of seven months and require a maximum of 30  
25 workers on-site at one time. Additionally, the certificate holder provided a conservative  
26 estimate that 30 percent of the workers necessary for the repowering would be local. The  
27 remaining 70 percent may be temporary new residents. In any case, the workforce required for  
28 the repowering activities would be less than the 175 transient workers evaluated in the Final  
29 Order on the Site Certificate.<sup>19</sup> Council previously concluded that the impact to the ability of  
30 communities to provide housing, police and fire protection, healthcare and schools was not  
31 likely to be significant. Operation of the proposed repowered facility would not result in  
32 permanent population increases.  
33

34 **Conclusions of Law**  
35

36 Based on the foregoing analysis, and in compliance with OAR 345-022-0110(2), the Department  
37 recommends Council rely on the existing and recommended amended conditions to address  
38 the Public Services standard.  
39

1 III.A.8 Waste Minimization: OAR 345-022-0120

2  
3 *(1) Except for facilities described in sections (2) and (3), to issue a site certificate, the*  
4 *Council must find that, to the extent reasonably practicable:*

5  
6 *(a) The applicant’s solid waste and wastewater plans are likely to minimize*  
7 *generation of solid waste and wastewater in the construction and operation of the*  
8 *facility, and when solid waste or wastewater is generated, to result in recycling and*  
9 *reuse of such wastes;*

10  
11 *(b) The applicant’s plans to manage the accumulation, storage, disposal and*  
12 *transportation of waste generated by the construction and operation of the facility*  
13 *are likely to result in minimal adverse impact on surrounding and adjacent areas.*

14  
15 *(2) The Council may issue a site certificate for a facility that would produce power from*  
16 *wind, solar or geothermal energy without making the findings described in section (1).*  
17 *However, the Council may apply the requirements of section (1) to impose conditions on*  
18 *a site certificate issued for such a facility.*

19 \*\*\*

20  
21 **Finding of Fact**

22  
23 The Waste Minimization standard requires the Council to find that the certificate holder will  
24 minimize the generation of solid waste and wastewater, and that the waste generated would  
25 be managed to minimally impact surrounding and adjacent areas. Pursuant to OAR 345-022-  
26 0020(2), the Council may issue a site certificate for a wind facility without making findings  
27 regarding the Waste Minimization standard; however, the Council may impose site certificate  
28 conditions based upon the requirements of the standard.

29  
30 *Solid Waste and Wastewater*

31  
32 As mentioned above in Section III.A.8. *Public Services* of this order, construction activities  
33 associated with the proposed RFA3 facility repower would generate solid waste, including non-  
34 hazardous packaging associated with equipment, removed wind turbine blades, and erosion  
35 control materials (i.e. straw bales and silt fencing) which will be removed and recycled or taken  
36 to landfill in compliance with federal, state and local regulations. The construction activities are  
37 not expected to generate wastewater. In RFA3, the certificate holder states that currently,  
38 turbine blades and other materials used for Facility maintenance are taken to the Columbia  
39 Ridge Landfill, and that operational Conditions 50, 51, 100, 101, and 102, which address the  
40 waste minimization standard, would continue to apply to the proposed RFA3 facility repower.  
41 Existing Condition 101 requires the certificate holder to implement a waste management plan  
42 during facility construction. Furthermore, it includes measures to be followed, including but not  
43 limited to the recycling of: steel and other metal scrap, wood waste, and packaging waste such  
44 as paper and cardboard. Although the certificate holder explains that the Columbia Ridge

1 Landfill has adequate capacity to accommodate construction-related debris and is not expected  
2 to reach full capacity for more than 100 years, the Department recommends that Council  
3 impose Condition 115 to ensure the certificate holder minimizes waste generation consistent  
4 with Council’s standard.

5  
6 **Recommended Condition 115:** During Amendment #3 facility repower activities, the  
7 certificate holder shall, or ensure its third-party contractors, reuse or recycle wind turbine  
8 blades, hubs and other removed wind turbine components to the extent practicable. The  
9 certificate holder shall report in its semi-annual report to the Department the quantities of  
10 removed wind turbine components recycled, reused, sold for scrap, and disposed of in a  
11 landfill, to the extent practicable.  
12 [Amendment #3]

13  
14 Solid waste from operations of the proposed RFA3 facility repower would not exceed the  
15 existing amount of solid waste generated from the facility. Council previously imposed  
16 Condition 102, to require the certificate holder to, during operation, implement a waste  
17 management plan. The Department recommends that Council find that compliance with  
18 previously imposed conditions would minimize potential operational solid waste, and potential  
19 impacts from solid waste on surrounding lands.

### 20 21 **Conclusions of Law**

22  
23 Based on the foregoing analysis, and subject to existing and recommended conditions, the  
24 Department recommends Council find that the proposed RFA3 facility repower would continue  
25 to comply with the Council’s Waste Minimization standard.

### 26 27 **III.A.9 Division 24 Standards**

28  
29 The Council’s Division 24 standards include specific standards for the siting of wind project,  
30 which is further evaluated below.

### 31 32 **III.A.9.1 Public Health and Safety Standards for Wind Energy Facilities: OAR 345-024-0010**

33  
34 *To issue a site certificate for a proposed wind energy facility, the Council must find that the*  
35 *applicant:*

36  
37 *(1) Can design, construct and operate the facility to exclude members of the public from*  
38 *close proximity to the turbine blades and electrical equipment.*

39  
40 *(2) Can design, construct and operate the facility to preclude structural failure of the tower*  
41 *or blades that could endanger the public safety and to have adequate safety devices and*  
42 *testing procedures designed to warn of impending failure and to minimize the consequences*  
43 *of such failure.*  
44

1 **Findings of Fact**

2  
3 OAR 345-024-0010 requires the Council to consider specific public health and safety standards  
4 related to wind energy facilities. Under this standard, the Council must evaluate a certificate  
5 holder’s proposed measures to exclude members of the public from proximity to the turbine  
6 blades and electrical equipment, and the certificate holder’s ability to design, construct and  
7 operate the facility, with proposed changes, to prevent structural failure of the tower or blades  
8 and to provide sufficient safety devices to warn of failure.  
9

10 *Potential Impacts from Structural Failure of the Tower or Blades and Safety Devices and Testing*  
11 *Procedures to Warn of Impending Failure*

12  
13 The Council must evaluate if the certificate holder has demonstrated that it has the ability to  
14 preclude a structural failure in the first place through design, construction and operation of the  
15 turbines. OAR 345-024-0010(2) does not require that a certificate holder demonstrate an  
16 *elimination* of all public health and safety risk [*Emphasis added*]. Instead, it requires that the  
17 certificate holder design, construct and operate the facility to avoid structural failure, to have  
18 adequate mechanisms in place to warn of an impending failure, and to minimize the  
19 consequences of such failure.  
20

21 The proposed repowering activity, resulting in a lower minimum aboveground blade tip  
22 clearance (25 to 21.5 meters) compared to the Council’s previous evaluation could potentially  
23 result in increased public health and safety risks. The Department evaluates the sufficiency of  
24 previously imposed conditions related to safety devices and testing procedures to warn of  
25 impending failure and minimize potential increases in risk.  
26

27 The site certificate includes a number of existing conditions that were imposed to address  
28 sub(2) of the standard and which would continue to ensure that the certificate holder reduces  
29 the risk of potential impacts from structural failure of the wind turbine tower or blades.  
30

- 31 • Condition 71 requires that the certificate holder notify the Department and the Gilliam  
32 County Planning Director within 72 hours of any accidents or mechanical failures  
33 associated with operation of the facility that may result in public health and safety  
34 concerns.
- 35 • Condition 40 establishes required setback distances of facility components to residential  
36 properties, public roads, and lease areas.

37  
38 As mentioned above in Section III.A.1 *General Standard of Review*, Council imposed Condition  
39 26 in The *Final Order on the ASC* to establish limits on the turbines selected, depending on the  
40 turbine type selected. Condition 26(d) established a the minimum blade tip clearance of 25  
41 meters above the ground at the closest point of rotation. In the *Final Order on Request for*  
42 *Amendment 1*, Council amended Condition 26 to specify the minimum blade tip clearance from  
43 25 meters to 21.5 meters based upon the proposed RFA2 O&M demonstration activities, for  
44 wind turbines 368 and 370. The proposed lowering of the minimum aboveground blade tip

1 clearance could result in potential public health and safety impacts from increased proximity to  
2 turbine blades. However, the certificate holder describes that the turbines would remain  
3 located entirely on private property, in a rural area, and that public access is limited. The  
4 Department recommends that the Council consider that the facility design, including restricted  
5 public access, and compliance to the setback requirements of Condition 40, to be sufficient to  
6 minimize potential increases in public health and safety risks from proximity to the proposed  
7 RFA3 repowered turbines, with lower minimum aboveground blade tip clearance.

8  
9 Based upon the proposed RFA3 repowering activities for Shepherds Flat Central, the  
10 Department recommends that Council amend Condition 26(d) to eliminate the reference to  
11 Turbines 368 and 370, and specify the a new minimum blade tip clearance from 25 meters to  
12 21.5 meters, applicable to all repowered turbines within the facility. Additionally, the  
13 Department recommends Council remove from the condition a limitation on the megawatt  
14 output of the facility. The Council's standards are not concerned with the electrical power  
15 output of the facility. The amended condition would read as follows:

16 **Recommended Amended Condition 26:** The certificate holder shall construct a facility  
17 substantially as described in the site certificate and may select turbines of any type,  
18 subject to the following restrictions and compliance with all other site certificate  
19 conditions. Before beginning construction, the certificate holder shall provide to the  
20 Department a description of the turbine types selected for the facility demonstrating  
21 compliance with this condition.

22 (a) The total number of turbines at the facility must not exceed 116 turbines.

23 ~~(b) The combined peak generating capacity of the facility must not exceed 290~~  
24 ~~megawatts.~~

25 (c) The turbine hub height must not exceed 105 meters and the maximum blade tip  
26 height must not exceed 150 meters.

27 (d) The minimum blade tip clearance must be 25 meters above ground, ~~with the~~  
28 ~~exception of turbine number 368 and 370 for which the minimum blade tip clearance~~  
29 ~~must be 21.5 meters above the ground.~~ Repowered turbines that comply with the setback  
30 requirements of Condition 40 must have a minimum blade tip clearance of 21.5 meters  
31 above ground.

32 (e) The maximum volume of concrete above three feet below grade in the turbine  
33 foundations must not exceed 66 cubic yards.

34 (f) The maximum combined weight of metals in the tower (including ladders and  
35 platforms) and nacelle must not exceed 393 U.S. tons per turbine.

36 (g) The certificate holder shall request an amendment of the site certificate ~~to increase~~  
37 ~~the combined peak generating capacity of the facility beyond 290 megawatts, to increase~~  
38 the number of wind turbines to more than 116 wind turbines or to install wind turbines  
39 with a hub height greater than 105 meters, a blade tip height greater than 150 meters or a  
40 blade tip clearance less than ~~25~~21.5 meters above ground.

41 [Amendment #1 (SFWF); Amendment #1, Amendment #2, Amendment #3]

1 As mentioned above, the proposed RFA3 facility repowering would not only lower the minimum  
2 blade tip clearance, but would also increase maximum height and the rotor diameter of the two  
3 specified turbines. The new maximum height of the repowered turbines would be 150 meters,  
4 consistent with the maximum blade tip height limited in Condition 26. Council previously  
5 evaluated and approved turbines with a maximum blade tip height of 150 meters in the Final  
6 Order on the ASC, and found that the certificate holder could design, construct, and operate the  
7 facility in compliance with the Public Health and Safety Standard for Wind Energy Facilities.

8  
9 Existing Condition 57 requires the certificate holder to submit a Notice of Proposed Construction  
10 or Alteration (Form 7460) to the Federal Aviation Administration (FAA) and the Oregon  
11 Department of Aviation (ODA). Existing Condition 106 requires the certificate holder to submit a  
12 Notice of Proposed Construction and Alteration to the FAA and ODA for wind turbines 368 and  
13 370. Because the existing turbine specifications feature a maximum blade tip height of 135  
14 meters, and the proposed demonstration activities would increase the maximum height to 150  
15 meters, the Department recommends Council impose Condition 116 to require the certificate  
16 holder to submit a Notice of Proposed Construction and Alteration to the FAA and ODA for the  
17 RFA3 facility repower. Recommended Condition 116 would read as follows:

18  
19 **Recommended Condition 116:** Prior to Amendment #3 facility repower activities, the  
20 certificate holder shall submit a Notice of Proposed Construction or Alteration to the  
21 Federal Aviation Administration (FAA) and the Oregon Department of Aviation identifying  
22 the new maximum blade tip height of 150 meters. The certificate holder shall promptly  
23 notify the Department of the responses from the FAA and the Oregon Department of  
24 Aviation.  
25 [Amendment #3]

26  
27 The Department recommends that Council find that compliance with the existing and  
28 recommended new and amended conditions would continue to satisfy the requirements of the  
29 standard and ensure that the proposed RFA3 facility repowering are designed, constructed, and  
30 operated to preclude structural failure of the tower or blades that could endanger public safety,  
31 and that the proposed RFA3 facility repowering would have adequate safety devices and testing  
32 procedures to warn of impending failure and minimize consequences of such failure, should it  
33 occur.

### 34 **Conclusions of Law**

35  
36  
37 Based on the foregoing analysis, and subject to compliance with existing and recommended  
38 conditions, the Department recommends the Council find that the proposed RFA3 facility  
39 repower activity would comply with the Council's Public Health and Safety Standards for Wind  
40 Energy Facilities.

1 **III.A.9.2 Cumulative Effects Standard for Wind Energy Facilities OAR 345-024-0015**  
2

3 *To issue a site certificate for a proposed wind energy facility, the Council must find that the*  
4 *applicant can design and construct the facility to reduce cumulative adverse environmental*  
5 *effects in the vicinity by practicable measures including, but not limited to, the following:*  
6

- 7 (1) *Using existing roads to provide access to the facility site, or if new roads are needed,*  
8 *minimizing the amount of land used for new roads and locating them to reduce adverse*  
9 *environmental impacts.*  
10 (2) *Using underground transmission lines and combining transmission routes.*  
11 (3) *Connecting the facility to existing substations, or if new substations are needed,*  
12 *minimizing the number of new substations.*  
13 (4) *Designing the facility to reduce the risk of injury to raptors or other vulnerable wildlife in*  
14 *areas near turbines or electrical equipment.*  
15 (5) *Designing the components of the facility to minimize adverse visual features.*  
16 (6) *Using the minimum lighting necessary for safety and security purposes and using*  
17 *techniques to prevent casting glare from the site, except as otherwise required by the*  
18 *Federal Aviation Administration or the Oregon Department of Aviation.*  
19

20 **Findings of Fact**  
21

22 This standard requires the use of practicable measures to reduce the cumulative adverse  
23 environmental effects by practicable measures.  
24

25 *Access Roads*  
26

27 OAR 345-024-0015(1) is related to the use of existing roads for facility site access, minimizing  
28 the amount of land used for new roads, and locating new roads in such a manner that reduces  
29 adverse environmental impacts. The certificate holder proposes to utilize existing access roads,  
30 to be temporarily widened to support the proposed RFA3 facility repowering. No new  
31 permanent roads would be constructed as part of RFA3.  
32

33 Because the proposed RFA3 facility repowering would not result in new permanent access  
34 roads, the Department recommends the Council continue to find that the certificate holder  
35 demonstrates that it would use existing roads where practicable to provide access to the site  
36 and through the temporary expansion of existing roads, would reduce adverse environmental  
37 impacts and constructed in a manner that minimizes the amount of land used.  
38

39 *Transmission Lines and Substations*  
40

41 RFA3 does not propose new transmission lines or substations, or changes to the previously  
42 approved site boundary. Therefore, the Department recommends Council find that RFA3 would

1 not result in a significant adverse impact under OAR 345-024-0015(2) and (3) that was not  
2 addressed in a previous Council orders.

3

#### 4 *Wildlife Protection*

5

6 OAR 345-024-0015(4) is related to facility design that reduces the risk of injury to raptors or  
7 other vulnerable wildlife in areas near wind turbines or electrical equipment.

8

9 The proposed RFA3 facility repowering would increase the rotor-swept diameter from 100  
10 meters to 127 meters, and decrease the aboveground blade tip clearance by 3.5 meters. The  
11 proposed changes in wind turbine dimension could result in increased bird and bat fatality risk  
12 from wind turbine collision. However, the certificate holder explains that the effect of turbine  
13 size on bird and bat collision rates remains unclear, particularly with respect to blade length.  
14 However, in response to ODFW recommendations, the certificate holder agrees that two years  
15 of fatality monitoring, to look at mortality effects from turbine repowering, following  
16 construction completion of the proposed RFA3 facility repower.

17

18 As discussed in Section III.A.6, *Fish and Wildlife Habitat*, the certificate holder proposes to  
19 conduct 2-years of post-construction fatality monitoring to determine whether the changes in  
20 wind turbine dimensions result in increased fatality risk and then whether additional mitigation  
21 is necessary. The post construction fatality monitoring would be implemented in accordance  
22 with the Wildlife Monitoring and Mitigation Plan (WMMP), provided as Attachment E to this  
23 order.

24

25 Based on compliance with other existing and recommended new site certificate conditions, the  
26 certificate holder would implement the following measures to further reduce and avoid wildlife  
27 impacts:

28

- 29 • Pre- and post-construction raptor nest monitoring, seasonal timing restrictions and  
30 avoidance requirements
- 31 • Habitat mitigation, revegetation and monitoring
- 32 • Weed control and monitoring

33

34 Subject to compliance with existing and recommended new site certificate conditions, the  
35 Department recommends the Council find the certificate holder continues to demonstrate that  
36 it can reduce cumulative adverse environmental effects in the vicinity by designing the  
37 proposed RFA3 facility repower to reduce the risk of injury to raptors or other vulnerable  
38 wildlife in areas near wind turbines or electrical equipment.

39

#### 40 *Visual Features*

41 The visual features of the proposed demonstration wind turbines would be similar to those  
42 previously evaluated by Council. Additionally, based on compliance with existing site certificate

1 conditions, the certificate holder would implement the following measures to reduce potential  
2 visual impacts from the proposed repowered wind turbines:

- 3
- 4 • Uniformly paint turbine towers, nacelles, and rotors in a neutral color to blend with the
- 5 surrounding landscape
- 6 • Exterior nighttime lighting would be kept to a minimum
- 7

8 Based on the evidence in the record and subject to compliance with existing site certificate  
9 conditions, the Department recommends the Council find the certificate holder continues to  
10 demonstrate that it can reduce cumulative adverse environmental effects in the vicinity by  
11 designing the components of the facility, with proposed changes, to minimize the adverse  
12 impacts of lighting.

### 13 14 *Lighting*

15  
16 Existing Condition 95 requires wind turbines to be equipped with the minimum turbine tower  
17 lighting required by FAA. Based on compliance with this condition, the Department  
18 recommends the Council find the certificate holder continues to demonstrate that it can reduce  
19 cumulative adverse environmental effects in the vicinity by designing the components of the  
20 facility, with proposed changes, to minimize the adverse impacts of lighting.

### 21 22 **Conclusions of Law**

23  
24 Based on the foregoing findings of fact and conclusions, and subject to compliance with existing  
25 conditions, the Department recommends Council finds that the proposed RFA3 facility repower  
26 would comply with the Council’s Cumulative Effects Standards for Wind Energy Facilities.

### 27 28 **III.A.10 Other Applicable Regulatory Requirements Under Council Jurisdiction**

29  
30 Under ORS 469.503(3) and under the Council’s General Standard of Review (OAR 345-022-  
31 0000), the Council must determine whether the proposed facility complies with “all other  
32 Oregon statutes and administrative rules...as applicable to the issuance of a site certificate for  
33 the proposed facility.” This section addresses the applicable Oregon statutes and administrative  
34 rules that are not otherwise addressed in Council standards, including the Oregon Department  
35 of Environmental Quality’s noise control regulations.

### 36 37 **III.A.10.1 Noise Control Regulations: OAR 340-035-0035**

38  
39 *(1) Standards and Regulations:*

40 \*\*\*

41 *(b) New Noise Sources:*

42  
43 *(B) New Sources Located on Previously Unused Site:*

- 1           (i) *No person owning or controlling a new industrial or commercial noise source*  
2           *located on a previously unused industrial or commercial site shall cause or*  
3           *permit the operation of that noise source if the noise levels generated or*  
4           *indirectly caused by that noise source increase the ambient statistical noise*  
5           *levels, L10 or L50, by more than 10 dBA in any one hour, or exceed the levels*  
6           *specified in Table 8, as measured at an appropriate measurement point, as*  
7           *specified in subsection (3)(b) of this rule, except as specified in subparagraph*  
8           *(1)(b)(B)(iii).*
- 9           (ii) *The ambient statistical noise level of a new industrial or commercial noise*  
10           *source on a previously unused industrial or commercial site shall include all*  
11           *noises generated or indirectly caused by or attributable to that source*  
12           *including all of its related activities. Sources exempted from the requirements*  
13           *of section (1) of this rule, which are identified in subsections (5)(b) - (f), (j),*  
14           *and (k) of this rule, shall not be excluded from this ambient measurement.*
- 15           (iii) *For noise levels generated or caused by a wind energy facility:*
- 16                   (i) *The increase in ambient statistical noise levels is based on an assumed*  
17                   *background L50 ambient noise level of 26 dBA or the actual ambient*  
18                   *background level. The person owning the wind energy facility may*  
19                   *conduct measurements to determine the actual ambient L10 and L50*  
20                   *background level.*
- 21                   (ii) *The "actual ambient background level" is the measured noise level at*  
22                   *the appropriate measurement point as specified in subsection (3)(b) of*  
23                   *this rule using generally accepted noise engineering measurement*  
24                   *practices. Background noise measurements shall be obtained at the*  
25                   *appropriate measurement point, synchronized with windspeed*  
26                   *measurements of hub height conditions at the nearest wind turbine*  
27                   *location. "Actual ambient background level" does not include noise*  
28                   *generated or caused by the wind energy facility.*
- 29                   (iii) *The noise levels from a wind energy facility may increase the ambient*  
30                   *statistical noise levels L10 and L50 by more than 10 dBA (but not*  
31                   *above the limits specified in Table 8), if the person who owns the noise*  
32                   *sensitive property executes a legally effective easement or real*  
33                   *covenant that benefits the property on which the wind energy facility*  
34                   *is located. The easement or covenant must authorize the wind energy*  
35                   *facility to increase the ambient statistical noise levels, L10 or L50 on*  
36                   *the sensitive property by more than 10 dBA at the appropriate*  
37                   *measurement point.*
- 38                   (iv) *For purposes of determining whether a proposed wind energy facility*  
39                   *would satisfy the ambient noise standard where a landowner has not*  
40                   *waived the standard, noise levels at the appropriate measurement*  
41                   *point are predicted assuming that all of the proposed wind facility's*  
42                   *turbines are operating between cut-in speed and the wind speed*  
43                   *corresponding to the maximum sound power level established by IEC*  
44                   *61400-11 (version 2002-12). These predictions must be compared to*

1                    *the highest of either the assumed ambient noise level of 26 dBA or to*  
2                    *the actual ambient background L10 and L50 noise level, if measured.*  
3                    *The facility complies with the noise ambient background standard if*  
4                    *this comparison shows that the increase in noise is not more than 10*  
5                    *dBa over this entire range of wind speeds.*

6                    (v) *For purposes of determining whether an operating wind energy*  
7                    *facility complies with the ambient noise standard where a landowner*  
8                    *has not waived the standard, noise levels at the appropriate*  
9                    *measurement point are measured when the facility's nearest wind*  
10                    *turbine is operating over the entire range of wind speeds between cut-*  
11                    *in speed and the windspeed corresponding to the maximum sound*  
12                    *power level and no turbine that could contribute to the noise level is*  
13                    *disabled. The facility complies with the noise ambient background*  
14                    *standard if the increase in noise over either the assumed ambient*  
15                    *noise level of 26 dBA or to the actual ambient background L10 and*  
16                    *L50 noise level, if measured, is not more than 10 dBA over this entire*  
17                    *range of wind speeds.*

18                    (vi) *For purposes of determining whether a proposed wind energy facility*  
19                    *would satisfy the Table 8 standards, noise levels at the appropriate*  
20                    *measurement point are predicted by using the turbine's maximum*  
21                    *sound power level following procedures established by IEC 61400-11*  
22                    *(version 2002-12), and assuming that all of the proposed wind*  
23                    *facility's turbines are operating at the maximum sound power level.*

24                    (vii) *For purposes of determining whether an operating wind energy*  
25                    *facility satisfies the Table 8 standards, noise generated by the energy*  
26                    *facility is measured at the appropriate measurement point when the*  
27                    *facility's nearest wind turbine is operating at the windspeed*  
28                    *corresponding to the maximum sound power level and no turbine that*  
29                    *could contribute to the noise level is disabled.*

30                    \*\*\*

31  
32                    **Findings of Fact**

33  
34                    The Department of Environmental Quality (DEQ) noise control regulations at OAR 340-035-0035  
35                    have been adopted by Council as the compliance requirements for EFSC-jurisdiction energy  
36                    facilities. The analysis area for the Noise Control Regulation is the area within and extending 1-  
37                    mile from the site boundary.

38  
39                    OAR 340-035-0035(5) outlines sources of noise that are exempt from the DEQ noise rules,  
40                    including sounds that originate from construction sites as well as maintenance of capital  
41                    equipment.

42  
43                    Noise generated by a wind energy facility located on a previously unused site must comply with  
44                    two tests: the “ambient noise degradation test” and the “maximum allowable noise test.”

1 Under the ambient noise degradation test, facility-generated noise must not increase the  
 2 ambient hourly L10 or L50 noise levels at any noise sensitive property (NSP) by more than 10  
 3 dBA when turbines are operating “between cut-in speed and the wind speed corresponding to  
 4 the maximum sound power level.” To show that a facility complies with this test, the certificate  
 5 holder may use an assumed ambient hourly L50 noise level of 26 dBA or measure the actual  
 6 ambient hourly noise levels at the receiver in accordance with the procedures specified in the  
 7 regulation. In this case, the certificate holder elected to use an assumed ambient hourly L50  
 8 noise level of 26 dBA.

9  
 10 To demonstrate compliance with the ambient noise degradation test, the noise generated  
 11 during facility operation must not cause the hourly L<sub>50</sub> noise level at any noise-sensitive  
 12 property to exceed 36 dBA. However, OAR 340-035-0035(1)(b)(B)(iii)(III) relieves the certificate  
 13 holder from having to show compliance with the ambient noise degradation test “if the person  
 14 who owns the noise sensitive property executes a legally effective easement or real covenant  
 15 that benefits the property on which the wind energy facility is located” (a “noise waiver”).

16  
 17 Under the maximum allowable noise test at OAR 340-035-0035(1)(b)(B)(i) a wind energy facility  
 18 may not exceed the noise levels specified in Table 8 of the noise rules, as represented in Table  
 19 4, *Statistical Noise Limits for Industrial and Commercial Noise Sources* below. Pursuant to OAR  
 20 340-035-0035(1)(b)(B)(iii)(III), it is not possible for a property owner to waive an exceedance  
 21 under the maximum allowable noise test.

22

24 *Potential Noise Impacts*

25

26 *Construction*

27

28 As discussed in RFA3 and in Section III.A.8, *Public Services*, of this order, proposed RFA3 facility  
 29 repower would result in worker and haul truck trips, and construction equipment operation,  
 30 which would generate temporary, short-term construction noise. In RFA3, the certificate holder  
 31 estimates that proposed RFA3 facility repowering activities would take approximately 11  
 32 months and would require approximately 30 temporary workers, 20 trucks, and 28 semi-trucks

1 per day, which the Department estimates equates to a maximum trip rate increase of 156 trips  
2 per day on local and state roads. Noise related to the construction of the turbine repowering,  
3 however, exempt from the noise standards pursuant to OAR 340-035-0035(5)(g) and (h). The  
4 evaluation of construction-related noise, including methodology and assumptions, is an  
5 informational requirement per OAR Chapter 345 Division 21 and can be utilized to inform the  
6 evaluation of construction-related noise impacts under the Council’s Recreation standard of  
7 this order.

8  
9 *Operation*

10  
11 In RFA3, the certificate holder states that the sound power properties of the repowered  
12 turbines is expected to be similar to the existing wind turbines, with a sound power level of 105  
13 dBA per turbine. The certificate holder indicates that the original noise study<sup>20</sup> demonstrated  
14 compliance with the DEQ noise requirements. Due to advances in blade airfoil shape and  
15 manufacturing, significantly reducing noise from wind turbine blades, in all likelihood, the  
16 repowered turbines of the proposed RFA3 facility repower will produce lower sound levels than  
17 the existing turbines. Council previously imposed Condition 97, which requires the certificate  
18 holder to provide sound power level and octave band data, based on manufacturer warranties  
19 or as otherwise confirmed acceptable by the Department, and demonstrate through a final  
20 noise modeling assessment compliance with the DEQ noise requirements.

21  
22 In RFA3, the certificate holder explains that Council concluded in both the *Final Order* and  
23 *Amendment 1*, that the facility, subject to site certificate conditions, would comply with the  
24 applicable Council noise regulations. A noise survey conducted in support of RFA1, indicated  
25 the facility’s compliance with the maximum noise level limits at all NSPs. However, the noise  
26 survey results of that study also indicated that a number of NSPs (approximately five) would  
27 potentially exceed the anti-ambient degradation noise level limits of 10 dBA above the assumed  
28 ambient of 26 dBA. To comply with the Council’s noise regulations, the certificate holder either  
29 had to modify the facility design to reduce the sound levels at the NSPs to below 36 dBA, or  
30 obtain noise waivers from the owners of the NSPs. In the RFA3, the certificate holder indicates  
31 that because of the similar sound power levels when compared to the existing wind turbines,  
32 the noise impacts of the repowered turbines at the NSPs are expected to be the same or less  
33 than those reported in the RFA1 noise survey. To verify ongoing compliance with the applicable  
34 requirements, the Department recommends Council impose Condition 117 which would  
35 require the certificate holder to provide to the Department the manufacturer’s warranties or  
36 specifications for the repowered wind turbines, to verify that the repowered turbines would  
37 produce no more sound than the currently installed turbines. If the manufacturer’s  
38 specifications demonstrate that the repowered turbines would produce a greater maximum  
39 sound power level than the currently installed turbines, additional noise modeling would be  
40 required to demonstrate compliance with the standard. Additionally, resubmittal of noise-  
41 easements would be required if the repowered turbines are demonstrated to produce a greater

1 maximum sound power level than the currently installed turbines and also if the current noise-  
2 easements do not already authorize anticipated statistical noise levels at or above the level  
3 expected to occur from the repowered facility at the appropriate measurement point:  
4

5 **Recommended Condition 117: Prior to Amendment #3 facility repower activities, the**  
6 **certificate holder shall provide to the Department:**

- 7 (a) The maximum sound power level and octave band for the modified wind  
8 turbines based on manufacturer’s warranties or confirmed by other means  
9 acceptable to the Department.
- 10 (b) If the information provided to the Department in (a) shows that the modified  
11 (repowered) wind turbines would produce a higher maximum sound power level  
12 and octave band than the currently installed wind turbines, the certificate holder  
13 must conduct a noise analysis of the modified (repowered) turbines. If required,  
14 the certificate holder must provide to the Department results of the noise  
15 analysis for the Amendment #3 facility repower, performed in a manner  
16 consistent with the requirements of OAR 340-035-0035(1)(b)(B)(iii)(IV) and (VI)  
17 demonstrating to the satisfaction of the Department that the total noise  
18 generated (including the noise from repowered wind turbines and existing  
19 substation transformers) would meet the ambient degradation test and  
20 maximum allowable test at the appropriate measurement point for all  
21 potentially-affected noise sensitive properties.
- 22 (c) If the information provided to the Department in (a) shows that the modified  
23 (repowered) wind turbines would produce a higher maximum sound power level  
24 and octave band than the currently installed wind turbines, the certificate holder  
25 must provide to the Department, for each noise-sensitive property where the  
26 certificate holder relies on a noise waiver to demonstrate compliance in  
27 accordance with OAR 340-035-0035 (1)(b)(B)(iii)(III) related to site certificate  
28 Amendment #3 activities, a copy of the a legally effective easement or real  
29 covenant pursuant to which the owner of the property authorizes the certificate  
30 holder’s operation of the facility to increase ambient statistical noise levels L10  
31 and L50 by more than 10 dBA at the appropriate measurement point. The  
32 easement must only be provided to the Department if the modified wind  
33 turbines would produce a higher maximum sound power level and octave band  
34 than the currently installed wind turbines and the current noise-easements do  
35 not allow ambient statistical noise levels L10 and L50 by more than the statistical  
36 noise levels anticipated to occur from the repowered turbines at the appropriate  
37 measurement point. The legally-effective easement or real covenant must:  
38 include a legal description of the burdened property (the noise sensitive  
39 property); be recorded in the real property records of the county; expressly  
40 benefit the certificate holder; expressly run with the land and bind all future  
41 owners, lessees or holders of any interest in the burdened property; and not be  
42 subject to revocation without the certificate holder’s written approval.

43 [Amendment #3]  
44

1 In addition, Council previously imposed Condition 98, which requires the certificate holder to  
 2 maintain a complaint response system to address noise complaints during operation. Condition  
 3 98 also allows Council to require the certificate holder to monitor and record the statistical  
 4 noise levels to verify compliance with the noise control regulations. This condition would  
 5 continue to apply to the proposed RFA3 facility repower.

6  
 7 **Conclusions of Law**

8  
 9 Based on the foregoing findings, the Department recommends that the Council find that the  
 10 proposed RFA3 facility repower would comply with the Noise Control Regulations in OAR 340-  
 11 035-0035(1)(b)(B).

12  
 13 **III.B. Standards Not Likely to Be Impacted by Request for Amendment 3**

14  
 15 RFA3, as described throughout this order, solely requests authorization for a proposed upgrade  
 16 (or repower) to the facility’s wind turbines, where blade replacement and nacelle modification  
 17 would occur. Amendment 2 authorized changes in the wind turbine dimensions for two specific  
 18 wind turbines, Turbine 368 and 370. the authorized dimensional changes to Turbines 368 and  
 19 370 are identical to what the certificate holder is requesting in RFA3. The changes in wind  
 20 turbine dimensions would lower wind turbine minimum aboveground blade tip clearance from  
 21 25 to 21.5 meters, increase blade tip height from 135 to 150 meters, and increase rotor  
 22 diameter from 100 to 127 meters, with the change in minimum aboveground blade tip  
 23 clearance representing the only change necessitating a site certificate condition amendment as  
 24 maximum blade tip height of 150 meters was previously evaluated and approved (Condition 26)  
 25 and rotor diameter was not previously correlated with an impact protected by a Council  
 26 standard nor limited by the site certificate.

27  
 28 In RFA3, the certificate holder describes the number of equipment and personnel that would be  
 29 required for the proposed RFA3 facility repower, and potential impacts associated with the  
 30 repowering activities. Based on the Department’s review of the RFA and of the previously  
 31 evaluated impacts and imposed conditions, the following standards would not be impacted by  
 32 RFA3 and do not require re-evaluation in this order.

III.B.9 Removal-Fill

The Oregon Removal-Fill Law (ORS 196.795 through 196.990) and Department of State Lands (DSL) regulations (OAR 141-085-0500 through 141-085-0785) require a removal-fill permit if 50 cubic yards or more of material is removed, filled, or altered within any “waters of the state.”<sup>21</sup> The Council, in consultation with DSL, must determine whether a removal-fill permit is needed and if so, whether a removal-fill permit should be issued. A removal-fill permit is not required for RFA3 activities.

III.B.10 Water Rights

Under ORS Chapters 537 and 540 and OAR Chapter 690, the Oregon Water Resources Department (OWRD) administers water rights for appropriation and use of the water resources of the state. Under OAR 345-022-0000(1)(b), the Council must determine whether the facility would comply with these statutes and administrative rules. OAR 345-021-0010(1)(o)(F) requires that if a facility needs a groundwater permit, surface water permit, or water right transfer, that a decision on authorizing such a permit rests with the Council. No such water permit is required for RFA3 activities.

1 **IV. DRAFT PROPOSED CONCLUSIONS AND ORDER**

2  
3 Based on the recommended findings and conclusions included in this order, the Department  
4 recommends that Council make the following findings:

6 1. The facility, with proposed changes included in Request for Amendment 3 of the  
7 Shepherds Flat Central site certificate complies with the requirements of the Oregon  
8 Energy Facility Siting Statutes, ORS 469.300 to 469.520.  
9  
10 2. The facility, with proposed changes included in Request for Amendment 3 of the  
11 Shepherds Flat Central site certificate complies with the standards adopted by the  
12 Council pursuant to ORS 469.501.  
13  
14 3. The facility, with proposed changes included in Request for Amendment 3 of the  
15 Shepherds Flat Central site certificate complies with all other Oregon statutes and  
16 administrative rules identified in the project order as applicable to the issuance of a  
17 site certificate for the facility.  
18

19 Accordingly, the Department recommends that the Council find that the Request for  
20 Amendment 3 of the Shepherds Flat Central site certificate complies with the General Standard  
21 of Review (OAR 345-022-0000). The Department recommends that the Council find, based on a  
22 preponderance of the evidence on the record, that the site certificate may be amended as  
23 requested.

#### II. SITE CERTIFICATION

33 Morrow County, Oregon, as described in Section III of this site certificate. ORS 469.401(1).
- 34 2. This site certificate is effective until it is terminated under OAR 345-027-0110 or the rules in  
35 effect on the date that termination is sought or until the site certificate is revoked under ORS  
36 469.440 and OAR 345-029-0100 or the statutes and rules in effect on the date that revocation

10 (SFWF); Amendment #1, Amendment #3]
- 11 4. Both the State and the certificate holder shall abide by local ordinances, state law and the  
12 rules of the Council in effect on the date this site certificate is executed. ORS 469.401(2). In  
13 addition, upon a clear showing of a significant threat to public health, safety or the  
14 environment that requires application of later-adopted laws or rules, the Council may require  
15 compliance with such later-adopted laws or rules. ORS 469.401(2).
- 16 5. For a permit, license or other approval addressed in and governed by this site certificate, the  
17 certificate holder shall comply with applicable state and federal laws adopted in the future to  
18 the extent that such compliance is required under the respective state agency statutes and  
19 rules. ORS 469.401(2).
- 20 6. Subject to the conditions herein, this site certificate binds the State and all counties, cities and  
21 political subdivisions in Oregon as to the approval of the site and the construction, operation  
22 and retirement of the facility as to matters that are addressed in and governed by this site  
23 certificate. ORS 469.401(3).
- 24 7. Each affected state agency, county, city and political subdivision in Oregon with authority to  
25 issue a permit, license or other approval addressed in or governed by this site certificate shall,  
26 upon submission of the proper application and payment of the proper fees, but without  
27 hearings or other proceedings, issue such permit, license or other approval subject only to  
28 conditions set forth in this site certificate. ORS 469.401(3).
- 29 8. After issuance of this site certificate, each state agency or local government agency that  
30 issues a permit, license or other approval for the facility shall continue to exercise  
31 enforcement authority over such permit, license or other approval. ORS 469.401(3).
- 32 9. After issuance of this site certificate, the Council shall have continuing authority over the site  
33 and may inspect, or direct the Oregon Department of Energy (Department) to inspect, or  
34 request another state agency or local government to inspect, the site at any time in order to  
35 ensure that the facility is being operated consistently with the terms and conditions of this  
36 site certificate. ORS 469.430.

### III. DESCRIPTION

#### 1. The Facility

##### (a) The Energy Facility

37 The energy facility is an electric power generating facility ~~with an average electric~~  
38 ~~generating capacity of up to 97 megawatts and a peak generating capacity of not more than 290~~  
39 ~~megawatts~~ that produces power from wind energy. The facility consists of not more than 116

1 wind turbines. The energy facility is described further in the *Final Order on Amendment #1 for*  
2 *the Shepherds Flat Wind Farm*, ~~and~~ in the *Final Order on Amendment #1 for the Shepherds Flat*  
3 *Central*, in the *Final Order on Amendment #2*, and in the *Final Order on Amendment #3 for*  
4 *Shepherds Flat Central*. [Amendment #1 (SFWF); Amendment #1] Request for Amendment #2  
5 approves O&M demonstration activities for two specific wind turbines (T368 and T370). The  
6 demonstration activities include replacing the wind turbine blades and modifying the nacelles.  
7 [Amendment #2]

### 8 **Wind Turbine Repower**

9 Wind turbine repowering includes removal and replacement of wind turbine blades and  
10 associated wind turbine components on existing turbine towers. Wind turbine repowering  
11 requires trucks, small cranes or telehandlers, and a track mounted crane. Trucks deliver new  
12 wind turbine components to wind turbine pad sites, and transport the old components offsite for  
13 proper disposal or recycling at a licensed facility. Once the new wind turbines components are  
14 delivered via truck to each pad site, smaller cranes or telehandlers unload and stage the  
15 components. A track mounted crane then mobilizes to the turbine pad area, setting up on the  
16 access road adjacent the turbine, and lowers the old rotor down to the pad site for disassembly,  
17 followed by the old gearbox. Once disassembled, the old components are staged for truck  
18 removal. The track mounted crane then lifts the new gearbox and rotor into place. Once,  
19 complete, the track mounted crane advances to the next wind turbine, and the process is repeated.  
20 [Amendment #3]

### (b) Related or Supporting Facilities

21 The facility includes the following related or supporting facilities described below and in  
22 greater detail in the *Final Order on Amendment #1 for the Shepherds Flat Wind Farm* and in the  
23 *Final Order on Amendment #1*:

- 24 • Power Collection System
- 25 • Collector Substation
- 26 • Meteorological towers
- 27 • Field workshop
- 28 • Control system
- 29 • Access roads
- 30 • Additional construction areas

31 [Amendment #1 (SFWF); Amendment #1]

#### 32 **Power Collection System**

33 A power collection system operating at 34.5 kilovolts (kV) transports power from each  
34 turbine to a collector substation. To the extent practicable, the collection system is installed  
35 underground at a depth of at least three feet. Segments of the collector system are aboveground.  
36 Aboveground segments are installed on single-pole, cross-arm structures. [Amendment #1]

#### 37 **Collector Substations and Interconnection**

38 The facility includes a collector substation. The facility includes a 230-kV transmission  
39 line between the substation and the interconnection site. The interconnection site is located at the  
40 Bonneville Power Administration Slatt Switching Station. [Amendment #1 (SFWF)]

1        **Meteorological Towers**

2            The facility includes two permanent meteorological (met) towers. [Amendment #1 (SFWF)]

3        **Field Workshop**

4            The facility includes a field workshop. Including fenced areas, the field workshop  
5 occupies about 1.6 acres. [Amendment #1 (SFWF)]

6        **Control System**

7            A fiber optic communications network links the control panels within each wind turbine  
8 to a host computer located in the field workshop. Supervisory, Control and Data Acquisition  
9 (SCADA) systems at the field workshop collect operating and performance data from the  
10 turbines and the facility’s met towers. [Amendment #1 (SFWF)]

11       **Access Roads**

12           The facility includes up to 33 miles of new roads that provide access to the turbine  
13 strings. The access roads connect to graveled turbine turnouts at the base of each turbine.  
14 [Amendment #1 (SFWF); Amendment #1]

15       **Temporary Construction Areas**

16           During construction, the facility includes temporary laydown areas used to stage  
17 construction and store supplies and equipment. The facility includes construction crane paths to  
18 move construction cranes between turbine strings.

**2. Location of the Facility**

19           The facility is located in Morrow County and Gilliam County south of Interstate  
20 Highway 84 and east of Arlington, Oregon, between State Highways 19 and 74. The facility is  
21 located entirely on private land subject to long-term wind energy leases. [Amendment #1 (SFWF)]

**IV. CONDITIONS REQUIRED BY COUNCIL RULES**

22           This section lists conditions required by OAR 345-~~027025-0020-0006~~ (Mandatory  
23 Conditions in Site Certificates), OAR 345-~~027025-0023-0010~~ (Site Specific Conditions), OAR  
24 345-~~027025-0028-0016~~ (Monitoring and Mitigation Conditions) and OAR Chapter 345, Division  
25 26 (Construction and Operation Rules for Facilities). These conditions should be read together  
26 with the specific facility conditions listed in Section V to ensure compliance with the siting  
27 standards of OAR Chapter 345, Divisions 22 and 24, and to protect the public health and safety.  
28 In these conditions, the definitions in OAR 345-001-0010 apply.

29           The obligation of the certificate holder to report information to the Department or the  
30 Council under the conditions listed in this section and in Section V is subject to the provisions of  
31 ORS 192.502 *et seq.* and ORS 469.560. To the extent permitted by law, the Department and the  
32 Council will not publicly disclose information that may be exempt from public disclosure if the  
33 certificate holder has clearly labeled such information and stated the basis for the exemption at  
34 the time of submitting the information to the Department or the Council. If the Council or the  
35 Department receives a request for the disclosure of the information, the Council or the  
36 Department, as appropriate, will make a reasonable attempt to notify the certificate holder and  
37 will refer the matter to the Attorney General for a determination of whether the exemption is  
38 applicable, pursuant to ORS 192.450.

1 In addition to these conditions, the site certificate holder is subject to all conditions and  
2 requirements contained in the rules of the Council and in local ordinances and state law in effect  
3 on the date the certificate is executed. Under ORS 469.401(2), upon a clear showing of a  
4 significant threat to the public health, safety or the environment that requires application of later-  
5 adopted laws or rules, the Council may require compliance with such later-adopted laws or rules.

6 The Council recognizes that many specific tasks related to the design, construction,  
7 operation and retirement of the facility will be undertaken by the certificate holder's agents or  
8 contractors. Nevertheless, the certificate holder is responsible for ensuring compliance with all  
9 provisions of the site certificate.

10 1 ~~OAR 345-025-0006(1)~~: The Council shall not change the conditions of the site certificate  
11 except as provided for in OAR Chapter 345, Division 27.

42 significantly from those described in the application for a site certificate. After the  
43 Department receives the notice, the Council may require the certificate holder to consult

1 with the Department of Geology and Mineral Industries and the Building Codes Division  
2 and to propose ~~and implement corrective or~~ mitigation actions. [\[Amendment #3\]](#)

3 14 ~~OAR 345-025-0006(14):~~ The certificate holder shall notify the Department, the State  
4 Building Codes Division and the Department of Geology and Mineral Industries promptly  
5 if shear zones, artesian aquifers, deformations or clastic dikes are found at or in the vicinity  
6 of the site. After the Department receives notice, the Council may require the certificate  
7 holder to consult with the Department of Geology and Mineral Industries and the Building  
8 Codes Division to propose and implement corrective or mitigation actions. [\[Amendment #2\]](#)

9 15 ~~OAR 345-025-0006(15):~~ Before any transfer of ownership of the facility or ownership of  
10 the site certificate holder, the certificate holder shall inform the Department of the proposed  
11 new owners. The requirements of OAR 345-027-0100 apply to any transfer of ownership  
12 that requires a transfer of the site certificate.

13 16 ~~OAR 345-025-0006(16):~~ If the Council finds that the certificate holder has permanently  
14 ceased construction or operation of the facility without retiring the facility according to a  
15 final retirement plan approved by the Council, as described in OAR 345-027-0110, the  
16 Council shall notify the certificate holder and request that the certificate holder submit a  
17 proposed final retirement plan to the Office within a reasonable time not to exceed 90 days.

8 (iii) Status of Surety Information: Documentation demonstrating that bonds or letters  
9 of credit as described in the site certificate are in full force and effect and will remain in full  
10 force and effect for the term of the next reporting period.

11 (iv) Monitoring Report: A list and description of all significant monitoring and  
12 mitigation activities performed during the previous year in accordance with site certificate  
13 terms and conditions, a summary of the results of those activities and a discussion of any  
14 significant changes to any monitoring or mitigation program, including the reason for any  
15 such changes.

16 (v) Compliance Report: A description of all instances of noncompliance with a site  
17 certificate condition. For ease of review, the certificate holder shall, in this section of the  
18 report, use numbered subparagraphs corresponding to the applicable sections of the site  
19 certificate.

20 (vi) Facility Modification Report: A summary of changes to the facility that the  
21 certificate holder has determined do not require a site certificate amendment in accordance  
22 with OAR 345-027-~~00500350~~. [Amendment #3]

24 ~~22~~ OAR 345-026-0105: The certificate holder and the Department of Energy shall exchange  
25 copies of all correspondence or summaries of correspondence related to compliance with

28 The certificate holder may submit abstracts of reports in place of full reports; however, the  
29 certificate holder shall provide full copies of abstracted reports and any summarized

## V. SPECIFIC FACILITY CONDITIONS

38 The conditions listed in this section include conditions based on representations in the  
39 site certificate application and supporting record. These conditions are required under OAR 345-  
40 ~~027025-00290006~~(10). The certificate holder must comply with these conditions in addition to  
41 the conditions listed in Section VI. This section includes other specific facility conditions the  
42 Council finds necessary to ensure compliance with the siting standards of OAR Chapter 345,  
43 Divisions 22 and 24, and to protect the public health and safety. For conditions that require

1 subsequent review and approval of a future action, ORS 469.402 authorizes the Council to  
2 delegate the future review and approval to the Department if, in the Council's discretion, the  
3 delegation is warranted under the circumstances of the case.

### 1. Certificate Administration Conditions

4 24 The certificate holder shall begin construction of the facility by July 25, 2011. The Council  
5 may grant an extension of the deadline to begin construction in accordance with OAR 345-  
6 027-0030 or any successor rule in effect at the time the request for extension is submitted.  
7 [Amendment #1 (SFWF)]

8 25 The certificate holder shall complete construction of the facility by July 25, 2014.  
9 Construction is complete when: 1) the facility is substantially complete as defined by the

12 consistent with the site certificate. The certificate holder shall promptly notify the

29 blade tip clearance of 21.5 meters above ground., with the exception of turbine number 368  
30 and 370 for which the minimum blade tip clearance must be 21.5 meters above the ground.

31 ~~(e)(d)~~ The maximum volume of concrete above three feet below grade in the turbine  
32 foundations must not exceed 66 cubic yards.

33 ~~(f)(e)~~ The maximum combined weight of metals in the tower (including ladders and  
34 platforms) and nacelle must not exceed 393 U.S. tons per turbine.

35 ~~(g)(f)~~ The certificate holder shall request an amendment of the site certificate ~~to increase~~  
36 ~~the combined peak generating capacity of the facility beyond 290 megawatts, to increase~~  
37 the number of wind turbines to more than 116 wind turbines or to install wind turbines with  
38 a hub height greater than 105 meters, a blade tip height greater than 150 meters or a blade  
39 tip clearance less than ~~25~~ 21.5 meters above ground.

40 [Amendment #1 (SFWF); Amendment #1, Amendment #2, Amendment #3]

41 27 The certificate holder shall obtain all necessary federal, state and local permits or approvals  
42 required for construction, operation and retirement of the facility or ensure that its  
43 contractors obtain the necessary federal, state and local permits or approvals.

1 28 Before beginning construction, the certificate holder shall notify the Department in advance  
2 of any work on the site that does not meet the definition of “construction” in ORS 469.300,  
3 excluding surveying, exploration or other activities to define or characterize the site, and  
4 shall provide to the Department a description of the work and evidence that its value is less  
5 than \$250,000.

6 29 Before beginning construction and after considering all micro-siting factors, the certificate  
7 holder shall provide to the Department, to the Oregon Department of Fish and Wildlife  
8 (ODFW) and to the Planning Directors of Morrow County and Gilliam County detailed  
9 maps of the facility site, showing the final locations where the certificate holder proposes to  
10 build facility components, and a table showing the acres of temporary and permanent  
11 habitat impact by habitat category and subtype, similar to Table 9 in the Final Order on  
12 Amendment #1 for the Shepherds Flat Wind Farm. The detailed maps of the facility site  
13 shall indicate the habitat categories of all areas that would be affected during construction  
14 (similar to the maps labeled “ODFW-2” in the site certificate application for the Shepherds  
15 Flat Wind Farm). In classifying the affected habitat into habitat categories, the certificate  
16 holder shall consult with the ODFW. The certificate holder shall not begin ground  
17 disturbance in an affected area until the habitat assessment has been approved by the  
18 Department. The Department may employ a qualified contractor to confirm the habitat  
19 assessment by on-site inspection. [Amendment #1 (SFWF)]

20 30 Before beginning construction, the certificate holder shall submit to the State of Oregon  
21 through the Council a bond or letter of credit in the amount described herein naming the  
22 State of Oregon, acting by and through the Council, as beneficiary or payee. The initial  
23 bond or letter of credit amount is either \$9.076 million (1<sup>st</sup> Quarter 2010 dollars), to be  
24 adjusted to the date of issuance as described in (b), or the amount determined as described  
25 in (a). The certificate holder shall adjust the amount of the bond or letter of credit on an  
26 annual basis thereafter as described in (b).

27 (a) The certificate holder may adjust the amount of the bond or letter of credit based on  
28 the final design configuration of the facility and turbine types selected by applying the unit  
29 costs and general costs illustrated in Table 2 in the Final Order on the Amendment #1 for  
30 the Shepherds Flat Wind Farm and calculating the financial assurance amount as described  
31 in that order, adjusted to the date of issuance as described in (b) and subject to approval by  
32 the Department.

33 (b) The certificate holder shall adjust the amount of the bond or letter of credit, using the  
34 following calculation and subject to approval by the Department:

35 (i) Adjust the Subtotal component of the bond or letter of credit amount (expressed in  
36 3<sup>rd</sup> Quarter 2009 dollars) to present value, using the U.S. Gross Domestic Product Implicit  
37 Price Deflator, Chain-Weight, as published in the Oregon Department of Administrative  
38 Services’ “Oregon Economic and Revenue Forecast” or by any successor agency (the  
39 “Index”) and using the index value for 3<sup>rd</sup> Quarter 2009 dollars and the quarterly index  
40 value for the date of issuance of the new bond or letter of credit. If at any time the Index is  
41 no longer published, the Council shall select a comparable calculation to adjust 3<sup>rd</sup> Quarter  
42 2009 dollars to present value.

43 (ii) Add 1 percent of the adjusted Subtotal (i) for the adjusted performance bond  
44 amount to determine the adjusted Gross Cost.

1 (iii) Add 10 percent of the adjusted Gross Cost (ii) for the adjusted administration and  
2 project management costs and 10 percent of the adjusted Gross Cost (ii) for the adjusted  
3 future developments contingency.

4 (iv) Add the adjusted Gross Cost (ii) to the sum of the percentages (iii) and round the  
5 resulting total to the nearest \$1,000 to determine the adjusted financial assurance amount.

6 (c) The certificate holder shall use a form of bond or letter of credit approved by the  
7 Council.

8 (d) The certificate holder shall use an issuer of the bond or letter of credit approved by  
9 the Council.

10 (e) The certificate holder shall describe the status of the bond or letter of credit in the  
11 annual report submitted to the Council under Condition 21.

12 (f) The bond or letter of credit shall not be subject to revocation or reduction before  
13 retirement of the facility site.

14 [Amendment #1 (SFWF); Amendment #1]

15 31 If the certificate holder elects to use a bond to meet the requirements of Condition 30, the  
16 certificate holder shall ensure that the surety is obligated to comply with the requirements  
17 of applicable statutes, Council rules and this site certificate when the surety exercises any  
18 legal or contractual right it may have to assume construction, operation or retirement of the  
19 energy facility. The certificate holder shall also ensure that the surety is obligated to notify  
20 the Council that it is exercising such rights and to obtain any Council approvals required by  
21 applicable statutes, Council rules and this site certificate before the surety commences any  
22 activity to complete construction, operate or retire the energy facility.

23 32 Before beginning construction, the certificate holder shall notify the Department of the  
24 identity and qualifications of the major design, engineering and construction contractor(s)  
25 for the facility. The certificate holder shall select contractors that have substantial  
26 experience in the design, engineering and construction of similar facilities. The certificate  
27 holder shall report to the Department any change of major contractors.

28 33 The certificate holder shall contractually require all construction contractors and  
29 subcontractors involved in the construction of the facility to comply with all applicable  
30 laws and regulations and with the terms and conditions of the site certificate. Such  
31 contractual provisions shall not operate to relieve the certificate holder of responsibility  
32 under the site certificate.

33 34 During construction, the certificate holder shall have a full-time, on-site assistant  
34 construction manager who is qualified in environmental compliance to ensure compliance  
35 with all site certificate conditions. The certificate holder shall notify the Department of the  
36 name, telephone number and e-mail address of this person.

37 35 Within 72 hours after discovery of conditions or circumstances that may violate the terms  
38 or conditions of the site certificate, the certificate holder shall report the conditions or  
39 circumstances to the Department.

## 2. Land Use Conditions

40 36 The certificate holder shall consult with area landowners and lessees during construction  
41 and operation of the facility and shall implement measures to reduce or avoid any adverse  
42 impacts to farm practices on surrounding lands and to avoid any increase in farming costs.

- 1 37 The certificate holder shall design and construct the facility using the minimum land area  
2 necessary for safe construction and operation. The certificate holder shall locate access  
3 roads and temporary construction laydown and staging areas to minimize disturbance with  
4 farming practices and, wherever feasible, shall place turbines and transmission  
5 interconnection lines along the margins of cultivated areas to reduce the potential for  
6 conflict with farm operations.
- 7 38 During construction and operation of the facility, the certificate holder shall implement a  
8 plan to control the introduction and spread of noxious weeds. The certificate shall develop  
9 the weed control plan consistent with the Gilliam County and Morrow County Weed  
10 Control Programs.
- 11 39 Before beginning construction of the facility, the certificate holder shall record in the real  
12 property records of Gilliam County a Covenant Not to Sue with regard to generally  
13 accepted farming practices on adjacent farmland consistent with Gilliam County Zoning  
14 Ordinance 7.020(T)(4)(a)(5).
- 15 40 The certificate holder shall construct all facility components in compliance with the  
16 following setback requirements:
- 17 (a) All facility components must be at least 3,520 feet from the property line of properties  
18 zoned residential use or designated in the Gilliam County Comprehensive Plan as  
19 residential.
- 20 (b) Where (a) does not apply, the certificate holder shall maintain a minimum distance of  
21 110-percent of maximum blade tip height, measured from the centerline of the turbine  
22 tower to the nearest edge of any public road right-of-way. The certificate holder shall  
23 assume a minimum right-of-way width of 60 feet.
- 24 (c) Where (a) does not apply, the certificate holder shall maintain a minimum distance of  
25 1,320 feet, measured from the centerline of the turbine tower to the center of the nearest  
26 residence existing at the time of tower construction.
- 27 (d) Where (a) does not apply, the certificate holder shall maintain a minimum distance of  
28 110-percent of maximum blade tip height, measured from the centerline of the turbine  
29 tower to the nearest boundary of the certificate holder’s lease area, except as provided in  
30 (e).
- 31 (e) The turbine tower setback distance described in (d) does not apply to the two isolated  
32 areas excluded from the certificate holder’s lease with the landowner identified as “Area A”  
33 and “Area B” in the *Final Order on Amendment #1*.
- 34 [Amendment #1]
- 35 41 Within 90 days after beginning operation, the certificate holder shall provide to the  
36 Department and to the Planning Directors of Gilliam County and Morrow County the actual  
37 latitude and longitude location or Stateplane NAD 83(91) coordinates of each turbine  
38 tower, connecting lines and transmission lines. In addition, the certificate holder shall  
39 provide to the Department and to the Planning Directors of Gilliam County and Morrow  
40 County, a summary of as-built changes in the facility compared to the original plan, if any.
- 41 42 The certificate holder shall install gates on all private facility access roads in Gilliam  
42 County, in accordance with Gilliam County Zoning Ordinance Section 7.020(T)(4)(d)(6).

### 3. Cultural Resource Conditions

1 43 Before beginning construction, the certificate holder shall provide to the Department a map  
2 showing the final design locations of all components of the facility and areas that would be  
3 temporarily disturbed during construction. In addition, the certificate holder shall comply  
4 with the following requirements:

5 (a) The certificate holder shall avoid disturbance within a 30-meter buffer around the  
6 prehistoric archaeological sites and historic-period archaeological sites within the facility  
7 boundary identified by AINW as “possibly eligible” for listing in the National Register of  
8 Historic Places (NRHP) as described in the Final Order on the Application for the  
9 Shepherds Flat Wind Farm.

10 (b) The certificate holder shall avoid disturbance of the stacked rock features within the  
11 facility boundary identified by AINW as “possibly eligible” for listing in the NRHP as  
12 described in the Final Order on the Application for the Shepherds Flat Wind Farm and  
13 shall, to the extent practicable, maintain a 30-meter no-construction buffer around these  
14 features. If a 30-meter buffer cannot be maintained, the certificate holder shall consult with  
15 the State Historic Preservation Office (SHPO) and the Department to determine appropriate  
16 action to preserve or document the feature.

17 (c) The certificate holder shall label “no entry” areas around all identified historic,  
18 cultural or archaeological resource sites on construction maps and drawings, and if  
19 construction activities will occur within 200 feet of an identified site, the certificate holder  
20 shall flag a 30-meter buffer around the site.

21 (d) The certificate holder shall hire qualified personnel to conduct pre-construction field  
22 investigation for historic, cultural or archaeological resources in any areas of potential  
23 construction disturbance that AINW did not previously survey.

24 (e) The certificate holder shall provide written reports of the field investigation required  
25 under (d) to the Department and to the SHPO. If any historic, cultural or archaeological  
26 resources are found that the SHPO determines to be significant, the certificate holder shall  
27 consult with the Department and the SHPO to develop plan to avoid disturbance of the  
28 resources during construction and operation of the facility. The certificate holder shall  
29 instruct all construction personnel to avoid areas where the resources were found and shall  
30 implement other appropriate measures to protect the resources.

31 [Amendment #1 (SFWF)]

32 44 The certificate holder shall ensure that a qualified archeologist, as defined in OAR 736-051-  
33 0070, instructs construction personnel in the identification of cultural materials and  
34 avoidance of accidental damage to identified resource sites.

35 45 The certificate holder shall ensure that construction personnel cease all ground-disturbing  
36 activities in the immediate area if any archaeological or cultural resources are found during  
37 construction of the facility until a qualified archeologist can evaluate the significance of the  
38 find. The certificate holder shall notify the Department and the State Historic Preservation  
39 Office (SHPO) of the find. If the SHPO determines that the resource is significant, the  
40 certificate holder shall make recommendations to the Council for mitigation, including  
41 avoidance, field documentation and data recovery, in consultation with the Department,  
42 SHPO, interested tribes and other appropriate parties. The certificate holder shall not restart  
43 work in the affected area until the certificate holder has demonstrated to the Department  
44 and the SHPO that it has complied with archaeological resource protection regulations.

1 46 In reference to the presumed alignments of the Oregon Trail described in the Final Order on  
2 the Application, the certificate holder shall comply with the following requirements:

3 (a) The certificate holder shall not locate facility components on visible remnants of the  
4 Oregon Trail and shall avoid any construction disturbance to those remnants.

5 (b) The certificate holder shall not locate facility components on undeveloped land where  
6 the trail alignment was marked by existing Oregon-California Trail Association markers as  
7 described in the October 2007 Archaeological Investigations Northwest, Inc. report (No.  
8 2012) on the Oregon Trail.

9 (c) Before beginning construction, the certificate holder shall provide to the State Historic  
10 Preservation Office (SHPO) and to the Department photographic documentation of the  
11 presumed Oregon Trail alignments within the site boundary.

12 (d) The certificate holder shall ensure that construction personnel proceed carefully in the  
13 vicinity of the presumed alignments of the Oregon Trail. If any intact physical evidence of  
14 the trail is discovered, the certificate holder shall avoid any disturbance to the intact  
15 segments, by redesign, re-engineering or restricting the area of construction activity. The  
16 certificate holder shall promptly notify the SHPO and the Department of the discovery. The  
17 certificate holder shall consult with the SHPO and the Department to determine appropriate  
18 mitigation measures.

#### 4. Geotechnical Conditions

19 47 Before beginning construction, the certificate holder shall conduct a site-specific  
20 geotechnical investigation and shall report its findings to the Oregon Department of  
21 Geology & Mineral Industries (DOGAMI) and the Department. The certificate holder shall  
22 conduct the geotechnical investigation after consultation with DOGAMI and in general  
23 accordance with DOGAMI open file report 00-04 “Guidelines for Engineering Geologic  
24 Reports and Site-Specific Seismic Hazard Reports.”

25 48 The certificate holder shall design and construct the facility in accordance with  
26 requirements set forth by the State of Oregon’s Building Code Division and any other  
27 applicable codes and design procedures. The certificate holder shall design facility  
28 structures to meet or exceed the minimum standards required by the 2003 International  
29 Building Code.

30 49 The certificate holder shall design, engineer and construct the facility to avoid dangers to  
31 human safety presented by non-seismic hazards. As used in this condition, “non-seismic  
32 hazards” include settlement, landslides, flooding and erosion.

#### 5. Hazardous Materials, Fire Protection & Public Safety Conditions

33 50 The certificate holder shall handle hazardous materials used on the site in a manner that  
34 protects public health, safety and the environment and shall comply with all applicable  
35 local, state and federal environmental laws and regulations. The certificate holder shall not  
36 store diesel fuel or gasoline on the facility site.

37 51 If a spill or release of hazardous material occurs during construction or operation of the  
38 facility, the certificate holder shall notify the Department within 72 hours and shall clean up  
39 the spill or release and dispose of any contaminated soil or other materials according to  
40 applicable regulations. The certificate holder shall make sure that spill kits containing items  
41 such as absorbent pads are located on equipment and at the field workshop. The certificate

1 holder shall instruct employees about proper handling, storage and cleanup of hazardous  
2 materials. [Amendment #1 (SFWF)]

3 52 During construction, the certificate holder shall ensure that construction personnel are  
4 trained in fire prevention and response, that construction vehicles and equipment are  
5 operated on graveled areas to the extent possible and that open flames, such as cutting  
6 torches, are kept away from dry grass areas.

7 53 During operation, the certificate holder shall ensure that all on-site employees receive  
8 annual fire prevention and response training, including tower rescue training, by qualified  
9 instructors or members of the local fire districts. The certificate holder shall ensure that all  
10 employees are instructed to keep vehicles on roads and off dry grassland, except when off-  
11 road operation is required for emergency purposes. The certificate holder shall encourage  
12 employees to become volunteer members of local fire departments and shall facilitate  
13 appropriate training.

14 54 During construction and operation of the facility, the certificate holder shall ensure that the  
15 field workshop and all service vehicles are equipped with shovels and portable fire  
16 extinguishers of a 4A50BC or equivalent rating. [Amendment #1 (SFWF)]

17 55 During construction and operation of the facility, the certificate holder shall develop and  
18 implement fire safety plans in consultation with the local fire protection agencies (the North  
19 Gilliam County Rural Fire Protection District and the Ione Rural Fire Protection District) to  
20 minimize the risk of fire and to respond appropriately to any fires that occur on the facility  
21 site. In developing the fire safety plans, the certificate holder shall take into account the dry  
22 nature of the region and shall address risks on a seasonal basis. The certificate holder shall  
23 meet annually with local fire protection agency personnel to discuss emergency planning  
24 and shall invite local fire protection agency personnel to observe any emergency drill or  
25 tower rescue training conducted at the facility.

26 56 Upon the beginning of operation of the facility, the certificate holder shall provide a site  
27 plan to the local fire protection agencies (the North Gilliam County Rural Fire Protection  
28 District and the Ione Rural Fire Protection District). The certificate holder shall indicate on  
29 the site plan the identification number assigned to each turbine and the location of all  
30 facility structures and shall provide an updated site plan if additional turbines or other  
31 structures are later added to the facility. During operation, the certificate holder shall ensure  
32 that appropriate fire protection agency personnel have an up-to-date list of the names and  
33 telephone numbers of facility personnel available to respond on a 24-hour basis in case of  
34 an emergency on the facility site.

35 57 Before beginning construction, the certificate holder shall submit a Notice of Proposed  
36 Construction or Alteration to the Federal Aviation Administration (FAA) and the Oregon  
37 Department of Aviation identifying the proposed final locations of turbine towers and  
38 meteorological towers. The certificate holder shall promptly notify the Department of the  
39 responses from the FAA and the Oregon Department of Aviation. [Amendment #1 (SFWF)]

40 58 The certificate holder shall construct turbines on concrete foundations and shall surround  
41 the base of each tower with a ten-foot pad area of washed crushed rock on all sides. The  
42 certificate holder shall cover turbine pad areas with non-erosive, non-flammable material as

1 soon as possible following exposure during construction and shall maintain the pad area  
2 covering during operation of the facility.

3 59 The certificate holder shall follow manufacturers' recommended handling instructions and  
4 procedures to prevent damage to turbine or turbine tower components that could lead to  
5 failure.

6 60 The certificate holder shall install and maintain self-monitoring devices on each turbine,  
7 connected to a fault annunciation panel or supervisory control and data acquisition  
8 (SCADA) system at the field workshop to alert operators to potentially dangerous  
9 conditions. The certificate holder shall maintain automatic equipment protection features in  
10 each turbine that would shut down the turbine and reduce the chance of a mechanical  
11 problem causing a fire. [Amendment #1 (SFWF)]

12 61 The certificate holder shall construct turbine towers with no exterior ladders or access to the  
13 turbine blades and shall install locked tower access doors. The certificate holder shall keep  
14 tower access doors locked at all times except when authorized personnel are present.

15 62 The certificate holder shall have an operational safety-monitoring program and shall inspect  
16 all turbine and turbine tower components on a regular basis. All turbine and turbine tower  
17 components will be inspected within 6 months of being repowered. The certificate holder  
18 shall maintain or repair turbine and turbine tower components as necessary to protect public  
19 safety. [Amendment #3]

20 63 For turbine types having pad-mounted step-up transformers, the certificate holder shall  
21 install the transformers at the base of each tower in locked cabinets designed to protect the  
22 public from electrical hazards and to avoid creation of artificial habitat for raptor prey.

23 64 To protect the public from electrical hazards, the certificate holder shall enclose the facility  
24 substation with appropriate fencing and locked gates. [Amendment #1 (SFWF)]

25 65 The certificate holder shall construct access roads with a finished width of approximately  
26 16 feet, a compacted base of native soil and a gravel surface to a depth of four to ten inches.  
27 [Amendment #1 (SFWF); Amendment #1]

28 66 During construction, the certificate holder shall implement measures to reduce traffic  
29 impacts, including:

30 (a) Providing notice to the City of Arlington Road Department, the Gilliam County Road  
31 Department and the Gilliam County Sheriff's Office in advance of deliveries that could  
32 cause traffic disruption in Arlington.

33 (b) Providing notice to the residents of Arlington in advance of deliveries that could  
34 cause traffic disruption.

35 (c) Requiring flaggers to be at appropriate locations at appropriate times during  
36 construction to direct traffic.

37 67 The certificate holder shall cooperate with the Gilliam County Road Department and the  
38 Morrow County Public Works Department to ensure that any unusual damage or wear to  
39 county roads that is caused by construction of the facility is repaired by the certificate  
40 holder. Submittal to the Department of an executed Road Use Agreement with Gilliam  
41 County and Morrow County shall constitute evidence of compliance with this condition.  
42 Upon completion of construction, the certificate holder shall restore county roads to pre-  
43 construction condition or better, to the satisfaction of the applicable county departments. If

1 required by Morrow County or Gilliam County, the certificate holder shall post bonds to  
2 ensure funds are available to repair and maintain roads affected by the proposed facility.

3 [\[Amendment #3\]](#)

4 68 During construction, the certificate holder shall require that all on-site construction  
5 contractors develop and implement a site health and safety plan that informs workers and  
6 others on-site what to do in case of an emergency and that includes the locations of fire  
7 extinguishers and nearby hospitals, important telephone numbers and first aid techniques.  
8 The certificate holder shall ensure that construction contractors have personnel on-site who  
9 are trained and equipped for tower rescue and who are first aid and CPR certified.

10 69 During operation, the certificate holder shall develop and implement a site health and safety  
11 plan that informs employees and others on-site what to do in case of an emergency and that  
12 includes the locations of fire extinguishers and nearby hospitals, important telephone  
13 numbers and first aid techniques.

14 70 During construction and operation of the facility, the certificate holder shall provide for on-  
15 site security and shall establish good communications between on-site security personnel  
16 and local law enforcement agencies (Gilliam County Sheriff and Morrow County Sheriff).  
17 During operation, the certificate holder shall ensure that appropriate law enforcement  
18 agency personnel have an up-to-date list of the names and telephone numbers of facility  
19 personnel available to respond on a 24-hour basis in case of an emergency on the facility  
20 site.

21 71 The certificate holder shall notify the Department and the Planning Directors of Gilliam  
22 County and Morrow County within 72 hours of any accidents including mechanical failures  
23 on the site associated with construction or operation of the facility that may result in public  
24 health and safety concerns.

## 6. Water, Soils, Streams & Wetlands Conditions

25 72 The certificate holder shall not build any roads or construct transmission line support poles  
26 within Eightmile Creek or within a 10-foot buffer from the ordinary high water line of the  
27 creek.

28 73 The certificate holder shall conduct all construction work, [including the repowering](#)  
29 [activities associated with Amendment #3](#), in compliance with an Erosion and Sediment  
30 Control Plan (ESCP) satisfactory to the Oregon Department of Environmental Quality and  
31 as required under the National Pollutant Discharge Elimination System (NPDES) Storm  
32 Water Discharge General Permit #1200-C. The certificate holder shall include in the ESCP  
33 any procedures necessary to meet local erosion and sediment control requirements or storm  
34 water management requirements. [\[Amendment #3\]](#)

35 74 During construction, the certificate holder shall limit truck traffic to designated existing and  
36 improved road surfaces to avoid soil compaction, to the extent practicable.

37 75 During construction, the certificate holder shall implement best management practices to  
38 control any dust generated by construction activities, such as applying water to roads and  
39 disturbed soil areas.

40 76 During construction, the certificate holder shall reduce temporary disturbance impacts by  
41 making use of previously disturbed areas, including roadways and tracks, and by preserving

1 vegetation rootstalks by crushing, rather than scraping, vegetation in areas of temporary  
2 disturbance.

3 77 During facility operation, the certificate holder shall routinely inspect and maintain all  
4 roads, pads and trenched areas and, as necessary, maintain or repair erosion and sediment  
5 control measures. The certificate holder shall restore areas that are temporarily disturbed  
6 during facility maintenance or repair activities to pre-disturbance condition or better.

7 78 During facility operation, the certificate holder shall obtain water for on-site uses from a  
8 well at the field workshop, subject to compliance with applicable permit requirements. The  
9 certificate holder shall not use more than 5,000 gallons of water per day from the facility's  
10 on-site well. [Amendment #1 (SFWF)]

## 7. Transmission Line & EMF Conditions

11 79 The certificate holder shall install the 34.5-kV collector system underground to the extent  
12 practicable. The certificate holder shall install underground lines at a minimum depth of  
13 three feet. Based on geotechnical conditions or other engineering considerations, the  
14 certificate holder may install segments of the collector system aboveground on single-pole,  
15 cross-arm structures, but the total length of aboveground double-circuit segments must not  
16 exceed 9 miles and the total length of aboveground single-circuit segments must not exceed  
17 6 miles. [Amendment #1 (SFWF); Amendment #1]

18 80 The certificate holder shall ground appropriate sections of fencing that parallel transmission  
19 lines to reduce the risk of shock from induced voltage. In particular, the certificate holder  
20 shall ground appropriate sections of fencing located in the northern project area on the west  
21 side of Eightmile Canyon if the certificate holder builds a parallel transmission line in that  
22 location that could induce a voltage on the fence.

23 81 The certificate holder shall take reasonable steps to reduce or manage human exposure to  
24 electromagnetic fields, including but not limited to:

25 (a) Constructing all aboveground transmission lines at least 200 feet from any residence  
26 or other occupied structure, measured from the centerline of the transmission line.

27 (b) Constructing all aboveground 34.5-kV transmission lines with a minimum clearance  
28 of 20 feet from the ground.

29 (c) Constructing all aboveground 230-kV transmission lines with a minimum clearance of  
30 24 feet from the ground.

31 (d) Fencing the areas near the facility substation to ensure that substation equipment is  
32 not accessible to the public.

33 (e) Providing to landowners a map of underground and overhead transmission lines on  
34 their property and advising landowners of possible health risks.

35 (f) Designing and maintaining all transmission lines so that alternating current electric  
36 fields do not exceed 9 kV per meter at one meter above the ground surface in areas  
37 accessible to the public.

38 [Amendment #1 (SFWF)]

39 82 In advance of, and during, preparation of detailed design drawings and specifications for  
40 230-kV and 34.5-kV transmission lines, the certificate holder shall consult with the Utility  
41 Safety and Reliability Section of the Oregon Public Utility Commission to ensure that the  
42 designs and specifications are consistent with applicable codes and standards.

## 8. Plants, Wildlife & Habitat Protection Conditions

1 83 The certificate holder shall conduct wildlife monitoring as described in the *Wildlife*  
2 *Monitoring and Mitigation Plan* that is incorporated in the *Final Order on Amendment #2*  
3 as Attachment D and as amended from time to time. [Amendment #1 (SFWF); Amendment #1;  
4 Amendment #2]

5 84 The certificate holder shall restore areas disturbed by facility construction but not occupied  
6 by permanent facility structures, and temporarily disturbed during routine operational road  
7 work activity, according to the methods and monitoring procedures described in the  
8 Revegetation Plan that is incorporated in the Final Order on Amendment #2 for the  
9 Shepherds Flat Wind Farm as Attachment C and as amended from time to time. [Amendment  
10 #1 (SFWF); Amendment #2]

11 85 The certificate holder shall acquire the legal right to create, enhance, maintain and protect a  
12 habitat mitigation area as long as the site certificate is in effect by means of an outright  
13 purchase, conservation easement or similar conveyance and shall provide a copy of the  
14 documentation to the Department. Within the habitat mitigation area, the certificate holder  
15 shall improve the habitat quality as described in the *Habitat Mitigation Plan* that is  
16 incorporated in the *Final Order on Amendment #1* as Attachment C and as amended from  
17 time to time. [Amendment #1 (SFWF); Amendment #1]

18 86 The certificate holder shall avoid permanent and temporary disturbance to the areas  
19 described in (a) through (g) and, during the times indicated, shall avoid construction  
20 disturbance in the areas described in (h) through (k). The certificate holder shall flag these  
21 areas for the duration of construction activities nearby and shall ensure that construction  
22 personnel avoid disturbance of the areas. The avoidance areas are:

23 (a) All Category 1 habitat and those areas of Category 2 habitat shown on the “ODFW-2”  
24 Figures 1 through 12 in the Shepherds Flat Wind Farm Application. [Amendment #1 (SFWF)]

25 (b) Areas of Category 3 shrub-steppe habitat as described in the *Final Order on*  
26 *Amendment #1 for the Shepherds Flat Wind Farm*, Section IV.4.(b)A, including three small  
27 areas of sage shrub-steppe habitat, one small area of purshia shrub-steppe habitat and one  
28 small area of shrub-steppe rabbitbrush habitat. [Amendment #1 (SFWF)]

29 (c) All seeps, riparian areas and vernal pools.

30 (d) All water sources for wildlife, including perennial and intermittent streams, stock  
31 ponds and watering stations.

32 (e) All faces of bluffs or rock outcroppings.

33 (f) All trees or other structures that contain active raptor nests.

34 (g) For the facility substation and field workshop, all Category 3 habitat. [Amendment #1  
35 (SFWF)]

36 (h) The area within 1,000 feet of Category 2 Washington ground squirrel (WGS) habitat  
37 (as shown on “ODFW-2” Figure 8 in the Shepherds Flat Wind Farm Application) during  
38 the period in which the squirrels are active. To determine when the WGS are active, the  
39 certificate holder shall hire a qualified independent professional biologist to monitor the on-  
40 site colony within the Category 1 WGS habitat area described in the Final Order on the  
41 Application. The biologist shall begin monitoring the colony on January 15 if construction  
42 activity is occurring within 0.5 miles of the Category 2 WGS habitat at that time.

43 Otherwise, the biologist shall begin monitoring upon the start of construction activity  
44 within 0.5 miles of the Category 2 WGS habitat at any time between January 15 and June

1 30. The biologist shall conduct weekly monitoring to detect signs of WGS activity. If signs  
2 of WGS activity are observed, the certificate holder shall halt construction activities within  
3 the avoidance area and shall notify the Department. The certificate holder shall flag the  
4 avoidance area and ensure that construction personnel avoid disturbance of the area until  
5 the biologist has determined that the WGS are no longer active. While the WGS are active,  
6 the biologist may suspend weekly monitoring until May 1. The certificate holder may  
7 resume construction activities within the avoidance area when the WGS are no longer  
8 active, as determined by the absence of WGS activity during three consecutive weeks of  
9 monitoring by the biologist. [This text had been removed by Amendment #1 (SFWF) and was restored  
10 by Amendment #1]

11 (i) The area within 0.5 miles of Category 3 curlew nesting habitat and the area within 0.5  
12 miles the BLM Horn Butte Wildlife Area during the nesting season (March 8 through June  
13 15). Before beginning construction, the certificate holder shall provide to the Department a  
14 map showing these avoidance areas relative to areas of potential construction disturbance.  
15 The certificate holder may engage in construction activities in these areas at times other  
16 than the nesting season.

17 (j) The area within 1,000 feet of any essential, limited and irreplaceable Washington  
18 ground squirrel (WGS) habitat within the new areas added to the site by Amendment #1  
19 (excluding the areas within the site boundaries of Shepherds Flat North, Shepherds Flat  
20 Central and Shepherds Flat South as approved on September 11, 2009) during the period in  
21 which the squirrels are active. The certificate holder shall hire a qualified independent  
22 professional biologist to conduct pre-construction surveys for State-listed threatened,  
23 endangered or sensitive wildlife species in these new areas within 1,000 feet of any area  
24 potentially disturbed by facility construction. To determine whether WGS habitat exists and  
25 to determine whether WGS are active, the biologist shall search for WGS in suitable habitat  
26 using a two-survey protocol approved by the Oregon Department of Fish and Wildlife  
27 (ODFW). The certificate holder shall submit the results of the survey to ODFW and to the  
28 Department. If signs of WGS activity are observed, the certificate holder shall flag the  
29 avoidance area and ensure that construction personnel avoid disturbance of the area until  
30 the biologist has determined that the WGS are no longer active.

31 (k) Areas within a suitable buffer around confirmed populations of Laurent's milk-vetch  
32 or any other State-listed threatened or endangered plant species within the new areas added  
33 to the site by Amendment #1 (excluding the area within the site boundaries of Shepherds  
34 Flat North, Shepherds Flat Central and Shepherds Flat South as approved on September 11,  
35 2009). The certificate holder shall not install facility components or cause temporary  
36 disturbance within these areas. The certificate holder shall hire a qualified independent  
37 professional biologist to conduct pre-construction surveys for State-listed threatened or  
38 endangered plant species in these new areas within 1,000 feet of any area potentially  
39 disturbed by facility construction. The certificate holder shall submit the results of the  
40 survey to the Department.

41 [Amendment #1]

42 87 The certificate holder shall microsite the facility in conformance with the industry's best  
43 practices. The certificate holder shall follow the recommendations of a qualified wildlife  
44 biologist to avoid building turbine towers in the following locations:

45 (a) Areas of increased risk to avian species due to constricted flight paths, such as narrow  
46 ridge saddles and gaps between hilltops.

1 (b) Areas on slopes greater than 20 percent.

2 (c) [text removed by Amendment #1 (SFWF)]

3 (d) [text removed by Amendment #1 (SFWF)]

4 **88** During construction, the certificate holder shall avoid construction activities in areas around  
5 active nests of the following species during the sensitive period, as provided in this  
6 condition:

<u>Species</u>	<u>Sensitive Period</u>	<u>Early Release Date</u>
Swainson's hawk	April 1 to August 15	May 31
Ferruginous hawk	March 15 to August 15	May 31
Burrowing owl	April 1 to August 15	July 15

7 The certificate holder shall conduct pre-construction surveys, using a protocol approved by  
8 the Oregon Department of Fish and Wildlife (ODFW) to determine whether there are any  
9 active nests of these species within 0.5 miles of any areas that would be disturbed during  
10 construction. The certificate holder shall search the scheduled construction areas and all  
11 areas within 0.5 miles of the construction areas. If a nest is occupied by any of these species  
12 after the beginning of the sensitive period, the certificate holder will flag the boundaries of  
13 a 0.5-mile buffer area around the nest and shall instruct construction personnel to avoid  
14 disturbance of the area. The certificate holder shall hire a qualified independent  
15 professional biologist to observe the active nest sites during the sensitive period for signs of  
16 disturbance and to notify the Department of any non-compliance with this condition. If the  
17 biologist observes nest site abandonment or other adverse impact to nesting activity, the  
18 certificate holder shall implement appropriate mitigation, in consultation with ODFW and  
19 subject to the approval of the Department, unless the adverse impact is clearly shown to  
20 have a cause other than construction activity. The certificate holder may begin or resume  
21 construction activities within a buffer area before the ending day of the sensitive period if  
22 any known nest site is not occupied by the early release date. If a nest site is occupied, then  
23 the certificate holder may begin or resume construction before the ending day of the  
24 sensitive period with the approval of ODFW, after the young are fledged. The certificate  
25 holder shall use a protocol approved by ODFW to determine when the young are fledged  
26 (the young are independent of the core nest site).

27 **89** The certificate holder shall not remove any trees that are greater than three feet in height.

28 **90** The certificate holder shall design all aboveground transmission line support structures  
29 following the most current suggested practices for avian protection on power lines  
30 published by the Avian Power Line Interaction Committee.

31 **91** The certificate holder shall reduce the risk of injuries to avian species by:

32 (a) Installing turbine towers that are smooth steel structures that lack features that would  
33 allow avian perching.

34 (b) Installing meteorological towers that are non-guyed structures to eliminate the risk of  
35 avian collision with guy-wires.

36 (c) Avoiding installation of aboveground transmission lines across narrow saddles,  
37 ravines and similar features and, where such crossings cannot be avoided, installing line-  
38 markers to make the lines more visible to avian species.

39 **92** The certificate holder shall impose and enforce construction and operation speed limits of 5  
40 miles per hour on roads within 1,000 feet of Category 1 or Category 2 Washington ground

1 squirrel habitat and 20 miles per hour on all other facility roads and shall ensure that all  
2 construction and operations personnel are instructed on the importance of cautious driving  
3 practices while on facility roads. [Amendment #1 (SFWF); Amendment #1]

## 9. Visual Effects Conditions

4 93 To reduce the visual impact of the facility, the certificate holder shall:

5 (a) Mount nacelles on smooth, steel structures, painted uniformly in a matte-finish,  
6 neutral white color.

7 (b) Paint substation structures in a neutral color to blend with the surrounding landscape.

8 (c) Not allow any advertising to be used on any part of the facility.

9 (d) Use only those signs required for facility safety, required by law or otherwise required  
10 by this site certificate, except that the certificate holder may erect a sign to identify the  
11 facility near the field workshop, may paint turbine numbers on each tower and may allow  
12 unobtrusive manufacturers' logos on turbine nacelles.

13 (e) Not locate any facility signs along Highway 74.

14 (f) Design signs in accordance with Gilliam County Zoning Ordinance Section 8.030 and  
15 Morrow County Zoning Ordinance Section 4.070, as applicable.

16 (g) Maintain any signs allowed under this condition in good repair.

17 [Amendment #1 (SFWF)]

18 94 The certificate holder shall design and construct the field workshop to be generally  
19 consistent with the character of similar buildings used by commercial farmers or ranchers in  
20 the area and shall paint the building in a neutral color to blend with the surrounding  
21 landscape. [Amendment #1 (SFWF)]

22 95 The certificate holder shall not use exterior nighttime lighting except:

23 (a) The minimum turbine tower lighting required or recommended by the Federal  
24 Aviation Administration.

25 (b) Security lighting at the field workshop and substation, provided that such lighting is  
26 shielded or downward-directed to reduce glare.

27 (c) Minimum lighting necessary for repairs or emergencies.

28 (d) Minimum lighting necessary for nighttime construction. The certificate holder may  
29 use lighting only at the work location and only directed downward to illuminate the work  
30 area at the turbine base or upward from the base to illuminate the turbine tower;  
31 construction lighting shall not be directed outward. The certificate holder shall use  
32 nighttime lighting only with the approval of the owner of the property on which the work is  
33 conducted and shall provide notice of nighttime construction to occupants of all residences  
34 within one-half mile of the construction site.

35 [Amendment #1 (SFWF)]

## 10. Noise Control Conditions

36 96 To reduce noise impacts at nearby residences, the certificate holder shall:

37 (a) Confine the noisiest operation of heavy construction equipment to the daylight hours.

38 (b) Require contractors to install and maintain exhaust mufflers on all combustion  
39 engine-powered equipment; and

1 (c) Establish a complaint response system at the construction manager’s office to address  
2 noise complaints.

3 97 Before beginning construction, the certificate holder shall provide to the Department:

4 (a) Information that identifies the final design locations of all turbines to be built at the  
5 facility.

6 (b) The maximum sound power level for the substation transformers and the maximum  
7 sound power level and octave band data for the turbines selected for the facility based on  
8 manufacturers’ warranties or confirmed by other means acceptable to the Department.

9 (c) The results of noise analysis of the facility to be built according to the final design  
10 performed in a manner consistent with the requirements of OAR 340-035-0035  
11 (1)(b)(B)(iii)(IV) and (VI) demonstrating to the satisfaction of the Department that the total  
12 noise generated by the facility (including the noise from turbines and substation  
13 transformers) would meet the ambient degradation test and maximum allowable test at the  
14 appropriate measurement point for all potentially-affected noise sensitive properties.

15 (d) For each noise-sensitive property where the certificate holder relies on a noise waiver  
16 to demonstrate compliance in accordance with OAR 340-035-0035 (1)(b)(B)(iii)(III), a  
17 copy of the a legally effective easement or real covenant pursuant to which the owner of the  
18 property authorizes the certificate holder’s operation of the facility to increase ambient  
19 statistical noise levels  $L_{10}$  and  $L_{50}$  by more than 10 dBA at the appropriate measurement  
20 point. The legally-effective easement or real covenant must: include a legal description of  
21 the burdened property (the noise sensitive property); be recorded in the real property  
22 records of the county; expressly benefit the certificate holder; expressly run with the land  
23 and bind all future owners, lessees or holders of any interest in the burdened property; and  
24 not be subject to revocation without the certificate holder’s written approval.

25 98 During operation, the certificate holder shall maintain a complaint response system to  
26 address noise complaints. The certificate holder shall promptly notify the Department of  
27 any complaints received regarding facility noise and of any actions taken by the certificate  
28 holder to address those complaints. In response to a complaint from the owner of a noise  
29 sensitive property regarding noise levels during operation of the facility, the Council may  
30 require the certificate holder to monitor and record the statistical noise levels to verify that  
31 the certificate holder is operating the facility in compliance with the noise control  
32 regulations. [Amendment #1 (SFWF)]

## 11. Waste Management Conditions

33 99 The certificate holder shall provide portable toilets for on-site sewage handling during  
34 construction and shall ensure that they are pumped and cleaned regularly by a licensed  
35 contractor who is qualified to pump and clean portable toilet facilities.

36 100 During operation, the certificate holder shall discharge sanitary wastewater generated at the  
37 field workshop to a licensed on-site septic system in compliance with county permit  
38 requirements. The certificate holder shall design the septic system for a discharge capacity  
39 of less than 2,500 gallons per day. [Amendment #1 (SFWF)]

40 101 The certificate holder shall implement a waste management plan during construction that  
41 includes but is not limited to the following measures:

42 (a) Recycling steel and other metal scrap.

- 1 (b) Recycling wood waste.
- 2 (c) Recycling packaging wastes such as paper and cardboard.
- 3 (d) Collecting non-recyclable waste for transport to a local landfill by a licensed waste
- 4 hauler or by using facility equipment and personnel to haul the waste.
- 5 (e) Segregating all hazardous wastes such as used oil, oily rags and oil-absorbent
- 6 materials, mercury-containing lights and lead-acid and nickel-cadmium batteries for
- 7 disposal by a licensed firm specializing in the proper recycling or disposal of hazardous
- 8 wastes.
- 9 (f) Discharging all concrete truck rinse water into foundation holes and completing truck
- 10 wash-down off-site.

11 102 The certificate holder shall implement a waste management plan during operation that

12 includes but is not limited to the following measures:

- 13 (a) Training employees to minimize and recycle solid waste.
- 14 (b) Recycling paper products, metals, glass and plastics.
- 15 (c) Recycling used oil and hydraulic fluid.
- 16 (d) Collecting non-recyclable waste for transport to a local landfill by a licensed waste
- 17 hauler or by using facility equipment and personnel to haul the waste.
- 18 (e) Segregating all hazardous, non-recyclable wastes such as used oil, oily rags and oil-
- 19 absorbent materials, mercury-containing lights and lead-acid and nickel-cadmium batteries
- 20 for disposal by a licensed firm specializing in the proper recycling or disposal of hazardous
- 21 wastes.

22 103 Before beginning construction, the certificate holder shall determine whether any

23 construction disturbance would occur in locations not previously investigated for potential

24 jurisdictional waters as described in the *Final Order on Amendment #1*. The certificate

25 holder shall conduct pre-construction investigations in these new areas within 1,000 feet of

26 any area potentially disturbed by facility construction to determine whether any State-

27 jurisdictional waters exist in those locations. The certificate holder shall submit a written

28 report on the pre-construction investigation to the Department of Energy and to the

29 Department of State Lands for approval before beginning construction and shall ensure that

30 construction would have no impact on any jurisdictional water identified in the report.

31 [Amendment #1]

## 12. New Conditions applicable to RFA2 facility modifications

32 The conditions listed in this section are specific to the facility modifications approved in the

33 Second Amended Site Certificate.

34

35 104 After January 1 but no later than April 30 of the year after completion of the Operations and

36 Maintenance demonstration activity for wind turbines 368 and 370, as approved in RFA2,

37 the certificate holder shall include in its Annual Report an activity and operational status

38 summary of the repowered wind turbines.

39 [Amendment #2]

40 105 Following completion of the O&M demonstration activity at wind turbines 368 and 370, as

41 approved in RFA2, the certificate holder shall implement an ongoing inspection,

42 monitoring and remediation program as follows:

1 (a) Submit to the Department a copy of an appropriate foundation inspection plan that  
2 specifies timing, frequency and methodology for evaluation of wind turbine  
3 foundation integrity, fatigue stress and other design checks, as recommended by the  
4 wind turbine manufacturer.

5 (b) Within five months of completion of the O&M demonstration activity at wind  
6 turbine 368, the certificate holder must complete a crack depth investigation or other  
7 testing such as coring to verify if the foundation cracks are surface or deep cracks.  
8 The certificate holder shall submit to the Department and DOGAMI the results of  
9 the crack depth investigation, remediation recommendations, and remediation  
10 schedule.

11 (c) Wind turbine 368 shall not be operated more than five months after the O&M  
12 demonstration activity unless the remediation actions are implemented per the  
13 investigation report referenced in (b), unless, based on the findings of the  
14 investigation report referenced in (b), approval to continue to operate wind turbine  
15 368 without remediation actions is granted from the Department in consultation  
16 with DOGAMI.

17 [Amendment #2]

18 106 Before beginning the operation and maintenance demonstration activities at Turbines 368  
19 and 370, the certificate holder shall submit a Notice of Proposed Construction or Alteration  
20 to the Federal Aviation Administration (FAA) and the Oregon Department of Aviation  
21 identifying the new maximum blade tip height of 150 meters. The certificate holder shall  
22 promptly notify the Department of the responses from the FAA and the Oregon Department  
23 of Aviation.

24 [Amendment #2]

25 107 Prior to completion of the O&M demonstration activity for wind turbines 368 and 370, as  
26 approved in RFA2, the certificate holder shall submit to the Department the maximum  
27 sound power level and octave band for the modified wind turbines based on manufacturer'  
28 warranties or confirmed by other means acceptable to the Department.

29 [Amendment #2]

### 13. New Conditions applicable to RFA3 facility modifications

30 108 The certificate holder shall begin construction of the Shepherds Flat Central facility  
31 modifications, as approved in the Third Amended Site Certificate, within three years after  
32 the effective date of the amended site certificate [TBD]. The certificate holder shall notify  
33 the Department when construction of the of the facility modifications, as approved in  
34 Request for Amendment 3, commences. Under OAR 345-015-0085(8), the amended site  
35 certificate is effective upon execution by the Council Chair and the certificate holder.  
36 [Amendment #3]

37 109 The certificate holder shall complete construction of the Shepherds Flat Central facility  
38 modifications, as approved in the Third Amended Site Certificate, within three years  
39 following the date of construction commencement [TBD]. The certificate holder shall  
40 promptly notify the Department of the date of completion of construction of the facility  
41 modifications, as approved in Request for Amendment 3. [Amendment #3]

1 110 Prior to Amendment #3 facility repower activities, the certificate holder shall provide the  
2 Department with the foundation uprate analysis on facility turbines. If the analysis results  
3 identify necessary mitigation and remediation measures, or operational timing  
4 recommendations, the certificate holder shall implement the identified measures and  
5 recommendations prior to beginning the repowering activities unless otherwise approved by  
6 the Department. [Amendment #3]

7 111 Prior to Amendment #3 facility repower activities, the certificate holder shall coordinate  
8 with the Gilliam County Weed Department and the Morrow County Weed Control  
9 Department, and submit to the Department, a Roadway Weed Control Plan. The  
10 Department shall review and approve the plan, in consultation with the Gilliam County  
11 Weed Department and the Morrow County Weed Control Department. The Roadway Weed  
12 Control Plan shall include, as pertinent, but not be limited to, identification of county-listed  
13 weeds of economic concern, methods for evaluating weeds within impact area, results of  
14 weed assessment, control methods specific to roadway weed control and timing, agency  
15 consultation protocol, and process for evaluating success of weed control. [Amendment #3]

16 112 The certificate holder shall:

17 (a) Prior to RFA3 facility repower activities:

18 (i) Provide an updated habitat assessment of areas of disturbance, based on a protocol  
19 approved by the Department in consultation with ODFW.

20 (ii) Identify monitoring and reference sites, including sites within each habitat  
21 category and subtype impacted, and the methodology utilized for selecting the  
22 number of monitoring and reference sites should be included.

23 (iii) Consult with the Department, ODFW and Gilliam County Weed Control  
24 Department and Morrow County Weed Control Department on timing and methods  
25 for revegetation and weed control.

26 (b) Following completion of RFA3 facility repower activities:

27 (i) Restore areas temporarily disturbed by RFA3 facility repower activities according  
28 to the methods and monitoring procedures described in the Revegetation Plan that is  
29 incorporated in the Final Order on Amendment 3 for Shepherds Flat Central as  
30 Attachment D and as amended from time to time.

31 (ii) Consult annually with the Department, ODFW. Gilliam and Morrow County

GENERAL COMMENTS: ODFW appreciates the opportunity to review this project according to the Energy Facility Siting Standard for Fish and Wildlife Habitat, as well as the Threatened and Endangered Species Standard.

ODFW appreciates the Applicant working with ODFW and our concerns on the proposed amendment. The Applicant has incorporated our comments from earlier consultation into their current application. ODFW would however make one comment regarding the proposed amendment.

SPECIFIC COMMENTS: ODFW would recommend that the Applicant complete two years of fatality monitoring on the project after the turbines have been retrofitted with the larger blades to look at mortality effects from the larger turbine sizes. ODFW's recommendation is based on the fact that the original project exceeded the raptor mortality threshold during the original post construction fatality monitoring. We also understand the mortality surveys can vary from year to year and that one year of monitoring may not be completely indicative of the fatality effects for the project.

ODFW has no further comments on this amendment at this time. Please contact Steve Cherry (District Wildlife Biologist) or Sarah Reif (Energy Coordinator) with any questions.

Gilliam County would encourage the existing conditions be reviewed and that particular attention be given to words and phrases about construction, although the wind farm is constructed there are several original construction conditions that may reapply to this situation. Throughout the Final Order and Conditions listed Gilliam County would emphasize that the word(s) 'during construction and/or construction' should apply to the repower installation; this may require rewording the conditions to ensure clarity that repower is in fact a type of construction.

A few examples are outlined below.

Please ensure landowners and lessees are informed of the repower project prior to commencing (No. 36)  
Weed control plan may need to be reviewed to determine if any additional measures/precautions need to take place during the repower (No. 38)  
Please ensure / double check there is no issue with sets backs and the new proposed longer blades (No. 40 b and d)  
Ensure local fire protection district and emergency service is informed of when repower construction will commence (No. 54, 55, 56, 68)  
Ensure Gilliam County Road Department is consulted regarding whether a road use agreement is necessary for this phase of repower construction (No. 66, 67)  
Ensure notification to local law enforcement specifically Gilliam County Sheriff's Office of when repower will commence and for how long the repower project is anticipated (No. 70)  
Suggest conducting wildlife monitoring to assess if the new longer blades impact area raptors and bats and coordinating repower construction with ODFW .  
Restore vegetation (No. 11)

Has the wind farm commented or proposed a timeframe for the repower? Or is the time frame prescribed by EFSC? (No. 24, 25, 26)

## 1 **I. Introduction**

2 This plan describes methods and standards for restoration of areas of construction  
3 disturbance and areas temporarily disturbed during routing operational road work activities. This  
plan applies to the areas surrounding the permanent facility components of Shepherds Flat Central  
(SFC).<sup>1</sup> The objective of revegetation is to restore the disturbed areas to  
5 pre-disturbance condition or better. The site certificate for the facility requires restoration of  
6 these areas. This plan has been developed in consultation with the Oregon Department of Fish  
7 and Wildlife (ODFW).

8 The areas of construction disturbance include cultivated or otherwise developed  
9 agricultural land (cropland) as well as areas of grassland, shrub-steppe habitat and other habitat  
10 subtypes (wildlife habitat areas). The intensity of construction impact will vary. In some areas,  
11 the impact will be relatively light, but in other areas, heavy construction activity will remove all  
12 vegetation, remove topsoil and compact the remaining subsoil. Where vegetation has been  
13 damaged or removed during construction, the certificate holder must restore suitable vegetation.  
14 In addition, the certificate holder shall maintain erosion and sediment control measures put in  
15 place during construction until the affected areas are restored as described in this plan and the  
16 risk of erosion has been eliminated. The plan specifies monitoring procedures to evaluate  
17 revegetation success of disturbed wildlife habitat areas. Remedial action may be necessary for  
18 wildlife habitat areas that do not show revegetation progress. Additional mitigation may be  
19 necessary if revegetation is unsuccessful.

## 20 **II. Description of the Project Area**

21 Most of the SFC site lies within Gilliam County (approximately 6,886 acres).  
22 Approximately 49 acres within the site boundary lie within Morrow County. Much of the area in  
23 the northern part of the site is characterized by shallow soils. The area is used primarily for  
24 grazing of sheep, but low rainfall (approximately 9 inches of precipitation annually) limits  
25 forage, and sheep are typically removed from the area from May to November. The site contains  
26 areas of bare sand, exposed rock and bare soil, and there are numerous unimproved roads and  
27 off-road vehicle tracks as well as several electrical transmission line corridors. Some locations  
28 are highly disturbed from congregation of sheep around watering and transport sites. Invasive  
29 species (such as cheatgrass and spring-Whitlow grass) are the predominant grass species in most  
30 areas, but native species (such as Sandberg's bluegrass, needle-and-thread grass, bluebunch  
31 wheatgrass and six-weeks fescue) are also present. Portions of Eightmile Canyon lie within or  
32 near the site boundary. Eightmile Canyon contains an intermittent stream and is cultivated in  
33 some areas. The southern part of the site contains deeper soils. Most of the southern area is  
34 cultivated for dryland wheat farming.

### 1 **III. Revegetation Methods**

2 The certificate holder shall begin restoration of disturbed areas as soon as possible after  
3 completion of facility construction activity in the area to be restored. Restoration measures  
4 include soil preparation and seeding as described below. Planting should be done at the  
5 appropriate time of year to facilitate seed germination, based on weather conditions. The  
6 certificate holder shall choose planting methods based on site-specific factors such as slope,  
7 erosion potential and the size of the area in need of revegetation.

#### 8 **1. Correction for Compaction**

9 In the northern section, soils are generally too shallow to become compacted by  
10 construction activities. Deeper soils in the southern section may become compacted. The  
11 certificate holder shall examine disturbed areas as soon as construction is finished in the area.  
12 Areas that appear to be affected by compaction will be treated by deep tillage or ripping  
13 (scarification) using the method preferred by the landowner. In some areas, compaction might  
14 not become evident until vegetation indicates the condition through poor seed sprouting, stunting  
15 or plant death. Where that occurs, the area will be tilled or ripped and then re-seeded.

#### 16 **2. Revegetation of Cropland**

17 In the dryland wheat areas, the larger disturbed areas will be cultivated as soon as  
18 possible after construction work is done. If it is the proper season for wheat planting and the  
19 disturbed area is within a field that is not intended to remain fallow, the area will be planted with  
20 a wheat variety selected by the landowner. Otherwise, cultivation and planting will occur on the  
21 same schedule as in surrounding fields. The certificate holder will reimburse landowners for the  
22 work if landowners prefer to perform the plowing and planting themselves.

#### 23 **3. Revegetation of Wildlife Habitat Areas**

24 The predominant wildlife habitat subtype that will be disturbed by facility construction is  
25 grassland. The seed mix used for revegetation in these areas will contain a mixture of species  
26 expected to perform well in the affected soils and including, as available, seed adapted to the  
27 local environment. The certificate holder will select a seed mix through consultation with the  
28 parcel landowner and the grazing right lessee, ODFW, the Oregon State University Extension  
29 Service, the Oregon Department of Agriculture, The Nature Conservancy and the Oregon  
30 Department of Energy (Department). The certificate holder shall use seed provided by a  
31 reputable supplier and complying with the Oregon Seed Law.

32 After construction activities are completed, disturbed areas will be evaluated to determine  
33 whether restoration seeding is needed. In some areas where existing vegetation has been crushed  
34 but not removed during construction, recovery is likely to occur in a reasonable time without  
35 intervention. Seeding will not be done in areas where the pre-construction condition was exposed  
36 rock, bare soil or sand that is unlikely to support vegetation.

37 Narrow areas of soil disturbance due to off-road trenching, off-road crane paths and other  
38 limited disturbance may be seeded and left without mulch. Hand seeding, rather than mechanical  
39 seeding, will be used in small areas where the use of planting equipment is likely to increase the  
40 area of disturbance. Larger disturbed areas will be seeded followed by application of weed-free

1 straw or other mulch to protect against erosion and preserve moisture. No-till methods, such as  
2 drilling or broadcast seeding, will be employed.

3 In the arid climate of the site, successful seeding is limited to mid-fall through very early  
4 spring. If seeding of large disturbance areas cannot be accomplished within this optimal seeding  
5 period within two months after construction disturbance, the areas will be mulched or otherwise  
6 treated to minimize erosion until seeding can be done in the fall.

### 7 **4. Weed control**

8 In the spring and early summer (approximately April through June), weeds commonly  
9 found on the site can be identified before they seed. After construction, all disturbed areas  
10 (except areas of exposed rock, bare soil and sand) will be evaluated annually in the spring for the  
11 presence of invasive weed species. The certificate holder shall implement weed control measures  
12 recommended by Gilliam County and Morrow County weed control authorities. Annual weed  
13 inspection and treatment of revegetation areas will be discontinued in areas that are determined  
14 to be successfully revegetated, but the certificate holder shall continue to implement a weed  
15 control program during facility operation, as required by Condition 38 of the site certificate.

## 16 **IV. Monitoring**

### 17 **1. Revegetation Record**

18 The certificate holder shall maintain a record of revegetation work for both cropland and  
19 wildlife habitat areas. In the record, the certificate holder shall include the date that construction  
20 activity was completed in the area to be restored, a description of the affected area (location,  
21 acres affected and pre-disturbance condition), the date that revegetation work began and a  
22 description of the work done within the affected area. The certificate shall update the  
23 revegetation records from time to time, as revegetation work occurs. The certificate holder shall  
24 provide copies of these records to the Department at the time of submitting the annual report  
25 required under the site certificate.

### 26 **2. Monitoring Procedures**

#### 27 Cropland

28 During the first growing season following planting of cropland previously disturbed by  
29 facility construction, the certificate holder shall consult with the landowners on soil compaction,  
30 construction-related erosion or poor crop growth in disturbed areas. The certificate holder may  
31 rely on the judgment of the landowner regarding any corrective measures needed.

#### 32 Wildlife Habitat Areas

33 The certificate holder shall monitor the revegetation of wildlife habitat areas as described  
34 in this section, unless the landowner has converted the area to a use inconsistent with the success  
35 criteria. The certificate holder shall employ a qualified investigator (an independent botanist or  
36 revegetation specialist) to examine all non-cropland revegetation areas to assess vegetation cover  
37 (species, structural stage, etc.) and progress toward meeting the success criteria described below  
38 in subsection (3). Within representative sample plots, the investigator will estimate the  
39 percentages of the area that are covered by bare soil, desirable native vegetation or invasive weed  
40 species. The investigator will qualitatively assess the degree of erosion at each site. The

1 investigator will compare the sample plots with representative reference plots of the same habitat  
2 category and subtype.

3 The investigator will survey at least 20 percent of the disturbed area. The investigator  
4 will select sample plots that are representative of all habitat subtypes disturbed. Sample plots  
5 must proportionally represent areas of light disturbance (crushed vegetation) and areas of heavier  
6 disturbance (scraped or heavily compacted soil). Reference plots will be selected from nearby  
7 undisturbed areas within the same habitat subtype and category. Reference plots should have  
8 similar slopes, soil depth and prevalence of rock outcrops as the sample plots to which they will  
9 be compared.

10 The investigator shall use the same reference and sample plots for every survey, unless  
11 the investigator finds that a plot is no longer suitable for survey purposes. If the investigator  
12 finds a plot is no longer suitable, the investigator will select a suitable replacement plot and  
13 report the reasons for the replacement to the certificate holder, the Department and ODFW.

14 Revegetation monitoring surveys will be conducted annually beginning one year after  
15 initial restoration seeding and continuing until there is sufficient evidence of progress for the  
16 Department to conclude that additional revegetation efforts in the area are not necessary.  
17 Thereafter, the restored areas will be surveyed at five-year intervals for the life of the facility.<sup>2</sup>

18 The investigator will report to the certificate holder, the Department and ODFW  
19 following each inspection. In the report, the investigator shall include an assessment of whether  
20 the revegetated areas are trending toward meeting the success criteria. The investigator will  
21 include in the report any remedial actions recommended. The investigator shall include a report  
22 on the success of weed control measures.

23 Within each revegetation area, the investigator shall evaluate the progress of habitat  
24 recovery in comparison to the reference area. The investigator shall evaluate the following site  
25 conditions (both within the revegetation area and within the reference area):

- 26 • Degree of erosion due to disturbance activities (high, moderate or low).
- 27 • Vegetation density.
- 28 • Relative proportion of desirable vegetation as determined by the average number  
29 of stems of desirable vegetation per square foot or by a visual scan of the area,  
30 noting overall recovery status.
- 31 • Species diversity of desirable vegetation.

### 32 **3. Success Criteria**

#### 33 Cropland

34 Cropland areas are successfully revegetated when the replanted areas achieve crop  
35 production comparable to adjacent non-disturbed cultivated areas. The certificate holder shall  
36 consult with the landowner or farmer to determine whether these areas have been successfully  
37 revegetated and shall report to the Department on the success of revegetation in these areas.

## Wildlife Habitat Areas

A wildlife habitat area is successfully revegetated when its habitat quality is equal to, or better than, the habitat quality of the reference area as measured by the site conditions listed above in subsection (2). When the Department finds that the condition of a revegetated wildlife habitat area satisfies the criteria for revegetation success, the Department will conclude that the certificate holder has met its restoration obligations for that area. If the Department finds that the landowner has converted a wildlife habitat area to a use that is inconsistent with the success criteria, the Department may conclude that the certificate holder has no further obligation to restore the area for wildlife habitat uses.

Revegetation will be considered successful when:

1. The percentage of vegetation cover by desirable native species in the sample plot is greater than or equal to the percentage of desirable native species cover in the reference plots.
2. The percentage of cover by invasive weed species in the sample plot is less than 10 percent; and
3. The percentage of bare soil in the sample plot is not greater than the percentage of bare soil in the reference plot, unless the percentage of desirable native species cover in the sample plot exceeds the percentage of desirable native species cover in the reference plots as described in #4 below.
4. If the percentage of desirable native species cover in the sample plot exceeds the percentage of desirable native species cover in the reference plots by 10 percent or more, then the percentage of bare soil in the sample plot may exceed the percentage of bare soil in the reference plot by up to 20 percent.

## **4. Remedial Action in Wildlife Habitat Areas**

After each monitoring visit, the certificate holder's qualified investigator shall report to the certificate holder regarding the revegetation progress of each wildlife habitat area. The investigator shall make recommendations to the certificate holder for reseeded or other remedial measures for areas that are not showing progress toward achieving revegetation success.

Indications that an area is not showing progress toward achieving revegetation success include emergence of comparatively few plants one year after disturbance or low vegetation cover in the second monitoring year compared to reference plots and little increase in vegetation between the first and second monitoring year.

The certificate holder shall take appropriate action to meet the objectives of this revegetation plan. If soil compaction is suspected as the reason for lack of progress, the compacted areas may be deep tilled or scarified to reduce compaction, followed by re-seeding. The certificate holder's qualified investigator shall assess the vegetation that has appeared in the disturbed area to determine specific recommendations for remediation.

On an annual basis as part of the annual report on the facility, the certificate holder shall report to the Department the investigator's recommendations and the remedial actions taken. The Department may require re-seeding or other remedial measures in those areas that do not meet the success criteria.

1           If a wildlife habitat area is damaged by wildfire, the certificate holder shall work with the  
2 landowner to restore the damaged area. The certificate holder shall report to the Department on  
3 the damage caused by wildfire and the cause of the fire, if known. The certificate holder shall  
4 continue to report on revegetation progress as described in this plan.

5           If an area is not trending toward meeting the success criteria by the fifth monitoring year  
6 (and has not been converted by the landowner to an inconsistent use), the certificate holder may  
7 conclude that revegetation of the area was unsuccessful and propose appropriate mitigation for  
8 the loss of habitat quality or quantity. The certificate holder shall carry out mitigation actions  
9 approved by the Department, subject to review by the Oregon Energy Facility Council (Council).

### 10 **V. Amendment of the Plan**

11           This Revegetation Plan may be amended from time to time by agreement of the  
12 certificate holder and the Council. Such amendments may be made without amendment of the  
13 site certificate. The Council authorizes the Department to agree to amendments to this plan. The  
14 Department shall notify the Council of all amendments, and the Council retains the authority to  
15 approve, reject or modify any amendment of this plan agreed to by the Department.

1 This plan describes wildlife monitoring that the certificate holder shall conduct during  
2 operation of Shepherds Flat Central (SFC).<sup>1</sup> The monitoring objectives are to determine whether  
3 the facility causes significant fatalities of birds and bats and to determine whether the facility  
4 results in a loss of habitat quality.

5 SFC consists of up to 116 wind turbines, two non-guyed meteorological (met) towers, a  
6 substation and other related or supporting facilities as described in the site certificate. The  
7 permanent facility components occupy a combined area of up to 72 acres.<sup>2</sup> The affected habitat  
8 lies within a micro-siting area of approximately 11,769 acres.

9 The certificate holder shall use experienced and properly trained personnel (the  
10 “investigators”) to conduct the monitoring required under this plan. The professional  
11 qualifications of the investigators are subject to approval by the Oregon Department of Energy  
12 (Department). For all components of this plan, the certificate holder shall hire independent third  
13 party investigators (not employees of the certificate holder) to perform monitoring tasks. The  
14 monitoring will be performed in a manner that minimizes agricultural crop loss and interference  
15 with agricultural and ranching activities.

16 The Wildlife Monitoring and Mitigation Plan for SFC has the following components:

17 1) Fatality monitoring program including:

- 18 a) Removal trials
- 19 b) Searcher efficiency trials
- 20 c) Fatality search protocol
- 21 d) Statistical analysis

22 2) Washington ground squirrel colony assessment

23 3) Raptor nest monitoring

24 4) Ongoing monitoring, reporting and handling of wildlife injuries and fatalities

25 4)5) Avian Collision Fatality Risk Mitigation (RFA2)

26 Based on the results of the monitoring programs, mitigation of significant impacts may be  
27 required. The selection of the mitigation actions should allow for flexibility in creating  
28 appropriate responses to monitoring results that cannot be known in advance. If the Department  
29 determines that mitigation is needed, the certificate holder shall propose appropriate mitigation  
30 actions to the Department and shall carry out mitigation actions approved by the Department,  
31 subject to review by the Oregon Energy Facility Council (Council).

## 1. Fatality Monitoring

### (a) Definitions and Methods

#### Seasons

This plan uses the following dates for defining seasons:

Season	Dates and Duration
Spring	March 16 to May 15 (2 months)
Summer	May 16 to August 15 (3 months)
Fall Migration	August 16 to October 31 (2 ½ months)
Winter	November 1 to March 15 (4 ½ months)

#### Schedule

The investigators shall perform fatality monitoring for two years for each phase of construction. For each phase of construction, the first monitoring year will begin one month after the beginning of commercial operation of that phase; the second monitoring year will begin directly following the first year.

In each monitoring year, the investigators shall conduct fatality monitoring searches at the rates of frequency shown below. Over the course of one monitoring year, the investigators will conduct 16 searches, as follows:

Season	Frequency
Spring	2 searches per month (4 searches)
Summer	1 search per month (3 searches)
Fall	2 searches per month (5 searches)
Winter	1 search per month (4 searches)

#### Search Plots

The investigators shall conduct fatality monitoring within search plots. The certificate holder, in consultation with the investigators and the Oregon Department of Fish and Wildlife (ODFW), shall select search plots based on a systematic sampling design that ensures that the selected search plots are representative of the habitat conditions in different parts of the site.

Each search plot will contain one turbine. Search plots will be circular. Circular search plots will be centered on the turbine location and will have a radius equal to the maximum blade tip height of the turbine contained within the plot. "Maximum blade tip height" is the turbine hub-height plus one-half the rotor diameter. The certificate holder shall provide maps of the search plots to the Department before beginning fatality monitoring at the facility. The investigators shall use the same search plots for each search conducted during a single monitoring year.

#### Sample Size

The sample size for fatality monitoring is the number of turbines searched per phase per monitoring year. For each phase of construction, the investigators shall search a representative sample of the turbines that are built in that phase, according to the following schedule:

1 If 50 to 116 turbines are built in a phase, the investigators shall search a different  
2 representative sample of 50 turbines in the second year, to the extent possible based on the total  
3 number of turbines built.

### 4 (b) Removal Trials

5 The objective of the removal trials is to estimate the length of time avian and bat  
6 carcasses remain in the search area. Estimates of carcass removal rates will be used to adjust  
7 carcass counts for removal bias. “Carcass removal” is the disappearance of a carcass from the  
8 search area due to predation, scavenging or other means such as farming activity.

9 The investigators shall conduct carcass removal trials within each of the seasons defined  
10 above during the years in which fatality monitoring occurs. For each trial, the investigators shall  
11 use 10 to 15 carcasses of small, medium and large-bodied species.<sup>3</sup> Trial carcasses shall be  
12 placed at least 1,000 feet from any search plots and distributed proportionately within habitat  
13 categories and subtypes similar to the search plots.

14 The investigators shall use game birds or other legal sources of avian species as test  
15 carcasses for the removal trials, and the investigators may use carcasses found in fatality  
16 monitoring searches. The investigators shall select species with the same coloration and size  
17 attributes as species found within the site boundary. If suitable trial carcasses are available, trials  
18 during the fall season will include several small brown birds to simulate bat carcasses. Legally  
19 obtained bat carcasses will be used if available.

20 Trial carcasses will be marked discreetly for recognition by searchers and other  
21 personnel. Carcasses will be placed in a variety of postures to simulate a range of conditions. For  
22 example, birds will be: 1) placed in an exposed posture (e.g., thrown over the shoulder), 2)  
23 hidden to simulate a crippled bird (e.g., placed beneath a shrub or tuft of grass) or 3) partially  
24 hidden. The planted carcasses will be located randomly within the carcass removal trial plots.  
25 Trial carcasses will be left at the location until the end of the carcass removal trial.

26 An approximate schedule for assessing removal status is once daily for the first 4 days,  
27 and on days 7, 10, 14, 21, 30 and 45. This schedule may be adjusted depending on actual carcass  
28 removal rates, weather conditions and coordination with the other survey work. The condition of  
29 scavenged carcasses will be documented during each assessment, and at the end of the trial all  
30 traces of the carcasses will be removed from the site. Scavenger or other activity could result in  
31 complete removal of all traces of a carcass in a location or distribution of feathers and carcass  
32 parts to several locations. This distribution will not constitute removal if evidence of the carcass  
33 remains within an area similar in size to a search plot and if the evidence would be discernable to  
34 a searcher during a normal survey.

35 Before beginning removal trials for the second year of fatality monitoring, the certificate  
36 holder shall report the results of the first year removal trials to the Department and ODFW. In the

1 report, the certificate holder shall analyze whether four removal trials per year, as described  
2 above, provides sufficient data to accurately estimate adjustment factors for carcass removal. The  
3 number of removal trials for the second year of fatality monitoring may be adjusted up or down,  
4 subject to the approval of the Department.

### 5 (c) Searcher Efficiency Trials

6 The objective of searcher efficiency trials is to estimate the percentage of bird and bat  
7 fatalities that searchers are able to find. The certificate holder shall conduct searcher efficiency  
8 trials on the fatality monitoring search plots in both grassland/shrub-steppe and cultivated  
9 agriculture habitat types. A pooled estimate of searcher efficiency will be used to adjust carcass  
10 counts for detection bias.

11 The investigators shall conduct searcher efficiency trials within each of the seasons  
12 defined above during the years in which the fatality monitoring occurs. Each trial will involve  
13 approximately 40 carcasses (approximately 160 carcasses per year). The searchers will not be  
14 notified of carcass placement or test dates. The investigators shall vary the number of trials per  
15 season and the number of carcasses per trial so that the searchers will not know the total number  
16 of trial carcasses being used in any trial.

17 For each trial, the investigators shall use small, medium and large-bodied species. The  
18 investigators shall use game birds or other legal sources of avian species as test carcasses for the  
19 efficiency trials, and the investigators may use carcasses found in fatality monitoring searches.  
20 The investigators shall select species with the same coloration and size attributes as species  
21 found within the site boundary. If suitable test carcasses are available, trials during the fall  
22 season will include several small brown birds to simulate bat carcasses. Legally obtained bat  
23 carcasses will be used if available. The investigators shall mark the test carcasses to differentiate  
24 them from other carcasses that might be found within the search plot and shall use methods  
25 similar to those used to mark removal test carcasses as long as the procedure is sufficiently  
26 discreet and does not increase carcass visibility.

27 The certificate holder shall distribute trial carcasses in varied habitat in rough proportion  
28 to the habitat types within the facility site. On the day of a standardized fatality monitoring  
29 search (described below) but before the beginning of the search, investigators will place  
30 efficiency trial carcasses randomly within search plots (one to three trial carcasses per search  
31 plot) within areas to be searched. If scavengers appear attracted by placement of carcasses, the  
32 carcasses will be distributed before dawn.

33 Efficiency trials will be spread over the entire season to incorporate effects of varying  
34 weather and vegetation growth. Carcasses will be placed in a variety of postures to simulate a  
35 range of conditions. For example, birds will be: 1) placed in an exposed posture (thrown over the  
36 shoulder), 2) hidden to simulate a crippled bird or 3) partially hidden.

37 The number and location of the efficiency trial carcasses found during the carcass search  
38 will be recorded. The number of efficiency trial carcasses available for detection during each  
39 trial will be determined immediately after the trial by the person responsible for distributing the  
40 carcasses. Following plot searches, all traces of test carcasses will be removed from the site.

41 If new searchers are brought into the search team, additional searcher efficiency trials  
42 will be conducted to ensure that detection rates incorporate searcher differences. The certificate

holder shall include a discussion of any changes in search personnel and any additional detection trials in the reporting required under Section ~~665~~ of this plan.

Before beginning searcher efficiency trials for the second year of fatality monitoring, the certificate holder shall report the results of the first year efficiency trials to the Department and ODFW. In the report, the certificate holder shall analyze whether the efficiency trials as described above provides sufficient data to accurately estimate adjustment factors for carcass removal. The number of removal trials for the second year of fatality monitoring may be adjusted up or down, subject to the approval of the Department.

### (d) Fatality Monitoring Search Protocol

The objective of fatality monitoring is to estimate the number of bird and bat fatalities that are attributable to facility operation as an indicator of the impact of the facility on habitat quality. The goal of bird and bat fatality monitoring is to estimate fatality rates and associated variances. The certificate holder shall conduct fatality monitoring using standardized carcass searches according to the schedule described above.

Personnel trained in proper search techniques (“the searchers”) will conduct the carcass searches by walking parallel transects approximately 20 feet apart within the search plots. A searcher will walk at a rate of approximately 45 to 60 meters per minute along each transect searching both sides out to three meters for casualties. Search area and speed may be adjusted by habitat type after evaluation of the first searcher efficiency trial.

Searchers shall flag all avian or bat carcasses discovered. Carcasses are defined as a complete carcass or body part, 10 or more feathers, or three or more primary feathers in one location. When parts of carcasses and feathers from the same species are found within a search plot, searchers shall make note of the relative positions and assess whether or not these are from the same fatality.

All carcasses (avian and bat) found during the standardized carcass searches will be photographed, recorded and labeled with a unique number. Searchers shall make note of the nearest two or three structures (turbine, power pole, fence, building or overhead line) and the approximate distance from the carcass to these structures. The species and age of the carcass will be determined when possible. Searchers shall make note of the extent to which the carcass is intact and an estimation of time since death. Searchers shall describe all evidence that might assist in determination of cause of death, such as evidence of electrocution, vehicular strike, wire strike, predation or disease, will be described. When assessment of the carcass is complete, all traces of it will be removed from the site.

Each carcass will be bagged and frozen for future reference and possible necropsy. A copy of the data sheet for each carcass will be kept with the carcass at all times. For each carcass found, searchers will record species, sex and age when possible, date and time collected, location, condition (e.g., intact, scavenged, feather spot) and any comments that may indicate cause of death. Searchers will photograph each carcass as found and will map the find on a detailed map of the search area showing the location of the wind turbines and associated facilities. The certificate holder shall coordinate collection of state endangered, threatened, sensitive or other state protected species with ODFW. The certificate holder shall coordinate collection of federally-listed endangered or threatened species and Migratory Bird Treaty Act

1 protected avian species with the U.S. Fish and Wildlife Service (USFWS). The certificate holder  
2 shall obtain appropriate collection permits from ODFW and USFWS.

3 The investigators shall calculate fatality rates using the statistical methods described in  
4 Section (f), except that the investigators may use different notation or methods that are  
5 mathematically equivalent with prior approval of the Department. In making these calculations,  
6 the investigators may exclude carcass data from the first search of each turbine (to eliminate  
7 possible counting of carcasses that were present before the turbine was operating).

8 The investigators shall estimate the number of avian and bat fatalities attributable to  
9 operation of the facility based on the number of avian and bat fatalities found at the facility site.  
10 All carcasses located within areas surveyed, regardless of species, will be recorded and, if  
11 possible, a cause of death determined based on blind necropsy results. If a different cause of  
12 death is not apparent, the fatality will be attributed to facility operation. The total number of  
13 avian and bat fatalities will be estimated by adjusting for removal and searcher efficiency bias.

14 On an annual basis, the certificate holder shall report an estimate of fatalities in eight  
15 categories: 1) all birds, 2) small birds, 3) large birds, 4) raptors, 5) grassland birds, 6) nocturnal  
16 migrants, 7) State Sensitive Species listed under OAR 635-100-0040 and 8) bats. The certificate  
17 holder shall report annual fatality rates on both a per-MW and per-turbine basis.

### 18 (e) Incidental Finds and Injured Birds

19 The searchers might discover carcasses incidental to formal carcass searches (e.g., while  
20 driving within the project area). For each incidentally discovered carcass, the searcher shall  
21 identify, photograph, record data and collect the carcass as would be done for carcasses within  
22 the formal search sample during scheduled searches. If the incidentally discovered carcass is  
23 found within a formal search plot, the fatality data will be included in the calculation of fatality  
24 rates. If the incidentally discovered carcass is found outside a formal search plot, the data will be  
25 reported separately. The certificate holder shall coordinate collection of incidentally discovered  
26 state endangered, threatened, sensitive or other state protected species with ODFW. The  
27 certificate holder shall coordinate collection of incidentally discovered federally-listed  
28 endangered or threatened species and Migratory Bird Treaty Act protected avian species with the  
29 USFWS.

30 The certificate holder shall develop and follow a protocol for handling injured birds. Any  
31 injured native birds found on the facility site will be carefully captured by a trained project  
32 biologist or technician and transported to a qualified rehabilitation specialist approved by the  
33 Department.<sup>4</sup> The certificate holder shall pay costs, if any, charged for time and expenses related  
34 to care and rehabilitation of injured native birds found on the site, unless the cause of injury is  
35 clearly demonstrated to be unrelated to the facility operations.

### 1 (f) Statistical Methods for Fatality Estimates<sup>5</sup>

2 The estimate of the total number of wind facility-related fatalities is based on:

- 3 (1) The observed number of carcasses found during standardized searches during the  
4 two monitoring years for which the cause of death is attributed to the facility.<sup>6</sup>
- 5 (2) Searcher efficiency expressed as the proportion of planted carcasses found by  
6 searchers.
- 7 (3) Removal rates expressed as the estimated average probability a carcass is expected  
8 to remain in the study area and be available for detection by the searchers during  
9 the entire survey period.

### 10 Definition of Variables

11 The following variables are used in the equations below:

### Observed Number of Carcasses

The estimated average number of carcasses ( $\bar{c}$ ) observed per turbine per year is:

$$\bar{c} = \frac{\sum_{i=1}^n c_i}{k} . \quad (1)$$

### Estimation of Carcass Removal

Estimates of carcass removal are used to adjust carcass counts for removal bias. Mean carcass removal time ( $\bar{t}$ ) is the average length of time a carcass remains at the site before it is removed:

$$\bar{t} = \frac{\sum_{i=1}^s t_i}{s - s_c} . \quad (2)$$

This estimator is the maximum likelihood estimator assuming the removal times follow an exponential distribution and there is right-censoring of data. Any trial carcasses still remaining at 40 days are collected, yielding censored observations at 40 days. If all trial carcasses are removed before the end of the trial, then  $s_c$  is 0, and  $\bar{t}$  is just the arithmetic average of the removal times. Removal rates will be estimated by carcass size (small and large), habitat type and season.

### Estimation of Observer Detection Rates

Observer detection rates (i.e., searcher efficiency rates) are expressed as  $p$ , the proportion of trial carcasses that are detected by searchers. Observer detection rates will be estimated by carcass size, habitat type and season.

### Estimation of Facility-Related Fatality Rates

The estimated per turbine annual fatality rate ( $m_t$ ) is calculated by:

$$m_t = \frac{\bar{c}}{\hat{\pi}} , \quad (3)$$

where  $\hat{\pi}$  includes adjustments for both carcass removal (from scavenging and other means) and observer detection bias assuming that the carcass removal times  $t_i$  follow an exponential distribution. Under these assumptions, this detection probability is estimated by:

$$\hat{\pi} = \frac{\bar{t} \cdot p}{I} \cdot \left[ \frac{\exp\left(\frac{I}{\bar{t}}\right) - 1}{\exp\left(\frac{I}{\bar{t}}\right) - 1 + p} \right] . \quad (4)$$

The estimated per MW annual fatality rate ( $m$ ) is calculated by:

$$m = \frac{m_t}{C} . \quad (5)$$

1 The final reported estimates of  $m$ , associated standard errors and 90% confidence  
2 intervals will be calculated using bootstrapping (Manly 1997). Bootstrapping is a computer  
3 simulation technique that is useful for calculating point estimates, variances and confidence  
4 intervals for complicated test statistics. For each iteration of the bootstrap, the plots will be  
5 sampled with replacement, trial carcasses will be sampled with replacement and  $\bar{c}$ ,  $\bar{t}$ ,  $p$ ,  $\hat{\pi}$  and  
6  $m$  will be calculated. A total of 5,000 bootstrap iterations will be used. The reported estimates  
7 will be the means of the 5,000 bootstrap estimates. The standard deviation of the bootstrap  
8 estimates is the estimated standard error. The lower 5<sup>th</sup> and upper 95<sup>th</sup> percentiles of the 5000  
9 bootstrap estimates are estimates of the lower limit and upper limit of 90% confidence intervals.

### 10 Nocturnal Migrant and Bat Fatalities

11 Differences in observed nocturnal migrant and bat fatality rates for lit turbines, unlit  
12 turbines that are adjacent to lit turbines and unlit turbines that are not adjacent to lit turbines will  
13 be compared graphically and statistically.

### 14 (g) Mitigation

15 The certificate holder shall use a worst-case analysis to resolve any uncertainty in the  
16 results and to determine whether the data indicate that additional mitigation should be  
17 considered. The Department may require additional, targeted monitoring if the data indicate the  
18 potential for significant impacts that cannot be addressed by worst-case analysis and appropriate  
19 mitigation.

20 Mitigation may be appropriate if fatality rates exceed a “threshold of concern.”<sup>7</sup> For the  
21 purpose of determining whether a threshold has been exceeded, the certificate holder shall  
22 calculate the average annual fatality rates for species groups after two years of monitoring. Based  
23 on current knowledge of the species that are likely to use the habitat in the area of the facility, the  
24 following thresholds apply to SFC:

1 If the data show that a threshold of concern for a species group has been exceeded, the  
2 certificate holder shall implement additional mitigation if the Department determines that  
3 mitigation is appropriate based on analysis of the data, consultation with ODFW and  
4 consideration of any other significant information available at the time. In addition, the  
5 Department may determine that mitigation is appropriate if fatality rates for individual avian or  
6 bat species (especially State Sensitive Species) are higher than expected and at a level of  
7 biological concern. If the Department determines that mitigation is appropriate, the certificate  
8 holder, in consultation with the Department and ODFW, shall propose mitigation measures  
9 designed to benefit the affected species. The certificate holder shall implement mitigation as  
10 approved by the Department, subject to review by the Council. The Department may recommend  
11 additional, targeted data collection if the need for mitigation is unclear based on the information  
12 available at the time. The certificate holder shall implement such data collection as approved by  
13 the Council.

14 Mitigation should be designed to benefit the affected species group. Mitigation may  
15 include, but is not limited to, protection of nesting habitat for the affected group of native species  
16 through a conservation easement or similar agreement. Tracts of land that are intact and  
17 functional for wildlife are preferable to degraded habitat areas. Preference should be given to  
18 protection of land that would otherwise be subject to development or use that would diminish the  
19 wildlife value of the land. In addition, mitigation measures might include: enhancement of a  
20 protected tract that is degraded by weed removal and control; increasing the diversity of native  
21 grasses and forbs; planting sagebrush or other shrubs; constructing and maintaining artificial nest  
22 structures for raptors; improving wildfire response; and conducting or making a contribution to  
23 research that will aid in understanding more about the affected species and its conservation needs  
24 in the region.

### 25 (h) Additional Mitigation

26 Two years of monitoring showed an exceedance of the threshold of concern for the raptor  
27 group. The Department determined that mitigation is appropriate. Certificate holder proposed  
28 mitigation measures, and consulted with the Department and ODFW with respect to their design  
29 and implementation. Therefore certificate holder shall:

- 30 • Amend the SFC Habitat Mitigation Plan to include tree planting and monitoring.

- 1 • Install bird flight diverters, pole-to-pole, on the transmission line segments adjacent to  
2 turbines 372 and 332. The diverters shall be of the same type and at the same spacing as  
3 those installed at other location in the facility.
- 4 • Contribute \$1,000 annually to the Rowena Wildlife Clinic (or equivalent rehabilitation  
5 facility approved by the Department and ODFW). Such contributions shall continue for  
6 the life of the facility.

## 7 **2. Washington Ground Squirrel Assessment**

8 A qualified professional biologist (investigator) will assess the status of that portion of  
9 the Washington ground squirrel (WGS) colony located within the site boundary.<sup>8</sup> The colony  
10 located on-site represents a small outpost of the larger complex off-site. It may expand or  
11 contract over the survey years as rainfall and vegetation affect the total population of the  
12 complex. There should be sufficient data collected before facility components are installed in the  
13 colony's vicinity for the investigator to assess natural colony fluctuation.

14 The investigator shall assess the status of the WGS colony when the squirrels are active  
15 (approximately mid-March through May) beginning in the first active period after the effective  
16 date of the site certificate for SFC. The colony will be assessed annually thereafter through the  
17 second year after the turbines closest to the WGS colony become commercially operational.

18 During each assessment, the investigator shall monitor WGS activity to determine the  
19 extent of the on-site colony and estimate the number of squirrels present. The investigator shall  
20 examine the surroundings for evidence of project-caused conditions that might increase erosion  
21 or result in a decline in vegetation quality and adversely affect the colony.

## 22 **3. Raptor Nest Monitoring**

23 The objectives of raptor nest surveys are: (1) to estimate the size of the local breeding  
24 populations of raptor species that nest on the ground or aboveground in trees or other  
25 aboveground nest locations in the vicinity of the facility; and (2) to determine whether operation  
26 of the facility results in a reduction of nesting activity or nesting success in the local populations  
27 of the following raptor species: Swainson's hawk, golden eagle, ferruginous hawk and burrowing  
28 owl.

29 The certificate holder shall conduct short-term and long-term monitoring. The certificate  
30 holder's qualified investigators will use aerial and ground surveys to evaluate nest success by  
31 gathering data on active nests, on nests with young and on young fledged. The investigators will  
32 analyze the data as described in Section 3(c) and will share the data with state and federal  
33 biologists.

### 34 (a) Short-Term Monitoring

35 Short-term monitoring will be done in two monitoring seasons. The first monitoring  
36 season will be in the first raptor nesting season after completion of construction of SFC. The

1 second monitoring season will be in the fourth year after construction is completed. The  
2 investigators will analyze two years of data after the second monitoring season.

### 3 Survey Protocol for Raptor Species that Nest Aboveground

4 During each monitoring season, the investigators will conduct a thorough ground survey  
5 for raptor nests in late May or early June and additional surveys as described in this section. The  
6 survey area is the area within the SFC site and a 2-mile buffer around the site. All nests  
7 discovered during pre-construction surveys and any nests discovered during post-construction  
8 surveys, whether active or inactive, will be given identification numbers. Nest locations will be  
9 recorded on U.S. Geological Survey 7.5-minute quadrangle maps. Global positioning system  
10 coordinates will be recorded for each nest. Locations of inactive nests will be recorded because  
11 they could become occupied during future years.

12 Determining nest *occupancy* will likely require at least two visits to each nest. For  
13 occupied nests, the certificate holder will determine nesting *success* by a minimum of one  
14 ground visit to determine species, number of young and young fledged. “Nesting success” means  
15 that the young have successfully fledged (the young are independent of the core nest site). Nests  
16 that cannot be monitored due to the landowner denying access will be checked from a distance  
17 where feasible.

### 18 Survey Protocol for Burrowing Owls

19 The investigators will monitor burrowing owl nests according to the following protocol.  
20 The investigators will monitor all nests discovered during pre-construction surveys and any  
21 additional burrowing owl nest sites that are discovered during any wildlife monitoring tasks  
22 conducted under this plan. All nests will be given identification numbers. Nest locations will be  
23 recorded on U.S. Geological Survey 7.5-minute quadrangle maps. Global positioning system  
24 coordinates will be recorded for each nest site. Coordinates for ancillary burrows used by one  
25 nesting pair or a group of nesting pairs will also be recorded. Locations of inactive nests will be  
26 recorded because they could become occupied during future years.

27 For occupied nests, the certificate holder will determine nesting *success* by a minimum of  
28 one ground visit to determine species, number of young and young fledged. “Nesting success”  
29 means that the young have successfully fledged (the young may or may not be independent of  
30 the core nest site). Three visits to the nest sites may be necessary to determine outcome. Nests  
31 that cannot be monitored due to the landowner denying access will be checked from a distance  
32 where feasible.

### 33 (b) Long-Term Monitoring

34 In addition to the two years of post-construction raptor nest surveys described above, the  
35 certificate holder will conduct long-term raptor nest surveys at five-year intervals for the life of  
36 the facility.<sup>9</sup> Investigators will conduct the first long-term raptor nest survey in the raptor nesting  
37 season of the ninth year after construction is completed and will repeat the survey at five-year  
38 intervals thereafter. In conducting long-term surveys, the investigators will follow the same  
39 survey protocols as described above in Section 3(a) unless the investigators propose alternative  
40 protocols that are approved by the Department. In developing an alternative protocol, the

1 investigators will consult with ODFW. The investigators will analyze the data after each year of  
2 long-term raptor nest surveys.

### 3 (c) Analysis

4 The investigators will analyze the raptor nesting data to determine whether a reduction in  
5 either nesting success or nest use has occurred in the survey area. If the analysis indicates a  
6 reduction in nesting success or nest use by Swainson's hawks, golden eagles, ferruginous hawks  
7 or burrowing owls, then the certificate holder will propose appropriate mitigation for the affected  
8 species as described in Section 3(d) and will implement mitigation as approved by the  
9 Department, subject to review by the Council

10 Any reduction in nesting success or nest use could be due to operation of SFC or some  
11 other cause. The investigators will attribute the reduction to operation of SFC unless the  
12 investigators demonstrate, and the Department agrees, that the reduction was due to a different  
13 cause. At a minimum, if the analysis shows that a Swainson's hawk, golden eagle, ferruginous  
14 hawk or burrowing owl has abandoned a nest territory within the facility site or within ½ mile of  
15 the facility site or has not fledged any young over two successive surveys within that same area,  
16 the investigators will assume the abandonment or unsuccessful fledging is due to operation of the  
17 facility unless another cause can be demonstrated convincingly.

18 Given the low raptor nesting densities in the area, statistical power to detect a relationship  
19 between distance from a wind turbine and nesting parameters (e.g., number of fledglings per  
20 reproductive pair) will be very low. Therefore, impacts may have to be judged based on trends in  
21 the data, results from other wind energy facility monitoring studies and literature on what is  
22 known regarding the populations in the region.

### 23 (d) Mitigation

24 The certificate holder will propose mitigation for the affected species in consultation with  
25 the Department and ODFW and will implement mitigation as approved by the Council. In  
26 proposing appropriate mitigation, the certificate holder will advise the Department if any other  
27 wind project in the area is obligated to provide mitigation for a reduction in raptor nesting  
28 success at the same nest site. Mitigation should be designed to benefit the affected species or  
29 contribute to overall scientific knowledge and understanding of what causes nest abandonment or  
30 nest failure. Mitigation may be designed to proceed in phases over several years. It may include,  
31 but is not limited to, additional raptor nest monitoring, protection of natural nest sites from  
32 human disturbance or cattle activity (preferably within the general area of the facility) or  
33 participation in research projects designed to improve scientific understanding of the needs of the  
34 affected species.

## 35 4. Ongoing Reporting and Handling of Wildlife Injuries and Fatalities

36 The certificate holder will implement an ongoing monitoring program for avian and bat  
37 casualties found during operation of the facility. The certificate holder will train facility  
38 personnel in the methods and practices needed to carry out this program. Facility personnel shall  
39 monitor the areas around all facility structures that may present a collision risk to avian and bat  
40 species, including turbine towers, meteorological towers, aboveground transmission lines, the  
41 substation and the field workshop. The monitoring program will include initial response,  
42 handling and reporting of bird and bat carcasses discovered incidental to maintenance operations

1 (“incidental finds”). Maintenance personnel will follow the certificate holder’s protocol for  
2 handling injured birds as described in Section 1(d).

3 All avian and bat carcasses discovered by maintenance personnel will be photographed  
4 and data will be recorded as would be done for carcasses within the formal search sample during  
5 scheduled searches as described in Section 1(d). Maintenance personnel will notify a project  
6 biologist of incidental finds. The project biologist must be a qualified independent professional  
7 biologist who is not an employee of the certificate holder. The project biologist (or the project  
8 biologist’s experienced wildlife technician) will collect the carcass or will instruct maintenance  
9 personnel to have an on-site carcass handling permittee collect the carcass. The certificate  
10 holder’s on-site carcass handling permittee must be a person who is listed on state and federal  
11 scientific or salvage collection permits and who is available to process (collect) the find on the  
12 day it is discovered. The find must be processed on the same day as it is discovered. The  
13 certificate holder shall coordinate collection of state endangered, threatened, sensitive or other  
14 state protected species with ODFW. The certificate holder shall coordinate collection of  
15 federally-listed endangered or threatened species and Migratory Bird Treaty Act protected avian  
16 species with the USFWS.

17 During the years in which fatality monitoring occurs, if there are incidental finds outside  
18 the search plots for the fatality monitoring searches, the data will be reported separately from  
19 fatality monitoring data. Data on incidental finds within search plots will be included in the  
20 calculation of fatality rates.

21 The Department may determine that mitigation is appropriate if avian or bat fatalities are  
22 higher than expected and at a level of biological concern. If the Department determines that  
23 mitigation is appropriate, the certificate holder, in consultation with the Department and ODFW,  
24 shall propose mitigation measures designed to benefit the affected species. The certificate holder  
25 shall implement mitigation as approved by the Department, subject to review by the Council.

### 26 **5. Avian Collision Fatality Risk Mitigation**

27 To address potential indirect impacts of bird and bat collision fatality risk, the certificate  
28 holder shall implement the following avian collision fatality risk mitigation:

29 Within 1-year following completion of the O&M demonstration activity for wind  
30 turbines 368 and 370, as approved in the Final Order on RFA2, the certificate holder shall  
31 coordinate with ODOE in consultation with ODFW to determine an appropriate financial  
32 contribution or level of participation in a research project designed to improve scientific  
33 understanding of larger turbine components on birds and bats. As an alternative, the certificate  
34 holder may coordinate with ODOE in consultation with ODFW to determine an appropriate  
35 financial contribution to be remitted to the Rowena Wildlife Clinic (or equivalent rehabilitation  
36 facility approved by ODOE and ODFW).

### 37 **6. Data Reporting**

38 The certificate holder will report wildlife monitoring data and analysis to the Department.  
39 The certificate holder shall notify USFWS and ODFW immediately if any federal or state  
40 endangered or threatened species are killed or injured on the facility site. The certificate holder  
41 shall report fatality monitoring program data, WGS colony assessment information, raptor nest  
42 monitoring data and data on avian and bat casualties found by facility personnel. The certificate

1 holder may include the reporting of wildlife monitoring data, analysis, and additional mitigation  
2 measures in the annual report required under OAR 345-026-0080 or submit this information as a  
3 separate document at the same time the annual report is submitted. In addition, the certificate  
4 holder shall provide to the Department any data or record generated by the investigators in  
5 carrying out this monitoring plan upon request by the Department.

### 6 **7. Amendment of the Plan**

7 This Wildlife Monitoring and Mitigation Plan may be amended from time to time by  
8 agreement of the certificate holder and the Council. Such amendments may be made without  
9 amendment of the site certificate. The Council authorizes the Department to agree to  
10 amendments to this plan and to mitigation actions that may be required under this plan. The  
11 Department shall notify the Council of all amendments and mitigation actions, and the Council  
12 retains the authority to approve, reject or modify any amendment of this plan or mitigation action  
13 agreed to by the Department.

1 **I. Introduction**

2 This plan describes methods and standards for preservation and enhancement of an area  
3 of land near Shepherds Flat Central (SFC) to mitigate for the impacts of the facility on wildlife  
4 habitat.<sup>1</sup> This plan addresses mitigation for both the permanent impacts of facility components  
5 and the temporal impacts of facility construction. The certificate holder shall protect and enhance  
6 the mitigation area as described in this plan. This plan specifies habitat enhancement actions and  
7 monitoring procedures to evaluate the success of those actions. This plan does not address  
8 additional mitigation that might be required under the SFC *Wildlife Monitoring and Mitigation*  
9 *Plan*.

10 **II. Description of the Impacts Addressed by the Plan**

11 The SFC footprint (area covered by permanent facility components) occupies areas of  
12 Category 2 grassland, Category 3 grassland and shrub-steppe vegetation, and other habitat  
13 subtypes in Categories 3, 4, 5 and 6. In compliance with Condition 86 of the site certificate, the  
14 certificate holder must avoid “all Category 1 habitat and those areas of Category 2 habitat shown  
15 on the “ODFW-2” Figures 1 through 12 in the Shepherds Flat Wind Farm Application.” The  
16 final design of the facility complied with this requirement. Affected areas of Category 2 habitat  
17 had been classified as Category 3 or 4 habitat at the time of the Shepherds Flat Wind Farm  
18 application in 2007 but were reclassified as Category 2 in April 2010 during the pre-construction  
19 habitat survey. The habitat quality of these reclassified areas had improved due to the passage of  
20 time and the absence of wildfire.

21 In addition to the areas affected by the SFC footprint, construction temporarily affected  
22 areas of Category 2, 3, 4, 5 and 6 habitat. After disturbance, the recovery of temporarily  
23 disturbed Category 2, 3 and 4 grassland areas to a mature stage might take two to four years;  
24 recovery of shrub-steppe vegetation might take ten to 30 years to reach maximum height and  
25 vertical branching. During the period needed to achieve full recovery of these habitat subtypes,  
26 habitat quality is temporarily degraded until recovery is successful (temporal impact).

27 **III. Calculation of the Size of the Mitigation Area**

28 The habitat mitigation area (HMA) must be large enough to achieve, within a reasonable  
29 time, the habitat mitigation goals and standards of the Oregon Department of Fish and Wildlife  
30 (ODFW) described in OAR 635-415-0025. For the footprint impacts, the mitigation area must  
31 include two acres for every one acre of Category 2 habitat affected (a 2:1 ratio) and one acre for  
32 every acre of impact to Category 3 and 4 habitat (a 1:1 ratio). The 2:1 ratio for Category 2 is  
33 intended to meet the ODFW goals of “no net loss” of Category 2 habitat and “net benefit” of  
34 habitat quantity. The ODFW goals require mitigation to achieve “no net loss” of habitat in  
35 Categories 3 and 4 (acre-for-acre mitigation). For Category 5 impacts, mitigation is achieved by  
36 a “net benefit in habitat quantity or quality.” To mitigate for Category 5 impacts, ODFW  
37 recommends that “the applicant enhance at least ½ acre of Category 3, 4, or 5 habitat” for every

1 acre of impact on Category 5 habitat.<sup>2</sup> For Category 6, mitigation is achieved by actions that minimize direct habitat loss and avoid impacts to off-site habitat.

To address the temporal loss of habitat quality during the recovery of Category 3 shrub-steppe-sage (SS-S) habitat temporarily disturbed during construction of SFC (outside the footprint), the HMA must include ½ acre for every acre of Category 3 SS-S habitat affected (a 0.5:1 ratio). To address the temporal loss of habitat quality during the recovery of Category 3 shrub-steppe-purshia (SS-P) habitat temporarily disturbed during construction, the HMA must include ½ acre for every acre of SS-P habitat affected. If the revegetation success criteria are not met in the affected areas of temporarily disturbed SS-S and SS-P habitat, as determined under the SFC Revegetation Plan, then the Council may require the certificate holder to provide additional mitigation.

Before beginning construction of the facility, the certificate holder provided to the Oregon Department of Energy (Department) and ODFW maps showing the final design configuration of the facility and a table showing the acres of permanent impacts and construction area impacts on habitat (by category, habitat types and habitat subtypes).<sup>3</sup> Based on the final design habitat assessment, SFC has had the following footprint impacts:

Habitat Category	Footprint Impact (acres)
Category 2	4.7
Category 3	23.2
Category 4	16.1
Category 5	0.8
Category 6	23.2
Total area	68.0

The overall minimum size of the HMA, the area of impact within each affected habitat category and the corresponding mitigation area requirements are shown below, based on the final design of SFC:

Category 2

Footprint impacts: 4.7 acres  
Temporal impacts to SS-S: 0.8 acres  
Mitigation area: (4.7 acres x 2) + (0.8 acres x 0.5) = 9.8 acres

Category 3

Footprint impacts: 23.2 acres  
Temporal impacts to SS-S and SS-P: 18.2 acres  
Mitigation area requirement: 23.2 acres + (18.2 acres x 0.5) = 32.3 acres

Category 4

Footprint impacts: 16.1 acres  
Mitigation area requirement: 16.1 acres

2            Footprint impacts: 0.8 acres

3            Mitigation area requirement: 0.8 acres x 0.5 = 0.4 acres of Category 3, 4 or 5 habitat <sup>4</sup>

4            **Total mitigation area (rounded to nearest whole acre): 59 acres**

5            Before beginning construction, the certificate holder determined the final size and  
6 boundaries of the mitigation area in consultation with ODFW and the affected landowners and  
7 with the approval of the Department. The certificate holder acquired the legal right to create,  
8 maintain and protect the HMA for the life of the facility by means of a conservation easement  
9 and provided a copy of the documentation to the Department.<sup>5</sup>

10          **IV. Description of the Mitigation Area**

11            The ODFW standards require mitigation for Category 2 and Category 3 impacts to be “in  
12 proximity” to SFC, and the HMA must be located where habitat protection and enhancement are  
13 feasible consistent with this plan.<sup>6</sup> The applicant for the Shepherds Flat Wind Farm identified a  
14 435-acre parcel in proximity to SFC but outside the site boundary. The baseline habitat  
15 characteristics of the 435-acre parcel are described in Section IV.4(b)(F) of the *Final Order on*  
16 *the Application for the Shepherds Flat Wind Farm* (July 25, 2008). This parcel, however, was  
17 not available to the certificate holder when construction of SFC was ready to begin. The  
18 certificate holder identified a replacement parcel, and the Department approved the parcel.  
19 ODFW determined that the replacement parcel was suitable for mitigation.<sup>7</sup> The HMA for SFC  
20 is contiguous with the HMA for Shepherds Flat North and is bordered on the north by lands held  
21 by The Nature Conservancy.<sup>8</sup> It is located east of Highway 74 north of Cecil. The HMA for SFC  
22 consists of approximately 70 acres containing grasslands, sage steppe, dry wash and ranch  
23 roads.<sup>9</sup> There are no trees and no observed raptor nests within the HMA. The terrain consists of  
24 ridges separated by ravines perpendicular to and sloping down towards Schoolhouse Canyon,  
25 which runs through the center of the HMA. The HMA includes approximately 18 acres of  
26 Category 2 grassland and SS-S habitat and 25 acres of Category 3 grassland and SS-S habitat.  
27 The landowner has used the area for cattle grazing.

**V. Habitat Enhancement Actions**

The certificate holder shall implement the habitat enhancement actions described in this plan. The objectives of the plan are to protect the habitat within the HMA for the life of the facility and to enhance the baseline condition of the habitat to meet the ODFW mitigation goals.

To achieve “no net loss” of habitat quantity or quality to mitigate for the permanent impacts of SFC in Category 2, 3 and 4 habitats and to achieve a “net benefit in habitat quantity or quality” to mitigate for the permanent impacts in Category 2 and 5 habitat, the certificate holder shall protect the habitat within the HMA for the life of the facility and shall implement the enhancement actions.<sup>10</sup> The certificate holder began the enhancement actions described in this section after the final design configuration of SFC was known and the location, size and boundaries of the HMA were determined and approved by the Department. Specific enhancement actions are described below.

1. Modification of Livestock Grazing Practices. The certificate holder shall restrict grazing within the habitat mitigation area. Limited livestock grazing in the mitigation area will enable recovery of native bunchgrass and sagebrush in areas where past grazing has occurred, resulting in better vegetative structure and complexity for wildlife. Reduced livestock grazing may be used as a vegetation management tool, limited to the period from November 15 to May 15.
2. Weed Control and Area Seeding. The certificate holder shall implement a weed control program. Under the weed control program, the certificate holder shall monitor the mitigation area to locate weed infestations. The certificate holder shall continue weed control monitoring, as needed, for the life of the facility. As needed, the certificate holder shall use appropriate methods to control weeds. Weed control on the mitigation site will reduce the spread of noxious weeds within the habitat mitigation area and on any nearby grassland, CRP or cultivated agricultural land. Weed control will promote the growth of desirable native vegetation. Where substantial areas of soil (greater than 100 ft<sup>2</sup>) are left bare from weed control activities, the certificate holder shall hand-seed the area in the appropriate time of year with a mixture containing native grass and shrub seeds. The certificate holder may consider weeds to be successfully controlled when weed clusters have been eradicated or reduced to a non-competing level. Weeds may be controlled with herbicides or hand-pulling. The certificate holder shall notify the landowner of the specific chemicals to be used on the site and when spraying will occur. To protect locations where young desirable forbs may be growing, spot-spraying may be used instead of total area spraying.
3. Fire Control. The certificate holder shall implement a fire control plan for wildfire suppression within the HMA. The certificate holder shall provide a copy of the fire control plan to the Department before starting habitat enhancement actions. The certificate holder shall include in the plan appropriate fire prevention measures, methods to detect fires that occur and a protocol for fire response and suppression. The certificate holder shall maintain fire control for the life of the facility. If wildfire damages any part of the HMA during the life of the facility, the certificate holder

1 shall assess the extent of the damage and implement appropriate actions to restore  
2 habitat quality in the damaged area.

- 3 4. Erosion Control. The certificate holder shall monitor the HMA to locate sites at which  
4 past livestock grazing or vegetation loss has caused soil erosion. As needed, the  
5 certificate holder shall control erosion by a combination of sediment barriers (such as  
6 hay bales, mulch or native rock) and seeding the affected area with a mixture  
7 containing native grasses and shrub seeds. The certificate holder may consider  
8 erosion control to be successful when eroded areas can support vegetation and no  
9 indications of new soil loss are evident.
- 10 5. Habitat Protection. For the life of the facility, the certificate holder shall restrict uses  
11 of the HMA that are inconsistent with achieving the habitat mitigation goals.
- 12 6. Litter Removal. To protect wildlife from wind-blown litter, the certificate holder shall  
13 monitor the Highway 74 Oregon Trail Wayside on a monthly basis and shall remove  
14 litter from the wayside area and areas within the HMA.
- 15 7. Nesting Habitat: In order to increase raptor nesting opportunities, the certificate  
16 holder shall plant at least five juniper trees, each at least three feet in height, in  
17 locations proposed by the certificate holder and approved by ODFW. Tree site  
18 selection will be based upon criteria as approved by the Department in consultation  
19 with ODFW. Plantings may be within or outside of the HMA. Within 30-days of  
20 approval of the amended HMP, the certificate holder shall provide a schedule to the  
21 Department specifying mitigation implementation dates such as timing of site  
22 identification, site/criteria evaluation, agency review and approval, tree purchase and  
23 planting, and monitoring.

24 **VI. Monitoring**

25 **1. Monitoring Procedures**

26 The certificate holder shall hire a qualified investigator (an independent botanist, wildlife  
27 biologist or revegetation specialist) to conduct a comprehensive monitoring program for the  
28 HMA. The purpose of monitoring is to evaluate the protection of habitat quality, the results of  
29 enhancement actions and the use of the area by avian and mammal species, especially during the  
30 wildlife breeding season. The investigator shall conduct HMA monitoring beginning in the first  
31 year after enhancement actions begin and continuing for the life of the facility. The investigator  
32 shall visit the site as necessary to carry out the following monitoring procedures:

- 33 1) Annually assess the general quality of planted junipers and vegetation cover (species,  
34 structural stage, etc).
- 35 2) Annually assess progress toward meeting the success criteria.
- 36 3) Annually record environmental factors (such as precipitation at the time of surveys  
37 and precipitation levels for the year).
- 38 4) Annually record any wildfire that occurs within the HMA and any remedial actions  
39 taken to restore habitat quality in the damaged area.
- 40 5) Annually assess the success of the weed control (including area seeding) and erosion  
41 control programs and recommend remedial action, if needed.

- 1           6) Assess the recovery of native bunchgrass and natural recruitment of sagebrush  
2           resulting from removal of livestock grazing pressure by comparing the quality of  
3           bunchgrass and sagebrush cover at the time of each monitoring visit with the quality  
4           observed in previous monitoring visits and as observed when the HMA was first  
5           established. The investigator shall establish photo plots of naturally recovering  
6           sagebrush and native bunchgrass during the first year following the beginning of  
7           enhancement actions. The investigator shall take comparison photos in the first year  
8           and every two years thereafter until desirable vegetation has achieved mature stature.  
9           The investigator shall determine the extent of successful recovery of native  
10          bunchgrass based on measurable indicators (such as signs of more abundant seed  
11          production) and shall report on the progress of recovery within in the monitoring  
12          plots. The investigator shall report on the timing and extent of any livestock grazing  
13          that has occurred within the mitigation area since the previous monitoring visit.
- 14          7) Between April 21 and May 21 beginning in the first spring season after the beginning  
15          of construction of SFC, conduct an area search survey of avian species. An “area  
16          search” survey consists of recording all birds seen or heard in specific areas (for  
17          example, square or circular plots that are 5 to 10 acres in size). Area searches will be  
18          conducted during morning hours on days with low or no wind. The investigator shall  
19          determine the number searches and the number of search areas in consultation with  
20          ODFW. The investigator shall repeat the area search survey every five years during  
21          the life of the facility.
- 22          8) Beginning in the first year after the beginning of construction of SFC and repeating  
23          every five years during the life of the facility, the investigator shall record  
24          observations of special status plant and wildlife species (federal or State threatened or  
25          endangered species and State sensitive species) during appropriate seasons for  
26          detection of these species.

27 **2. Reporting**

28           The certificate holder shall report the investigator’s findings and recommendations  
29           regarding the monitoring of the mitigation area to the Department and to ODFW on an annual  
30           basis. The certificate holder shall describe all habitat mitigation actions carried out during the  
31           reporting year and all additional work performed based on recommendations of the qualified  
32           investigator. The report shall include an evaluation of mitigation success, based on the success  
33           criteria described below, and a description of the methods used to perform the evaluation. The  
34           report to the Department may be included as part of the annual report on SFC that is required  
35           under Condition 21 of the site certificate.

36 **3. Success Criteria**

37           Mitigation of the permanent and temporal habitat impacts of the facility may be  
38           considered successful if the certificate holder protects and enhances sufficient habitat within the  
39           mitigation area to meet the ODFW goals of no net loss of habitat in Categories 2, 3 and 4 and a  
40           “net benefit” for impacts to habitat in Categories 2 and 5. The certificate holder must protect the  
41           quantity and quality of habitat within the HMA for the life of the facility. The mitigation goals  
42           are successfully achieved when the HMA contains a sufficient quantity of habitat in each  
43           category to meet the mitigation area requirements calculated under Section III. The certificate

1 holder may count habitat of higher value toward meeting the acreage requirements for Category  
2 3, 4 and 5 habitat.

3 The certificate holder may demonstrate enhancement of habitat quality based on evidence  
4 of indicators such as increased avian use by a diversity of species, more abundant seed  
5 production of desirable native bunchgrass, natural recruitment of sagebrush and successful weed  
6 control.

7 The success of Habitat Enhancement Action 7, tree planting, will be evidenced by the  
8 presence of five living trees, at least one mile apart, ten years after planting, in locations  
9 proposed by the certificate holder and approved by ODFW.

10 If the certificate holder cannot demonstrate that the HMA is trending toward meeting the  
11 success criteria within five years after the date construction of SFC begins, the certificate holder  
12 shall propose remedial action. The Department may require supplemental planting or other  
13 corrective measures, which may include increasing the size of the HMA.

### 14 **VII. Amendment of the Plan**

15 This Habitat Mitigation Plan may be amended from time to time by agreement of the  
16 certificate holder and the Oregon Energy Facility Siting Council (“Council”). Such amendments  
17 may be made without amendment of the site certificate. The Council authorizes the Department  
18 to agree to amendments to this plan. The Department shall notify the Council of all amendments,  
19 and the Council retains the authority to approve, reject or modify any amendment of this plan  
20 agreed to by the Department.
