#### STAFF RECOMMENDATION

The Department recommends Council adopt the Proposed Order as the Final Order and grant an amended site certificate for Shepherds Flat Central wind facility.

At the January 24, 2020 Council meeting, the Department will present to Council a summary of the RFA3, the draft proposed order (DPO), comments received on the DPO, and the Department's proposed order. Please note that the proposed order will be prepared after the close of the public comment period and provided to Council electronically, prior to the January 23-24 Council meeting. The DPO is attached to this staff report as Attachment 1.

#### **BACKGROUND**

Shepherds Flat Central (facility) is an operating wind energy generation facility approved by the Council in 2008 with 116 wind turbines and a maximum generating capacity of 290 megawatts. The facility is located within a site boundary of approximately 11,769 acres in Gilliam and Morrow counties.

The certificate holder, South Hurlburt Wind, LLC (certificate holder), a wholly owned subsidiary of Caithness Energy, LLC, a subsidiary of Caithness Equities Corporation, submitted a complete Request for Amendment 3 (amendment request or RFA3) on December 31, 2019. The amendment request seeks Council's approval to repower 114 of the 116 existing wind turbines. The remaining two wind turbines, turbines 368 and 370, have previously been repowered, as approved by Council under RFA2. The repowering of RFA3 would include removing and replacing the wind turbine blades, with longer blades, consequently lowering minimum

aboveground blade tip clearance from 25 to 21.5 meters. The repowering would also include the replacement and modification to associated machinery including the rotor upgrade (replacing the hub casting), modification to existing nacelles roof, and installation of a new gearbox and bedplate in the nacelle. The longer turbine blades would increase the blade-tip height and rotor diameter for turbines, however, they would remain within the parameters already allowed by the site certificate.

On December 31, 2019, the Oregon Department of Energy (Department) issued its draft proposed order (DPO) recommending that Council approve RFA3. On the same day, the Department also issued a notice of a public comment period on the amendment request and DPO. The comment period extends from December 31, 2019 through January 20, 2020, which represents a 20-day comment period. This amendment request is being processed under Council's Type B review process, and therefore does not include a public hearing on the draft proposed order nor an opportunity to request a contested case proceeding on the proposed order.

During the Department's review of the amendment request (prior to the issuance of the DPO), the Department received comments from the following reviewing agencies which are included in Attachment B of the DPO. The DPO is included as Attachment A to this staff report.

- The Oregon Department of Fish and Wildlife (ODFW) Recommended two years of fatality monitoring upon completion of the proposed RFA3 facility repower.
- The Oregon Department of Aviation (ODA) Recommended that a Notice of Proposed Construction or Alteration be submitted to the Federal Aviation Administration (FAA), and to notify both ODA and ODOE of the response from the FAA.
- The Gilliam County Planning Department Recommended a pre-construction meeting between the Gilliam County Road Master and the Certificate Holder. Additionally, the Gilliam County Planning Department encouraged the Department to review existing conditions (particularly those that include "words and phrases about construction...[and/or] 'during construction'"), clarifying that the proposed RFA3 facility repower "is in fact a type of construction."

As of the issuance of this staff report, no comments on the DPO of RFA3 have been received. Any written comments received during the comment period will be transmitted to Council electronically, prior to the January 23-24 Council meeting. All comments will also be included in an attachment (Attachment C) to the proposed order, which will be prepared and released after the close of the public comment period.

At the January 23-24, 2020 Council meeting, the Department will present to Council a summary of the RFA3, the DPO, comments received on the DPO, and the Department's proposed order which will be prepared after the close of the public comment period and provided to Council electronically, prior to the January 23-24 Council meeting.

### PROPOSED FACILITY MODIFICATIONS

Pursuant to OAR 345-027-0365, the DPO addresses each of the Council standards, and comments received on the record during the completeness review phase, and recommends that Council find that the facility, with proposed modifications, would comply with, or based on compliance with existing and recommended amended site certificate conditions, each of the Council standards.

As presented in the DPO, the Department does not recommend any changes in conditions between the existing Site Certificate and the DPO on RFA2 for the following standards and applicable rules. As such, these standards are not further addressed in this staff report. However, the Department has conducted a full review of these standards, which can be found in the respective sections of the DPO.

- Organizational Expertise
- Land Use
  - The Department concluded, in coordination with both the Gilliam County and Morrow County Planning Departments, that the proposed facility modifications of RFA3 would continue to comply with the requirements of the existing conditional use permits, and that the proposed facility modifications would not require an amended conditional use permit from either of the counties.
- Protected Areas
- Retirement and Financial Assurance
- Threatened and Endangered Species
- Scenic Resources
- Historic, Cultural and Archeological Resources
- Recreation
- Siting Standards for Transmission Lines
- Removal-Fill Law
- Water Rights

Based on the scope of the requested amendment, the DPO includes analysis and findings and recommended new or amended site certificate conditions related to the following standards:

## **Division 22 Standards**

- General Standard of Review
  - Staff recommends Council adopt new Site Certificate Conditions 108 and 109 to grant a construction commencement and completion deadlines for the proposed RFA3 facility repower activities, based upon three years following the amended site certificate execution date and an additional three years following date of construction commencement. (Page 14 of the DPO)
- Structural Standard
  - Staff recommends Council adopt new Site Certificate Condition 110 to require the certificate holder to implement any necessary mitigation and remediation

- measures, or operational timing recommendations, if identified in the forthcoming foundation upright analysis. (Page 20 of the DPO)
- Staff recommends Council amend Site Certificate Condition 62 to require an inspection of all turbine and turbine tower components within 6 months of being repowered. (Page 20 of the DPO)

#### Soil Protection

Staff recommends Council amend Site Certificate Condition 73 to clarify that the
requirements of Condition 73 (ensuring that an Oregon Department of
Environmental Quality issued 1200-C National Pollutant Discharge Elimination
System permit is obtained prior to construction and that erosion control
measures are implemented in accordance with the Erosion and Sediment
Control Plan (ESCP), if determined to be necessary) would continue to apply to
the proposed RFA3 facility repower activities. (Page 22 of the DPO)

#### • Fish and Wildlife Habitat

- Staff recommends Council adopt new Site Certificate Condition 111 to require
  the certificate holder to coordinate with the Gilliam County Weed Department
  and the Morrow County Weed Control Department, and submit to the
  Department a specific Roadway Weed Control Plan. (Page 32 of the DPO)
- Staff recommends Council adopt new Site Certificate Condition 112, relating to revegetation and weed control measures that apply specifically to the proposed RFA3 facility repower disturbance areas, both prior to and following completion of the RFA3 facility repower activities. (Page 32 of the DPO)
- Staff recommends Council adopt new Site Certificate Condition 113 to minimize potential disturbance impacts to state-sensitive species. (Page 33 of the DPO)
- Staff recommends Council adopt new Site Certificate Condition 114, in response to ODFW recommendations, requiring the certificate holder to conduct a bird and bat fatality monitoring study be for two years following completion of the facility repowering activities. (Page 35 of the DPO)

#### Public Services

 Staff recommends Council amend Site Certificate Condition 67 to require the certificate holder to provide the Department executed road use agreements with both Gilliam and Morrow County, in an effort to account for the Departments role in condition compliance. (Page 38 of the DPO)

#### Waste Minimization

 Staff recommends Council adopt new Site Certificate Condition 115 to ensure the certificate holder minimizes waste generation consistent with Council's standard. (Page 40 of the DPO)

# Division 24 Standards

- Public Health and Safety Standards for Wind Energy Facilities
  - Staff recommends Council amend Site Certificate Condition 26 to change the minimum blade tip clearance for the repowered turbines from 25 meters (82 feet) to 21.5 meters (70.5 feet), and to remove from the condition a limitation on the megawatt output of the facility. (Page 42 of the DPO)
  - Staff recommends Council adopt new Site Certificate Condition 116 to require the certificate holder to submit a Notice of Proposed Construction and Alteration to the FAA and ODA, prior to RFA3 facility repower activities. (Page 43 of the DPO)

# Other Applicable Regulatory Requirements Under Council Jurisdiction

- Noise Control Regulations
  - Staff recommends Council adopt new Site Certificate Condition 117 to verify the repowered turbines ongoing compliance with the applicable State noise regulations and requirements. (Page 51 of the DPO)

### RECOMMENDED COUNCIL ACTION

The Department recommends Council conclude that RFA3, with staff proposed conditions, complies with all applicable standards and that Council adopt the Proposed Order as the final order and grant an amended site certificate.
