[5:30 p.m.] Obsidian Solar Center, Draft Proposed Order Public Hearing (Public Hearing) The proposed Obsidian Solar Center facility includes approximately 400 megawatts of solar photovoltaic power generation equipment and its related or supporting facilities, occupying up to 3,921 acres in north Lake County, near Christmas Valley, Oregon. The applicant is Obsidian Renewables, LLC.
 - 1. Proposed Facility Overview: Kellen Tardaewether, Senior Siting Analyst will provide a brief overview of the proposed facility and the procedural history for the Application for Site Certificate.
 - 2. Hearing Officer Process Overview: Joe Allen, Senior Administrative Law Judge, Oregon Office of Administrative Hearings and Council-appointed hearing officer will outline the procedural steps for the hearing as provided in the Oregon Administrative Rules.
