- C. Council Review of Amended Wildlife Mitigation and Monitoring Plans for Wheatridge Renewable Energy Facility I and Wheatridge Renewable Energy Facility II (Action Items) – Sarah Esterson, Senior Siting Policy Analyst. The Council will receive a presentation from staff (continued from the presentation provided at the July 22, 2020 Council meeting) on certificate holder requests to modify the survey methods and use a different statistical analytical model for the post-construction bird and bat fatality monitoring study required under the Wildlife Monitoring and Mitigation Plan (WMMP). Council may approve, modify or reject the WMMP amendment requests.
- D. Initiation of Protected Areas, Scenic Resources, and Recreation Rulemaking (Action Item) Christopher Clark, Rules Coordinator. Council will consider staff's recommendation to initiate rulemaking proceedings to develop proposed revisions to the Council's Protected Areas, Scenic Resources, and Recreation Standards and associated rules.
- **E. Biennial Fee Update (Action Item)** Sisily Fleming, Siting Fiscal Analyst. The Council will consider staff's recommended fee schedule for 2021-2022.
