Facility Overview

Certificate Holder:

Boardman Solar Energy LLC

Certificate Holder Parent Company:

Invenergy Solar Development LLC; subsidiary of Invenergy LLC

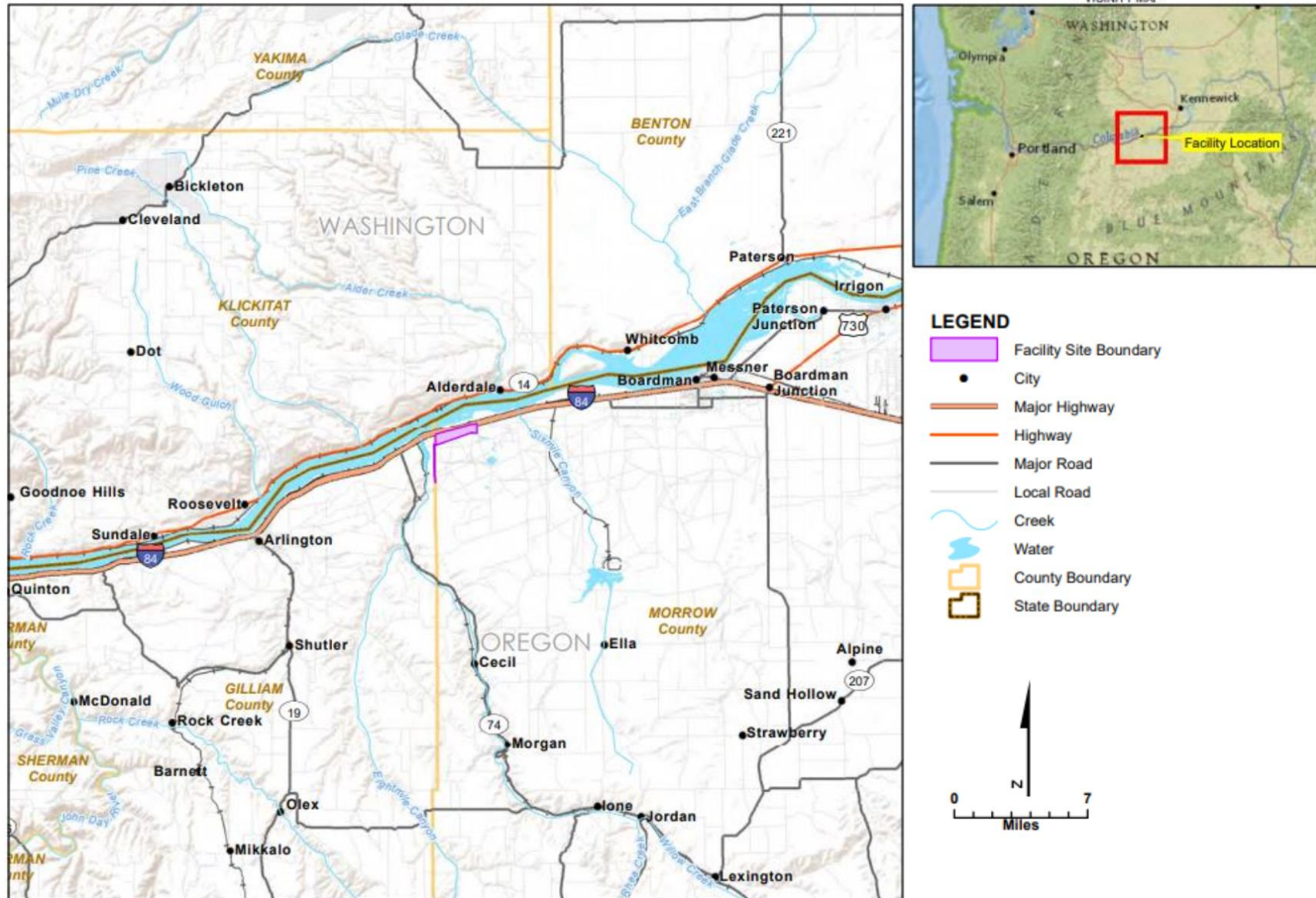
Type of Facility:

Solar photovoltaic energy generation facility with a peak generating capacity of 75 MW

Relating or Supporting Facilities:

- Underground Electrical Collection System
- Substation, Control House and Generator Step-up Transformer
- 115 kilovolt (kV) Transmission Line (approximately 2.1 miles long) and Private Service Road
- Point of Interconnection (POI)
- Operations and Maintenance (O&M) Building
- Private Access Road
- Service Roads, Gates and Security Fence
- Additional Temporary Construction Areas

Facility Site/Site Boundary Location 1 of 2



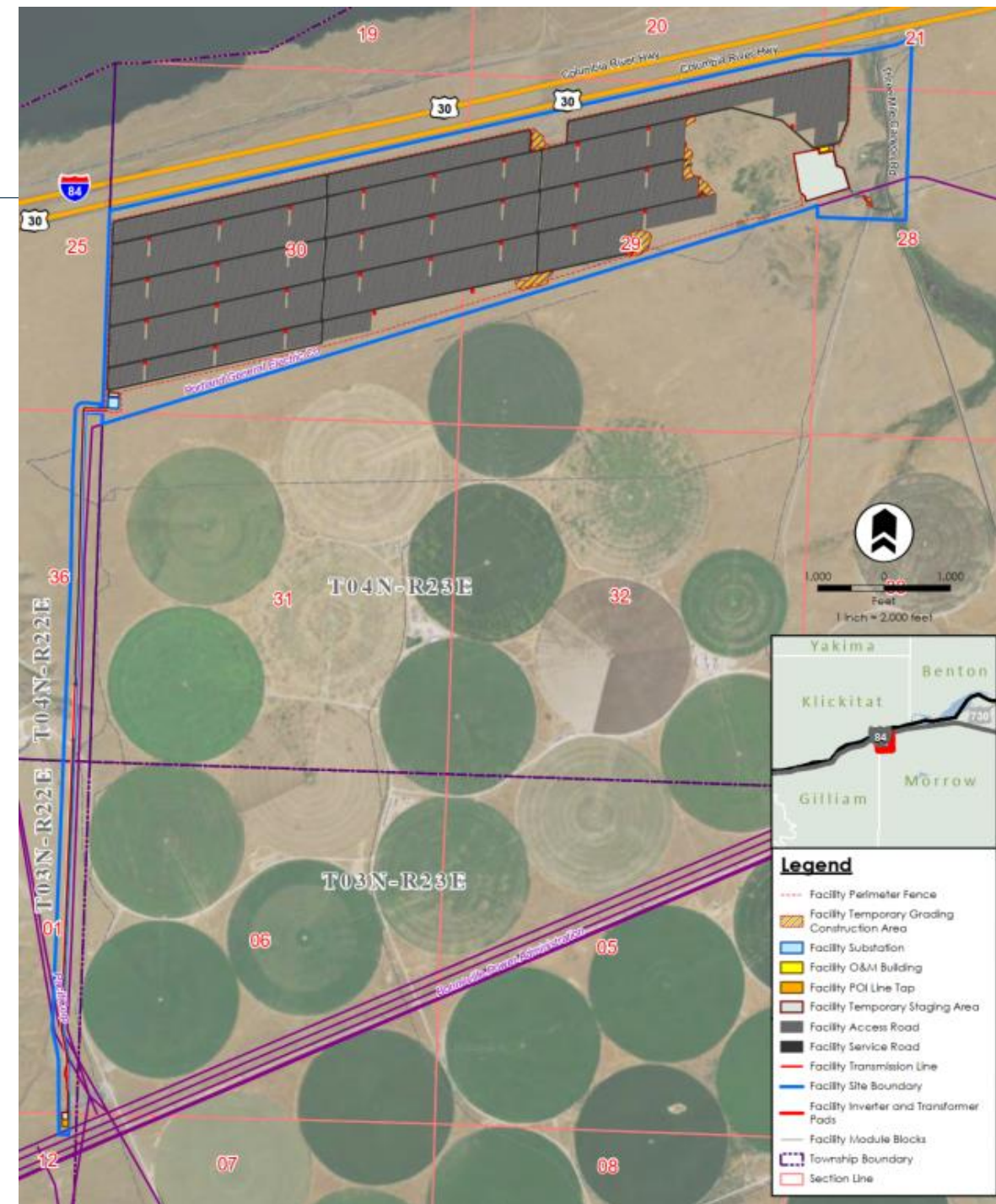
Facility Site/Site Boundary Location (2 of 2)

Site Boundary

- Contains approximately 798 acres
- Private Land in Gilliam and Morrow counties. The solar energy generation components of the facility will be located in Morrow County, and the 115-kV transmission line connecting the energy facility to the grid will be located within Gilliam County.

Site Certificate History

- Site Certificate effective February 23, 2018



RFA1 – Requested Modifications

- Requests the authorization to extend the deadlines for beginning and completing construction of the facility by three years. The proposed change would extend the construction commencement deadline from February 23, 2021 to February 23, 2024. There will be no physical alterations to the approved facility.

Overview of Comments received:

Julia Pommert: Opposition to extension of construction deadlines because of immediate need for renewable energy; House Bill 2021.

ODA: Mitigation for glare impacts to local airports – specifically the Arlington Municipal Airport in Gilliam County, and the Boardman Airport in Morrow County .

Morrow Co.: Amendment to Conditional Use Permit (CUP) – if site certificate is amended; Zoning permit per Taxlot within the project boundary; and coordination between certificate holder and Morrow County Public Works Director on securing a Road Use Agreement.

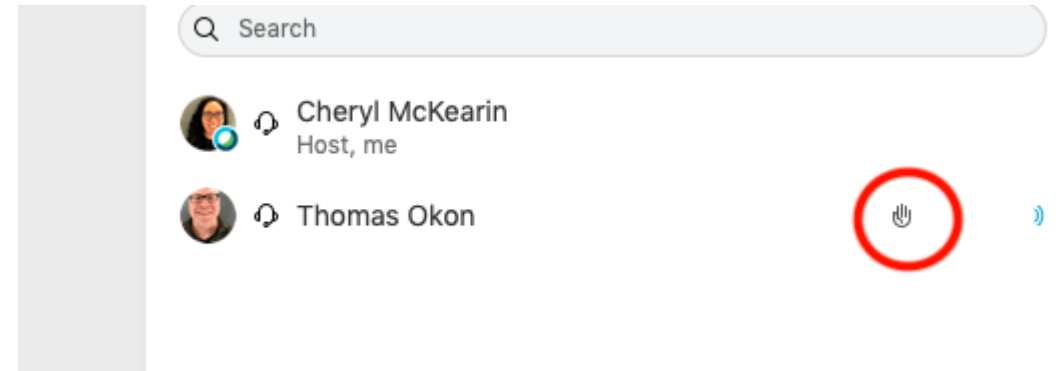

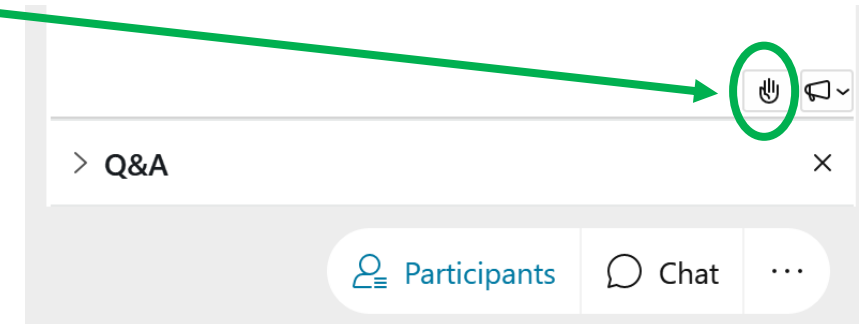
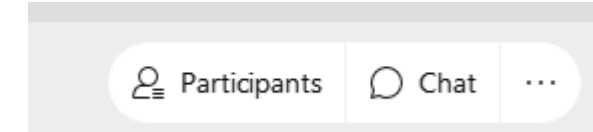

Retirement and Financial Assurance Standard Overview Part 2

Overview

- Overview of the Standard: What does it require?
- Decommissioning Estimate: How is it developed?
- Finalization of the Amount: How/why is the value adjusted throughout the process (ASC/RFA, precon, operations]?

Application of the Standard

The standard requires that Council, in part:

- Review a proposed decommissioning estimate
 - Determine whether estimate is sufficient for restoration (useful/nonhazardous)
- Determine if long-term monitoring (site contamination) is necessary

Mandatory Site Certificate Conditions

The following conditions must be imposed in all site certificates:

- Certificate holder must submit a bond or letter of credit acceptable to Council prior to construction; maintain bond or letter of credit until facility retirement [OAR 345-025-0006(8)]
- Certificate holder must submit a proposed retirement plan for Council approval within 2 years after permanent cessation of construction or operation, and retire the facility according to the plan [OAR 345-025-0006(9)]
- Authorize use of bond or letter of credit by ODOE to retire facility, if Council finds certificate holder failed to meet its obligation to retire the facility [OAR 345-025-0006(16)]

Decommissioning Cost Estimates

Based on:

- Applicant/certificate holder identified tasks and actions
- Unit costs of materials, equipment rates, wage/labor rates
- Contractor insurance, profit and other contingencies
- Description and justification of methods and assumptions
- ODOE Added Contingencies
 - Performance Bond, Project Management and Future Development Contingencies

Decommissioning Cost Estimates

Decommissioning Cost Estimates - Adjustments

- Inflation (to present value at preconstruction; annually during operation)
- Built Facility (based on final number of facility components)
- Additional Considerations (periodic review?)
- Applicant/Certificate Holder Proposals (power purchase agreement = reduced amount; scrap value = reduced amount)
