- E. Stateline Wind Project, Proposed Order on Request for Amendment 7 of the Site Certificate (Action Item) Chase McVeigh-Walker, Senior Siting Analyst. Council will review the Proposed Order on Request for Amendment 7 (RFA7) of the Stateline Wind Project Site Certificate and will either adopt, modify or reject the Proposed Order as the Final Order. RFA7 seeks Council approval to amend a condition to allow a lower minimum aboveground blade-tip clearance and higher hub height for Vansycle II wind turbines, if repowered.
