Well Springs Solar Facility

Notice of Intent and Public Informational Meeting

Summary

Notice Date:

February 4, 2026

Proposed Facility:

A proposed solar power generating facility located on approximately 7,365 acres (11.5 sq. miles) of private land zoned for exclusive farm use. The proposed facility would include up to 750 megawatts (MW) of generation capacity, up to 500 MW of battery storage, and other related or supporting facilities including an up to 14-mile 230 kilovolt (kV) overhead transmission line.

Proposed Facility Location:

Morrow County, approximately 5 miles northwest of Lone.

Applicant:

Well Springs Solar LLC (applicant), a subsidiary of MN8 Energy Development Company LLC (parent company).

Notice of Intent:

On December 22, 2025, the applicant submitted a Notice of Intent (NOI) to submit an Application for Site Certificate (ASC) to the Energy Facility Siting Council (EFSC or Council). The Oregon Department of Energy (ODOE or Department) is staff to EFSC and conducts review of the NOI and ASC.

Public Comment Period and Informational Meeting:

The public comment period on the NOI is from February 4 to March 26, 2026. **Comments must be received by 5:00 pm Pacific Time (PT) on March 26, 2026**, to be considered in the development of the Project Order. More information about how to submit comments is provided below.

The Department will host a public informational meeting on the NOI to provide additional opportunities for the public to learn about the proposed facility and the state siting review process, provide written or oral comments, and ask questions.

The public information meeting is *not* a public hearing and will not include public testimony or on the record public comments. Opportunity for written or oral testimony will be provided at a later date – during the draft proposed order (DPO) public comment period and public hearing – following issuance of the DPO as described below. This informational meeting will be recorded and posted on the Department’s project webpage after the meeting.

Description of the Proposed Facility:

Energy Facility

- Up to 750 MW generating capacity solar facility constructed in 2 or more phases
- 197 Inverters and Transformers

Related or Supporting Facilities

- Up to 500 MW of battery energy storage
- Up to 14 miles of 230-kilovolt (KV) overhead transmission line along one of five alternative routes
- Operations & Maintenance Building(s)
- 34.5 kV Collection System
- Up to two Collector substation(s)
- Site service and access roads
- Perimeter fencing and gates
- Temporary construction and laydown areas.

Location of Proposed Facility:

The proposed facility would be located on 7,365 acres of privately owned land zoned for Exclusive Farm Use located approximately 5 miles northwest of Lone, in Morrow County.

EFSC Review Process:

The proposed facility would include a solar power generation facility located on over 3,840 acres of land and therefore is an energy facility subject to EFSC jurisdiction under the definition in ORS 469.300(11). As such, the proposed facility must receive approval from EFSC for a site certificate prior to construction.

The EFSC review is a consolidated, comprehensive permitting process. The applicant must demonstrate that the proposed facility meets all applicable EFSC standards established under Oregon Revised Statute (ORS) 469.501 and set forth in Oregon Administrative Rule (OAR) chapter 345, divisions 22 and 24, as well as all other applicable Oregon statutes, rules and standards.

ASC Process Overview:

Notice of Intent:

On December 22, 2026, the Department received an NOI to file an ASC for the proposed facility.

Submitting the NOI is the first step in the process of obtaining a site certificate. The NOI includes information about the site and characteristics of the proposed facility and discusses potential impacts from construction and operation of the proposed facility.

Land Use Standard:

The applicant may choose to meet the Council's Land Use standard, OAR 345-022-0030, by obtaining land use approval from the affected local governments (ORS 469.504(1)(a)) or by seeking a determination of compliance from Council (ORS 469.504(1)(b)). In the NOI, the applicant has indicated that it intends to seek a determination from Council under ORS 469.504(1)(b). If the applicant chooses to obtain local land use approval later in the process, any person interested in land use issues should participate in the affected local governments' land use processes if they are not yet complete.

Submission of Comments on the NOI:

This Notice initiates the public comment period on the NOI. Comments are encouraged to help the Department and the applicant identify issues and concerns early in the process. **Comments must be received by 5:00 pm PT on March 26, 2026**, to be considered in the development of the Project Order. Choose "Well Springs Solar Facility" from the drop-down menu. Click "Next" and follow the instructions on the screen. You will receive an email confirmation after submitting your comment.
3. Orally during the informational meeting. If using Webex or telephone, additional instructions will be provided at the meeting. Please note that individual commentors may be limited to 7 minutes. However, the time may be decreased (or increased) based on the number of commentors.
4. Hand Delivered at the address listed above or during the public meeting.

Please note: Comment submission does not register your contact information to receive future notices. All comments submitted to ODOE may be disclosed to the public, subject to Oregon Public Records Laws (ORS Chapter 192). Public comments are made available via the systems described in this Notice.

Project Order

Based on the Department's review of the NOI and all comments received during the NOI comment timeframe, the Department will issue a Project Order establishing the state and local standards

and criteria that must be met for Council to issue a site certificate.

Preliminary Application for Site Certificate

An applicant has two years from the date of submitting the NOI to submit their preliminary application for site certificate (pASC). The applicant indicates that it intends to submit the pASC in Q1 2026.

During this phase, the Department, along with applicable state agencies, local governments and tribal governments will review the pASC to ensure it is complete, and request additional information, if necessary.

Complete Application

An application for site certificate (ASC) is complete when the Department finds that the applicant has submitted information adequate for Council to make findings or impose conditions on all applicable Council standards.

This phase includes another Public Notice and public informational meeting. However, there is no public comment timeframe associated with this phase.

Draft Proposed Order

The DPO contains the Department's initial recommendation to Council, the final decision maker, on whether each applicable standard is met. The DPO will include staff's analysis of the ASC as well as comments received from state agencies, local governments, and tribal governments. The DPO will include recommended findings of facts, conclusions of law and site certificate conditions of approval.

Issuance of the DPO will initiate a public comment period. In addition to the written public comment period, there will be an opportunity for oral comments at one or more public hearings to be held in the vicinity of the proposed facility. In order to preserve your right to request to participate in the contested case proceeding and

any subsequent appeal of the Council's decision, you must comment either orally at the public hearing or in writing during the comment period on the DPO.

Following the conclusion of the comment period, Council will review the DPO, all submitted comments, any applicant responses to comments, and will provide their comments to the Department.

Proposed Order

Taking into consideration all the comments received, applicant responses, and Council's comments, the Department will issue a Proposed Order, staff's second recommendation to Council. Council will appoint a Hearing Officer to conduct a contested case proceeding on the Proposed Order.

Contested Case

The purpose of the contested case proceeding is for an impartial hearing officer to evaluate properly raised issues and make recommendations to Council on those issues. Only people who commented on the DPO may request to participate in the contested case proceeding.

Final Order

Following a contested case proceeding, Council shall issue a Final Order either approving or denying the ASC for the proposed facility.
