EFSC meeting agenda item: Jordan Cove Energy Project application for exemption.

### Application process to date:

The Oregon Department of Energy, staff to the Energy Facility Siting Council, received an Application for Exemption from a Site Certificate from Jordan Cove Energy Project L.P. ("Jordan Cove LNG") for a high efficiency co-generation energy facility on June 22, 2018.

On Wednesday, September 12, 2018, ODOE staff received a letter from Jordan Cove LNG (see below) indicating its intention to submit an amended application for a Site Certificate exemption, and requesting that the scheduled agenda item be removed from the September Energy Facility Siting Council meeting. As there were no other items on the Council's September 27-28 agenda, the meeting has been cancelled.

### Description of the process going forward:

Once ODOE receives Jordan Cove LNG's amended application for exemption, the Department will

issue a public notice establishing new time frames associated with the review of the application for exemption. These time frames will include another completeness review by ODOE staff, and a further opportunity for public review of and comment on the amended application for exemption.

### Location of Proposed Facility

The proposed energy generating components of the LNG terminal would be located in the northeast portion of the terminal site, which is proposed to be located on the North Spit of Coos Bay, Oregon approximately 3,800 feet north of the city limits of North Bend, Oregon.

### Receipt of this Notice

Please note that you may be receiving this notice for one or more of the following reasons:

1. You have signed up via GovDelivery or by contacting the Department to receive notices related to all EFSC projects.
2. You previously signed up to receive notices related to the South Dunes Power Plant. The South Dunes Power Plant was formerly proposed to be built in connection with the JCEP terminal, but in 2016 the applicant withdrew the application for site certificate.
3. You are on the mailing list for another state agency with a permit application in process related to the same facility.


