Request for Comments on the Complete Request for Amendment 7 and Draft Proposed Order

Notice Summary:

Notice Date: May 13, 2022

<u>Site Certificate Amendment Request</u>: Amend the approved turbine specifications (specifically the minimum above-ground blade tip height and the hub height) for Vansycle II wind turbines, if repowered as previously approved.

<u>Facility Location</u>: Northern Umatilla County, north and east of Helix, Oregon.

<u>Amendment Review Type</u>: Type B review, which does not include a public hearing or opportunity for contested case proceeding.

Recommendation: The Oregon Department of Energy Staff (Department) recommends that Request for Amendment 7 (RFA7) meets all required standards and should be approved by the Energy Facility Siting Council (EFSC or Council).

Written Comment Deadline: June 6, 2022 (5:00 PDT)

Description of Facility (Approved/In Operation):

The Stateline Wind Project consists of two geographic units. Stateline 1 & 2 (Unit 1) is composed of 186 wind turbines and has a peak generating capacity of up to 123 megawatts (MW). Vansycle II (Unit 2) consists of 45 wind turbines with a peak generating capacity of up to 119 MW. There are two certificate holders for the Stateline Wind Project site certificate, based on the two geographic units of the facility. The certificate holder for Stateline 1 and 2 is FPL Energy Vansycle, LLC (FPL Vansycle); the certificate holder for Vansycle II is FPL Energy Stateline II, Inc. (FPL Stateline), both of which are wholly-owned subsidiaries of NextEra Energy Resources, LLC (NEER) (certificate holder owner).

Description of Amendment Request: RFA7 seeks EFSC approval to amend the approved turbine dimensional specifications for the Vansycle II wind turbines, if repowered as approved in the Final Order on RFA6. The certificate holder indicates in RFA7 that

further refinement of design and associated engineering resulted in a proposed repowered configuration that would require a decrease in minimum above-ground blade tip height (from 59 to 50 feet), and an increase in hub height (from 295 to 315 feet). The certificate holder proposes changes to the turbine specifications in site certificate Condition 137, and the Department recomends revisions to Condition 137 in the Draft Proposed Order.




Figure 1: Stateline Wind Project: Vansycle II Unit Regional Location

Facility Location: The approved facility is located in northern Umatilla County, north and east of Helix, Oregon, as presented in Figure 1, Stateline Wind Project: Vansycle II Unit Regional Location. The communities closest to the facility include City of Helix, Oregon, and Touchet, Washington. The site boundary is located within northern Umatilla County, approximately 20 miles north of the City of Pendleton and Interstate I-84 and east of the Town of Milton-Freewater and State Highway 11. EFSC Review Process

The site certificate amendment process is a consolidated, comprehensive siting process. The site certificate holder must demonstrate that the proposed amendment meets all applicable EFSC standards established under Oregon Revised Statute (ORS) 469.501 and set forth in Oregon Administrative Rule (OAR) Chapters 345, Divisions 22, 24 and 27 as well as all other applicable Oregon statutes, rules and standards.

Request for Amendment: On April 19, 2022, the Department received pRFA7. In pRFA7, the certificate holder included a request that the amendment be processed under Type B review per OAR 345-027-0357(8). On May 12, 2022, the Department determined the amendment request to be complete. Under OAR 345-027-0363(5), a request for amendment is complete when the Department finds that the certificate holder has submitted

information adequate for the Council to make findings or impose conditions on all applicable Council standards. The Department determined that Type B review was justified on May 13, 2022.

<u>Draft Proposed Order</u>: On May 13, 2022, the Department issued a Draft Proposed Order (DPO) on RFA7. The DPO, ODOE's first evaluation of the proposed facility which includes findings of facts, conclusions of law and conditions, recommends EFSC approve RFA7 and issue an amended site certificate. The DPO is not a Final Order. The purpose of this DPO notice is to inform the public of an open written comment period.

Comment Period Written comments on RFA7 and the DPO must be received by the Department by 5 p.m. PDT on June 6, 2022, and must be submitted in writing through the public comment portal described below, by mail, email or faxed per below:

The Council will not accept or consider public comments on RFA7 or on the DPO after the written comment deadline that closes the record on the DPO.

Please note: All comments submitted to the Department may be disclosed to the public, subject to Oregon Public Records Laws (ORS Chapter 192). Public comments may be available on the Department's webpage for the Stateline Wind Project as an attachment to the later-issued Proposed Order.

Comment submission does not register your contact information to receive future notices. If you would like to receive notices for this facility or any other EFSC facility, and have not already done so, please follow the information in this notice to subscribe to the ClickDimensions email notification list.

<u>Proposed Order</u>: After the Department has considered all comments received before the comment deadline for the DPO, as described in this notice, the Department will issue a Proposed Order. The Proposed Order shall recommend approval, modification, or denial of the seventh amended site certificate. The Department will issue, concurrently, a notice of the Proposed Order and the Proposed Order.

<u>Final Order</u>: EFSC, may adopt, modify or reject the Proposed Order based on the considerations described in OAR 345-027-0375. In a written Final Order, EFSC shall either grant or deny issuance of an amended site certificate.
