### **Sunstone Solar Project**

# Public Hearing and Request for Comments on Request for Site Certificate Amendment 1 and Proposed Order

**Summary:** 

Notice Date: October 31, 2025

Approved Facility: A not-yet constructed 1,200 megawatt (MW) solar photovoltaic (PV) power generation facility approved to occupy up to 9,442 acres of a 10,600 (17 sq. miles) site boundary.

Amendment Request: Request for Amendment 1 (RFA1) seeks Energy Facility Siting Council (EFSC or Council) authorization to: split the approved facility into six separate facilities, amending the current site certificate and creating five new site certificates; three facility design modifications; and amend several conditions to be consistent with the site certificate split.

<u>Facility Location</u>: Morrow County, approximately 15 miles northeast of Lexington, Oregon.

<u>Proposed Order Recommendation</u>: In the Proposed Order (PO), the Oregon Department of Energy (ODOE or Department) recommends that the facility, with the changes proposed in RFA1, complies with all required standards and should be approved by Council, subject to new and recommended amended site certificate conditions.

#### **Public Comment Period and Hearing:**

The comment period extends 35-days, from October 31, 2025 through December 5, 2025. The public may provide written or verbal comments regarding RFA1 and the PO including but not limited to recommended new or amended site certificate conditions. Written comments may be submitted during the public comment period to the Department Representative identified below on page 3. Verbal comments may be made during the public hearing.

# Description of Approved but Not Yet Constructed Facility:

#### **Energy Facility**

- 1,200 MW Solar PV power generation facility
- 1,200 MW Battery Energy Storage System with 6 hours of discharge Capacity

#### Related or Supporting Facilities

- An interconnection substation
- Up to six collector substations

- Up to four operations and maintenance buildings
- Up to 9.5 miles of 230-kilovolt (kV) overhead transmission lines
- Other infrastructure including roads, perimeter fencing and gates.

The Council approved the facility and issued a site certificate on November 14, 2024. The site certificate requires construction to begin by November 18, 2027, and be completed within three years from the construction start date.

**Description of Changes Proposed in RFA1:** RFA1 seeks Council approval for the following changes to the site certificate:

- Split the approved facility into six separate facilities; each with their own site boundary, certificate holder, and site certificate. The split would amend the current site certificate and create five new site certificates.
- 2. Three facility design modifications:
  - a. Modify the transmission line corridor, in length and location.
  - b. Reduce the number of switchyards from two to one.
  - c. Increase the footprint (acreage) of the Phase 1 substation from 1.6 to 7.3 acres.
- 3. Amend several conditions to be consistent with the site certificate split.

#### **Approved Facility Location:**

Approximately 15 miles northeast of Lexington, Oregon. The facility is approved to be located on privately owned land zoned for Exclusive Farm Use. A map of the approved and proposed site boundaries is included in this Notice. The map is also available on the Sunstone Solar Project Webpage and ODOE's Online Mapping Tool.

#### **EFSC Review Process:**

The EFSC review is a consolidated, comprehensive permitting process. The Department Siting Division serves as staff to EFSC and conducts the RFA review process. The certificate holder must demonstrate through a preponderance of evidence on the record that the facility, with the proposed changes, complies with all laws and Council standards applicable to an

original site certificate application; the amount of the bond or letter of credit required under OAR 345-022-0050 is adequate; and, the facility, with the proposed RFA1 changes, complies with the applicable laws or Council standards that protect a resource or interest that could be affected by the proposed change. #### **RFA Process Overview and Hearing Information:**

Request for Site Certificate Amendment
Sunstone Solar, LLC (certificate holder), a wholly owned subsidiary of Pine Gate Renewables, LLC, filed the preliminary Request for Amendment 1 on July 24, 2025. Based on the Department's review of the preliminary request, and responses to its requests for additional information received, the Department notified the certificate holder that the amendment request was complete on October 29, 2025. A complete amendment request was received on October 31, 2025 and has been reviewed by the Department. RFA1 is available on the project webpage for review, as described in the More Information section below.

#### Proposed Order Issuance

On October 31, 2025, the Department issued a Proposed Order on RFA1. The Proposed Order, ODOE's first evaluation for the amendment request, includes recommended findings of fact, conclusions of law and recommends new and amended site certificate conditions, all of which are open for the public to comment on. The Proposed Order recommends that EFSC find that EFSC approve RFA1, subject to existing and recommended new and amended conditions. The Proposed Order is available on the project webpage for review, as described below.

#### **Public Hearing and Comment Period:**

EFSC will hold the public hearing on RFA1 and the Proposed Order on November 21, 2025, which will be both in person and remote. See Hearing details on page 1.

During the hearing, there will first be a brief overview by ODOE on the siting process, the approved facility and requested amendment, followed by an overview of the hearing format and finally an opportunity to provide oral comments on RFA1 and the Proposed Order. The duration of the time for individual commenters to provide oral comments will be 5 minutes, but that may be lengthened or shortened based on the number of people who wish to comment. Written comments reflecting oral comments are encouraged.

Council has the ability to pose questions to the Department, certificate holder, and commenters, should they seek additional clarification.

Commenters contending that the Council should reject the RFA or the Department's Proposed Order must raise their issues on the record, with sufficient specificity. To raise an issue on the record, a person must raise the issue in person during the public hearing or in a written comment submitted after the date of this Notice of the public hearing and received by the Department before the comment deadline, December 5, 2025.

To raise an issue with sufficient specificity, in their written and/or oral comments, a person must

- identify the recommended findings of fact, conclusions of law or conditions of approval identified in the proposed order to which they object;
- specify the Council standard or other applicable state and local requirements on which their objection is based; and,
- present facts or statements supporting their objection.

In order to be included on the record of the public hearing, written comments **must be received by December 5, 2025 (the comment deadline)** through the public comment portal described below or by mail, or email to the Department's representative listed below:

Following the close of the public comment period on December 5, 2025, commenters may participate in the following process:

- Certificate holder must submit written responses to written and verbal comments by December 19, 2025.
- Department may submit written responses to written and verbal comments by December 19, 2025.
- 3. Commenters may submit replies to certificate holder and Department responses by December 29, 2025.
- 4. Certificate holder and Department may submit sur-replies to commenters by January 7, 2026.

If no comments are received during the comment period, the process and deadlines above do not apply.

Council Review of the Draft Final Order
Following the sur-reply deadline, as identified above, during an EFSC meeting, EFSC will review the Department's draft Final Order including its written analysis of comments, responses, replies and surreplies. EFSC will then issue a Final Order either approving or rejecting RFA1. If approved, one
