## **Speedway Energy Facility**

### Notice of Intent, Public Comment Period and Public Informational Meeting

**Summary:** 

Notice Date: December 16, 2025

<u>Proposed Facility</u>: 1,400-megawatt (MW) combined solar photovoltaic (PV) and wind power generation facility, up to 500 MWs of battery storage, and related or supporting facilities located within an up to 25,000-acre (39.1-square mile) site boundary.

<u>Proposed Facility Location</u>: Sherman County. The northernmost portion of the site boundary is 3.3 miles southeast of the City of Moro, and near the City of Grass Valley.

<u>Applicant</u>: BGTF Speedway Project, LLC. (applicant), a subsidiary of Brookfield Renewable U.S (parent company).

Notice of Intent: On October 24, 2025, the applicant submitted a Notice of Intent (NOI) to submit an Application for Site Certificate (ASC) to the Energy Facility Siting Council (EFSC or Council). The Oregon Department of Energy (ODOE or Department) is staff to EFSC and conducts review of the NOI and ASC.

Public Comment Period and Informational Meeting: The public comment period on the NOI is from December 16, 2025 to January 23, 2026 at 5:00 p.m. Pacific Time.

The Department will host a public informational meeting on the NOI to provide additional opportunities for the public to learn about the proposed facility and the state siting review process, provide written or oral comments, and ask questions.

#### **Description of the Proposed Facility:**

#### Solar Energy Facility Components

- Solar modules connected in strings
- Tracker systems and posts
- Inverters, transformers and cabling
- 34.5 kilovolt (kV) collection system

#### Wind Energy Facility Components

- Up to 100 wind turbines with nacelles, blades, rotors and towers: 8 MW, 575-foot rotor diameter, total max height of 698 feet
- Turbine foundations
- 34.5 kV collection system

**Battery Energy Storage System** 

• Up to 500 MW; centralized or dispersed battery storage within site boundary

#### **Related or Supporting Facilities**

- One Operations and Maintenance Building
- Up to 6 collector substations
- One central substation
- New and improved access and service roads
- Perimeter and interior fencing and gates
- Temporary construction staging areas
- Temporary onsite workforce housing

#### **Location of Proposed Facility:**

The proposed facility would be located on approximately 25,000 acres (approximately 39.1 square miles) of privately owned land zoned F-1 for Exclusive Farm Use located in Sherman County.

A general map of the proposed facility and site boundary are included at the end of this notice. #### **EFSC Review Process:**

The facility that would generate up to 1,400 MW of solar and/or wind power and occupy up to 25,000 acres (39.1 sq. mi.) of land and therefore is an energy facility subject to EFSC jurisdiction under the definitions in ORS 469.300(11)(a)(A) a wind power generation facility over 25 MW; and ORS 469.300(11)(a)(A)(D)(ii) a solar photovoltaic power generating facility occupying over 2,560 acres of arable land. As such, the proposed facility must receive approval from EFSC for a site certificate prior to construction.

The EFSC review is a consolidated, comprehensive permitting process. The applicant must demonstrate that the proposed facility meets all applicable EFSC standards established under Oregon Revised Statute (ORS) 469.501 and set forth in Oregon Administrative Rule (OAR) chapter 345, divisions 22 and 24, as well as all other applicable Oregon statutes, rules and standards.

#### **ASC Process Overview:**

Notice of Intent: On October 24, 2025, the Department received an NOI to file an ASC for the proposed facility.

Submitting the NOI is the first step in the process of obtaining a site certificate. The NOI includes information about the site and characteristics of the proposed facility and discusses potential impacts from construction and operation of the proposed facility.

Land Use Standard: The applicant may choose to meet the Council's Land Use standard, OAR 345-022-0030, by obtaining land use approval from the affected local governments (ORS 469.504(1)(a)) or by seeking a determination of compliance from Council (ORS 469.504(1)(b)). In the NOI, the applicant indicates that it intends to seek a determination from Council under ORS 469.504(1)(b). If the applicant chooses to obtain local land use approval later in the process, any person interested in land use issues should participate in the affected local governments' land use processes if they are not yet complete.

#### **Submission of Comments on the NOI:**

This Notice initiates the public comment period on the NOI. Comments are encouraged to help the Department and the applicant identify issues and concerns early in the process. Comments must be received by January 23, 2026 by 5:00 p.m., Pacific Time. Comments may be submitted:

All comments submitted to ODOE may be disclosed to the public, subject to Oregon Public Records Laws (ORS Chapter 192). Public comments are made available via the systems described in this Notice.

#### Project Order

Based on the Department's review of the NOI and all comments received during the NOI comment timeframe, the Department will issue a Project Order establishing the state and local standards and criteria that must be met for Council to issue a site certificate.

#### Preliminary Application for Site Certificate

An applicant has two years from the date of submitting the NOI to submit their preliminary application for site certificate (pASC). The applicant indicates that it intends to submit the pASC in early 2026.

During this phase, the Department, along with applicable state agencies, local governments and tribal governments will review the pASC to ensure it is complete, and request additional information, if necessary.

#### **Complete Application**

An ASC is complete when the Department finds that the applicant has submitted information adequate for Council to make findings or impose conditions on all applicable Council standards.

This phase includes another Public Notice and public informational meeting. However, there is no public comment timeframe associated with this phase.

#### **Draft Proposed Order**

The DPO contains the Department's initial recommendation to Council, the final decision maker, on whether each applicable standard is met. The DPO will include staff's analysis of the ASC as well as comments received from state agencies, local governments, and tribal governments. The DPO will include recommended findings of facts, conclusions of law and site certificate conditions of approval.

Issuance of the DPO will initiate a public comment period. In addition to the written public comment period, there will be an opportunity for oral comments at one or more public hearings to be held in the vicinity of the proposed facility. In order to preserve your right to request to participate in the contested case proceeding and any subsequent appeal of the Council's decision, you must comment either orally at the public hearing or in writing during the comment period on the DPO.

Following the conclusion of the comment period, Council will review the DPO, all submitted comments, any applicant responses to comments, and will provide their comments to the Department.

#### **Proposed Order**

Taking into consideration all the comments received, applicant responses, and Council's comments, the Department will issue a Proposed Order, staff's second recommendation to Council. Council will appoint a Hearing Officer to conduct a contested case proceeding on the Proposed Order.

#### **Contested Case**

The purpose of the contested case proceeding is for an impartial hearing officer to evaluate properly raised issues and make recommendations to Council on those issues. Only people who commented on the DPO may request to participate in the contested case proceeding.

#### Final Order

Following a contested case proceeding, Council shall issue a Final Order either approving or denying the ASC for the proposed facility.
