1.0 Introduction

Wagon Trail Energy Center, LLC c/o NextEra Energy Resources, LLC (Applicant) proposes to construct and operate the Wagon Trail Solar Project (Facility), a solar energy generation facility and related or supporting facilities in Morrow County, Oregon. This Exhibit CC was prepared to meet the submittal requirements in Oregon Administrative Rule (OAR) 345-021-0010(1)(cc).

2.0 State Statutes, Rules, and Ordinances

- Oregon Office of Emergency Management;
- Oregon Department of Environmental Quality; and
- Oregon State Police.
