Subject: Public Comment on Radioactive Waste Transportation Fee Rulemaking

EFSC,

I am **writing in support** of the OR DOE's Radioactive Waste Transportation Fee Rulemaking. **Rail carriers** should also be included in the fee rulemaking, for the same reasons other shippers will be. The fact that rail businesses are voicing strong opposition is to be expected, and should not be cause for exemption.

The state of Oregon **must fund emergency preparedness and response**, especially in light of the dramatic increase in shipments of nuclear waste from the Hanford Nuclear Site that is expected. I live within walking distance of both an interstate highway (I84) and two very active railroads (along the Columbia River, one on the WA side and one on the OR side). Both highway transporters and trains have created disasters already in our community, dumping toxic chemicals and igniting wildfires. Nuclear waste accidents would [will] be MUCH worse. ALL carriers need to pay into a fee structure that robustly funds emergency preparedness and emergency response.

I also urge EFSC to ensure that **carriers of liquid radioactive waste** through the state pay a larger fee since liquid waste poses a larger risk than solidified waste. Gov. Kotek previously noted, in writing to the Tri-Party Agencies re: Holistic

Negotiations, that “Oregon has significant concerns about the inherent risk of transport of liquid waste.”

Thank you for the opportunity to comment on this rulemaking. Kindly let me know that you’ve received my comments and added them to the official record.

Dear Energy Facility Siting Council,

I am very supportive of the Oregon Department of Energy's Radioactive Waste Transportation Fee Rulemaking. I also strongly support the inclusion of rail carriers within this rule, despite the industry pushback.

Shipments of nuclear waste from the Hanford Nuclear Site are expected to increase exponentially as tank operations advance. Somewhere between 60 to 110 shipments per year are expected to originate just from the 200 West project alone. In comparison, from 2023 to 2024, the Oregon Department of Transportation reported a total of 349 radioactive shipments through the state. It is imperative that the state of Oregon fund emergency preparedness and response in light of this increase.

I also urge EFSC to include a larger fee on carriers of liquid radioactive waste through the state, which poses a larger risk than solidified waste. In 2024, Governor Kotek wrote to the Tri-Party Agencies in response to Holistic Negotiations that, "Oregon has significant concerns about the inherent risk of transport of liquid waste." It remains an open question whether increased waste shipments from Hanford will contain waste in a solid or liquid form and Oregon should be prepared to respond to either.
