1. We currently use Energy Efficiency Incentive funds from BPA to run our rebate program. Would that be considered another funding stream per the eligibility requirements of this program?

No. We understand that many COUs utilize these BPA funds, and use thereof does not prohibit applications to this program. COU customers, however, can only receive financial support from one federal funding source, per eligible project.

3. Will there be a webinar?

No webinar is scheduled at this time.

4. Will there be administrative funds available for this program?

There are no administrative funds available to support this program. All funding must be used to support individual residential weatherization incentives of no more than \$2,000 per household.

5. Can funding from this grant be stacked with other incentives?

Funding for this program may not be stacked with additional incentives. Homeowners may receive up to \$2,000 per weatherization grant. Incentives from other programs may be used by the homeowner if the work is done at a different time.

6. If a weatherization project costs the homeowner less than \$2,000, what incentive amount will the homeowner receive?

Homeowners are eligible for up to \$2,000 per project. Incentive program managers should use the formula for their existing weatherization program to determine the amount a homeowner will receive.

7. What is the timeline for submitting incentive receipts under this program?

Payments for this program are reimbursement-based. Utilities should submit invoices, with appropriate receipts, monthly. Invoices should be submitted no later than 30 calendar days following the end of the subgrantees monthly billing period.

8. Are there additional requirements for homeowners beyond what is required under our current weatherization program?

There are additional attestation requirements. Utilities may need to add additional data to their application to comply with the requirements listed on the CERTA Application.

9. We are unable to provide ODOE with the required data listed in the Program Guide. Are we still eligible for the program?

ODOE is required to report on greenhouse gas emissions reductions. The data is required to calculate these reductions. If a utility has concerns over reporting requirements, please reach out to weatherization@energy.oregon.gov with specific data collection questions.
