## Roll call and opening remarks.

Chair Wyatt opened the meeting at 8:30 a.m.

After Board and staff introductions, the meeting summary from the October 2023 meeting was approved.

## **Board opening and meeting recording**

## U.S. Department of Energy

Delmar Noyes and Roger Gordon presented the Board with an update about the Test Bed Initiative, TBI, and the Direct Feed-Low Activity Vitrification Facility and recent melter heat-up and initial glass pour.

Delmar explained the TBI process and why they chose tank Y 101 for the 2000 test. Delmar explained why they picked SY 101 and there were several factors: It has a large level of liquid waste, which means all the solids have settled out, which is also what this system is designed for, and that very low solid liquid waste, further, it's located in our West Farm area.

Roger explained the steps and processes that are occurring with the melter heat-up activities and how they successfully poured a batch of test glass into a container. Roger further explained what they intend to do when they add tank waste to make the first batch of glass.
