**US Department of Energy, Hanford Field Office**

US DOE, Hanford Field Office staff provided the Board updates on the following cleanup topics:

- Tank Waste Treatment; including Tank-side Cesium Removal System (TSCR), Test Bed Initiative (TBI), Effluent Treatment Facility (ETF), and waste retrievals
- Waste Treatment Plant (WTP) update, including commissioning of the direct-feed low activity waste facility (DFLAW), and the high-level waste treatment facility.
- Update on milestones and Records of Decisions for 100-K, 100-N, and 324 Building

**DOE UPDATE**

**Energy Communities Alliance: Transition Paper - Recommendations to the Incoming Administration and the Hanford Communities Perspective**

David Reeploeg, Executive Director of Hanford Communities and Energy Communities Alliance (ECA) Executive Board Member, provided an overview of ECA's Transition Paper, titled 'Ensuring Long-Term Success: Recommendations for the Next Administration on the U.S. Department of Energy's Environmental Management Mission.' ECA issues a Transition Paper every four years, during each presidential election cycle. David provided an overview of the Transition Paper's key recommendations and discussed how they relate to Hanford cleanup. The key recommendations are:

- Ensure Safe and Available Disposal Capability is Available for All Waste Aligned with Local Community Needs
- Re-assess Use of End-State Contracting
- Ensure Regulatory Agreements are Reasonably Achievable and Balance Short- and Long-Term Needs
- Improve Workforce Planning to Address EM "Brain Drain" and Ensure EM is Well Integrated with Other DOE Programs
- Maintain Robust Local Community Engagement
- Continue to Focus on Economic/Energy Development Benefits From Cleanup

- Clarify that DOE Will Fully Investigate and Remediate Hazardous Materials Discovered at Completed Sites
- Reconstitute a Dedicated Nuclear Waste Organization Within DOE

### ECA UPDATE

#### **Oregon Department of Energy Updates**

Matt Hendrickson and Max Woods presented on the results of the Holistic Negotiations at the Hanford Nuclear Reservation. The focus was on Oregon based residents, community group, or Agency submissions and the Tri-Party agency responses. At least 11 self-identified Oregonians, 4 Oregon based community groups, 1 Tribal Nation, and the City of Bend submitted comments beyond those of the OHCB Board. The comments submitted were similar across multiple interest groups and in general supported solidifying material before shipment, providing training for first responders, providing more public input opportunities, and ensuring proper environmental review and compliance is performed.

The Tri-Party agencies did delay a key Milestone, M-62-64 (200W waste infrastructure needs assessment) to the end of 2025 based on comments received. Further OHCB and public engagement opportunities are coming this year, with the 200W WIR (Waste Incidental to Reprocessing) decision due in Spring, a Supplement Analysis on DFHLW and 200W expected out in September, and a new Hanford Lifecycle, Scope, Schedule, and Cost report that incorporates the Holistic changes due this year.
