**Minutes of the Meeting**

2:00 pm **Welcome and introductions – Cam Preus, Convener**

Cam Preus called the meeting to order and we went around and provided introductions both on the phone and in person at the meeting.

2:05 pm **Public Comment**

There was no public testimony.

2:10 pm **Discuss criteria and timeline for Regional Infrastructure Fund responses**

Regional Solutions Coordinator Courtney Crowell reviewed the memo prepared for the advisory committee members that explained the criteria that other Regional Solutions Advisory Committees are using and that Regional Solutions staff felt comfortable with. Courtney also walked through the timeline of the process for the Regional Infrastructure Fund and explained that the prioritization that is happening at today's meeting is not funding decisions but only for messaging purposes for the February legislative session. The committee discussed that there would be a second phase of application for projects in the spring that would be the actual funding decisions.

2:30 pm **Discussion of Regional Infrastructure Fund RFI responses and prioritization**

Regional Solutions Coordinator Courtney Crowell walked through the 15 RFI applications and for each project did a short summary of the project and explained how the Regional Solutions team members felt each project corresponded to the criteria. This was reflected in the rubric included in the meeting materials.

After a lengthy discussion with all the committee members, the following seven projects were prioritized.
