ORS 182.550 Section 1 requires state agencies designated as natural resources agencies per ORS 182.535 to submit an annual report to the Environmental Justice Council.

These agencies include:

- Department of Environmental Quality (DEQ)
- State Department of Agriculture (ODA)
- Water Resources Department (OWRD)
- State Department of Fish and Wildlife (ODFW)
- State Department of Forestry (ODF)
- Department of State Lands (DSL)
- State Department of Geology and Mineral Industries (DOGAMI)
- Department of Land Conservation and Development (DLCD)
- State Marine Board (OSMB)
- Public Utilities Commission (OPUC)
- Department of Transportation (ODOT)
- Department of the State Fire Marshal (OSFM)
- Oregon Health Authority (OHA)
- Department of Energy (ODOE)

Each of the agencies above collaborated within their agencies to respond to the prompts outlined in ORS 182.550 and to additional questions posed by the Environmental Justice Council during their meetings in 2023. These include discussion during the September 5th meeting (Agenda Item #7).

To support development of the annual reports, the Environmental Justice Council (EJC) Coordinator hosted workshops for state agencies on October 23, 2023; November 27, 2023; and December 28, 2023 to allow state agencies to collaborate on how to respond to the 2023 prompts. This allowed for interagency information sharing and development of best practices within the EJC Liaison team. A template was also developed to provide guidance for all agencies on how to incorporate content that would answer the prompts from ORS 182.550 and the questions posed by the EJC. Use of this template was voluntary, but most agencies used this template as a starting point for their reports.

In addition to the monthly workshops in the last quarter of 2023, the state agency team of EJC Liaisons have been meeting at least monthly to discuss feedback from EJC meetings,

their needs to implement environmental within their respective agencies, and information sharing that led to deeper interagency collaboration outside of meetings.

The EJC Coordinator has also collected annual reports from all the listed state agencies and will distribute the annual reports to all Council members. This information will also be available for public consumption on the EJC website by February 29, 2024.

State agencies request the EJC to consume the reports throughout 2024 and provide feedback on the information provided. They also request guidance on how to address their agency needs that can enhance their ability to implement more robust environmental justice programs that lean on the pillars of meaningful involvement, fair treatment, and centering their work with environmental justice communities.
