and mixed income housing. That's just a few, over two dozen policy bills taking policy issues.

The budget session was challenged – biggest areas where funding wasn't identified due to ways and means decision and revenue with legislature. Good funding around shelter, so we should be able to maintain present services. Rehousing services funding was significantly lowered in legislative adopted budget. Homeownership investment for downpayment assistance and new home development. Some of the downpayment assistance was not actualized for the session.

**Svetha**: In the priorities, as 814 is listed, the youth housing assistance is passed. Housing coordinator OHCS did not pass.

Jimmy: Biggest disappointment was \$44M in prevention funding loss, what I'm worried about is the downstream impacts especially in Metro. We will likely face more evictions, it makes it unlikely this upcoming session there will not be a lot of funds to go around.

Melinda: There needs to be more around affordable homeownership. I'm seeing some people aren't apartment or home ready. Some are ready, and they still can't obtain it for lower income, credit, race, etc. I myself have been trying to obtain homeownership. Someone needs to make it make sense. I graduated from Washington county access program and am still not there. There has to be more ways for people trying to get homeownership to get that goal.

**Kim**: Of the proposals we had previously, we have to readvocate for eviction prevention funding, and we need to do it in the context of reduced revenue. If there is anyone putting forth that concept that would decouple us from the federal tax structure so Oregon can save some of that money, that would be one of the pathways that could be supportive of our objectives.

Javier: What about the Lift program?

**Will**: I think advocacy for that program is always important. Have seen benefits in person and livability, would advocate for that. Culturally responsive housing support would be something of interest for me.

**Jimmy**: Svetha, we double the size of energy assistance for Pacific Power and PGE customer footprint for low income communities. We toyed with the idea of doing

something for low income housing. One way we could create additional funds for prevention is creating something similar for multifamily property owners for example. There can be some things out there to offset reduction of funds.

**Svetha**: Bond pass throughs, agreed. There can be other options as well such as bond pass throughs.

Jimmy: We have a good system in or to incentivize affordable housing. Part of the reason we are operating in such a deficit for units, the economy is working so heavily against us. We can't just gravitate towards immediacy like shelter and prevention. We're not building enough long term. All efforts in short term will be lost if long term isn't focused on.

**Javier**: Lift is a long term effort. Preservation of existing efforts is also something we discussed to move forward. What would that engagement look like, what would be the most appropriate way to start?

Matt: Submissions from agencies were just finalized by the departments at the end of July. That was the timeline asked and so we have an inventory of all of the policy and program implementations. That is not every program, they are the priority programs for the Governor and her three initiative areas. We have that list and we're still kind of working through this specific implementation timelines for some of them, but I think we could share the summary list of projects. There is more than what I think the committee has time for but the committee could choose the ones they're interested in providing feedback on and then we can ask the departments to incorporate some part of the process for the committee to give their thoughts and recommendations.

**Javier**: Making note for us to determine what is of interest and doing some polling to rank.

**Kim**: One of the new themes is new sources of revenue. This would include the bond, tax reform, mortgage interest reduction, fees, real estate transfer, etc.

**Will**: For me it would be both but realistic its probably more programmatic given budget.

**Javier**: What about eviction prevention?

Kim: Eviction prevention was a previous priority but

would like to uplift again. What is our role as a committee to continue to talk about housing on racial groups. I don't think there are many groups that will be talking with our legislators, policy makers, program directors – thinking about how we can draw the lines for why the Lift program matters, why eviction prevention matters because of race based disparities – that is something important to remember.

**Svetha**: There is a good opportunity when committee looks at the options on what they'd like to prioritize and can use that racial equitable outcome lens and how the programs are being developed. I would also mention coordinating with BIPOC caucus.

Javier: Matt and Svetha will send a list out.
