New Director Presentation: Dept. of Administrative Services, Director, Betsy Imholt	Betsy Imholt: Been with DAS for three months. Been in state government for 30+ years. Grateful to be here. DAS does everything from landscaping to calculating your kicker. We also do publishing and distribution, mail delivery, financial budgeting and accounting, procurement, IT, policy work, fleet and car repairs, and many other services for agencies. Our mission is to ensure our resources are used efficiently. I work closely with Melinda Gross, who is on my team.  Kim: Can you expand on racial equity work your department is doing?  Betsy: Theres been a lot in last 5-6 years that has directed the department

via Executive Order and commitments with legislature. The work Melinda and the team are doing has built a trusting environment. In those sessions, there's accountability and open dialogue. That is intense work going across the enterprise and haven't experienced before. Really unique to Melinda and her team's talents. Takes most of the time on our team. Very impactful.

**John**: What work are you doing to improve relationships with small business community?

**Betsy**: Most direct and obvious is to get procurement system fixed. Theres a lot of money and potential that can benefit small businesses, if they cant participate in it then it will be a hinderance.

**Governor**: The Business Roundtable notes have been communicated to DAS. Betsy is also focused on technical challenges. Procurement is important.

**Mark**: Is there any look at reimbursement model around the state? Lack of reserve funds, doing services where you need to be reimbursed, expectation around increasing admin percentage cap?

**Betsy**: We have a long list of system barriers, technology barriers, and programmatic barriers – would add those to the mix for sure. Will take us a while to get things to work. It is a system we are rebuilding from ground up. We can do it with programmatic information in mind on choices we can make along the way. Disparity study helps to inform that.

**Governor**: The goal is to pay people on time and to help people be partners with the state.

**Betsy**: We have a policy on the books. It has been to pay within 45 days and to hold onto it. Why? Because we make interest on that. We are changing that and it will no longer be our point of view. The policy to unwind that, it takes time.

**James Alan Parker**: Applaud your priority for procurement. Hope we can find ways to support your goal there.

**Governor**: We anticipate a return engagement in 6 months.

Melinda Gross: I want to talk about Racial Equity Impact Statements (REIS). The budget starts in 2026, and we have a year to get work moving forward before new '27 year. We've done two rounds of REIS process. At this point we want to be intentional and bring you in earlier in the process to form what we hope to have in the REIS together.

REIS has to describe impact of programs for policies and budget modifications on Oregonians who are Black, Indigenous or other people of color. Budgets are a reflection of your moral values. If agencies aren't thinking of racial equity and its impacts then it will be hard to make those changes. For 23-25 budget cycle, we did a phased approach. 27 agencies were identified to submit an REIS regarding specific programs

they had. For 2025-2027 year we had all executive branch agencies submit and REIS and instead of *program* specific, we had them do it *agency* specific.

Office of Cultural Change reviews all budgets and makes recommendations to the Governor. Agencies asked for support, and we worked with them on identifying a picture on how they are doing along with their DEI work. Learnings from this include the quality and information of REIS submitted differed, and there is room for improvement on how REIS is used for budgetary items. I want to hear your thoughts on how you would like to engage. I want to plant the seed so we can develop what the process for upcoming budget cycle. So many ways for you guys to engage, want to flag now before we make decisions. Want to ensure folks can learn at a nice pace vs too fast.

**Paul**: Really timely as we are presenting later in the agenda on our priorities. Thanks for sharing on 23-25 for REIS process. That year it felt rushed; we want to engage earlier on in the process. I was unclear how agencies went about determining which programs they were using. Our committees had ideas on what programs were good, but they weren't the ones the agencies necessarily brought to our committees. Hungry to engage with you, specifically for Criminal justice sphere.

**Melinda G**: Wasn't around for 23-25 budget but this is the opportunity to engage earlier. If you want programs or presentations, lets do it. Would love REIS to be a tool for agencies to do before setting budgets. Right now, they are doing it as the last thing in the process which means they aren't doing it before or as they are creating it. Would like your support on thoughts and work together.

**Angela**: Love the intentionality and ensure the impact statements aren't just pushed aside. Wondering if other states are doing or leading in this area to connecting impact to budget creation? Secondly, do legislators have access or inform legislature as they look at GRB or other budgets when it comes to decision making.

**Melinda G**: Don't have insights on other states. Been thinking on how we engage with other states and DEIB. Haven't thought on the REIS piece. We do have someone from media who wanted to know more about REIS process. I want to engage with WA, CA, and CO. If you have other states, let us know. When it comes to legislature, it's not involved.

**Andre**: There currently is no official process.

**Jimmy**: Has there been a desire for touchpoints outside of budget process just to check in? What did you get from the reports from those 27 agencies and what did they utilize the impact statements and future budgeting?

Melinda G: We asked for progress reports last time. There were a few agencies that continued work, even if they didn't get funding directly. Others shared progress reports, but we didn't find out until two years later. We do support agencies with DEI plans, but now they are also required to do their budget. Maybe we do touchpoint work with DEI plan

and budget, also integrating the two possibly.

**Melinda DR**: With the political climate, financial constraints, and federal impacts - does that change anything? Out in the community there is a big fear and people have scrubbed websites for example. This is great but reality of where we are...

Melinda G: Can't talk about budget if we aren't talking on real impacts we're experiencing. We're in unprecedented times. Totally get it and feel it. Folks working at the state in DEI have that anxiety or those just working in the social justice work have that anxiety. We haven't backed down on DEI commitments. Agencies that get federal funding, for example, are impacted but are adapting. Will be hard and challenging. Theres a commitment from Oregon to continue to do the work. We are exploring what our north start with DEI looks like. We might be adapting to dig into the work stronger and be more specific on outcomes we are looking for and making DEI language more accessible – naming what we are working towards.

Melinda DR: Are there practice conversations or guidance on adapting?

**Melinda G:** That's part of the north star work and how we are engaging in next few months. Agencies that are outward facing are harder impacted. Going to get that North Star work launched in the next few months, if you're interested in participating, would love to have you.

**Governor**: Anything you do for human beings applies. I appreciate how we use and learn from it. Excited to hear from next steps. Going back and thinking on how we can structure to make proposals for budget, we are looking at budget reductions. How do we keep the North Star in a budget constrained environment. While we are talking about building a new year budget down the line, can we use that to make the best choices possible.

# RJC Priorities Discussion: Council Alignment and Committee Report Outs

## <u>Housing and Homelessness Committee</u>

**Kim**: Would like to come back to rental assistance as a priority. It's an extremely effective tool. Focus on housing development – see it as a continuum of need to ensure folks have that support for affordable housing.

Marin: How is housing development and work going overall statewide?

**Kim**: Meg has more experience in housing development than I do. There was commitment from state and local jurisdictions like Portland and metro area. Folks are committed to that goal and a good sign.

**Governor**: Whatever dollars that have been identified, we are trying to move as fast as possible.

#### Economic Opportunity Committee

**Jan**: Analyzing Agency Effectiveness – want to ensure people are receiving Business Oregon dollars and key data. Want to work with Business Oregon on recommendations.

Update on EO22-15 – disparity study and Office of Cultural Exchange. We have worked to make recommendations for Governor to encompass language and how we approach DEI and racial justice in this moment in time. Workforce Workgroup: working to draft recommendations based on Future

Ready Oregon and providing a model for workforce development. Would like to provide and strengthen workforce and talent expansion. Enabling completion and retention for folks in those programs. Goal is to set recommendations so Governor has them by 2026 first quarter.

## Environmental Equity Committee

**Ana**: Many of our things were tied to budget and didn't move forward unfortunately. Want to maintain our current work.

Environmental Restoration Funds – will start coming to Oregon and conservation programs for pollution reduction efforts.

Resiliency efforts – want to actively engage and provide feedback.

Working with Env. Justice Council. Our climate justice movement is so small that there's an ongoing question on moving forward. So many of the same people are being pulled into different spaces.

**Jan**: Have you thought on looking at Social Development Goals or EDGs Environmental Social Governance? Would encourage you to look at those as possible ways to talk to legislators to talk about environmental equity.

Ana: Our committee is so small we haven't had an opportunity to invest and talk about those conversations. Many of our members outside of the committees interact with legislators, as a broader look at climate justice and wins were under different leadership. Right now, it's an educational endeavor.

**Governor**: In a budget constrained environment, Oregon Env. Restoration Fund. There was a lot of thought to ensure it was used intentionally. It's the type of fund that could be easily tapped for other services, it's nice that it's guarded to be used as intended. Glad it's on the list.

### Health Equity and Human Services Committee

**Josie**: We have two overarching things to focus on in the coming months. We can help with communicating decisions for folks on the ground and navigating changes going forward.

Federal Medicaid and SNAP impacts. Been a lot of talk on data sharing and protections, will want to continue monitoring what's happening and be an agent to communicate impacts on the ground.

Coordinated Care Organizations model – lots of concerns on future viability. Want to be a partner for what comes next.

Healthier Oregon Program – want to monitor what goes on with enrollment and utilization. Significant chilling effect with current climate and want to connect on any changes that might be coming.

**Marin**: Behavioral health is a big issue. Want to continue monitoring and ensuring equity. We have a workforce crisis when it comes to workers, we want to ensure we promote bilingual bicultural therapists.

Residential Capacity and DHS funding and focusing on mental health. Traditional Health Workers – during COVID they had a big impact. Regional Health Equity Coalitions – also of interest.

### Criminal Justice Reform Committee

**Paul**: Affirming Sanctuary Laws –Want to ensure victims at risk are mindful that they feel protected and safe in this community.

Policy on Medicaid 1115 Waiver – to allow state to begin providing services to Oregon Health Plan.

Restorative Justice and reinforcing efforts – though we don't have any asks in short session. Want to keep legislators informed on our work and educate folks.

**Annie**: You mentioned there's been more payments made on issues coming up with Women in Custody. Where do I find that data.

**Paul**: Might defer to the Governor on that. Dept. of Corrections likely has that on settlements paid out.

**Governor**: Has been significant ton last couple years. Gender informed practices at Coffee Creek is trying to undo that.

**Annie**: We have talked to law enforcement in Southern Oregon on people in custody and detaining. When some counties differ from others, what do we do to remedy that?

**Paul**: For deflection – I also chair Criminal Justice Commission. We have 28 programs across 36 counties. Hopeful that the commission will develop best practice standards and something counties can adhere to. Want to ensure there is accountability and parody.

For 1115 waiver, when people go into custody they lose benefits. And the waiver gave 90 days. Not everyone stays a long time, and they are left with no coverage. This is a big issue for folks in custody.

**Governor**: We have a shared goal and value on making this work. Generally, it's a confluence of many factors. 1115 was slow to start and we were finding implementation challenges. The waiver benefits have an expiration. Will go back to agency to see what considerations are in play to restart it and for us to have a conversation about it. We should come back and see can we do this and if so what can we do.

### **Education Committee**

**Mark**: Want to educate elected officials and how these impacts and fiscal impact of cuts affect the system. Even by district.

Accountability – ensuring we prioritize safety, civil rights, workforce priorities, and system alignment. Seen significant reductions on some programs but want to ensure we get rationale on why cuts were done on equity programs vs across the board.

**Cynthia**: We've identified what we need for our students. When you put actions into place, and then when funding is gone, we need to start over again. We need stability. Those cuts have hurt us tremendously. Now everyone has to go back to developing a plan to overcome the cuts.

**Marin**: Are you also looking at the budget? Read somewhere we are spending about 35% on admin personnel and less on teachers. How do we improve our system.

Mark: Not for that particular item. Our focus is primarily on cuts from equity.

**Annie**: Want to suggest adding a bit more to accountability. Where are we trying to get accountability from – ex: teacher, students, system? Maybe more defined for our communities.

Governor: Maybe "school district accountability"?

**Mark**: Thank you. We have to find accountability for district control, as it impacts kids and families.

**Andre**: Thanks for the hard work, everyone. This was a lot of work and intentionality based on passion that comes with these priorities. This makes us even more powerful as we go into conversations with legislators and going into legislative session.

## What is an REIS?



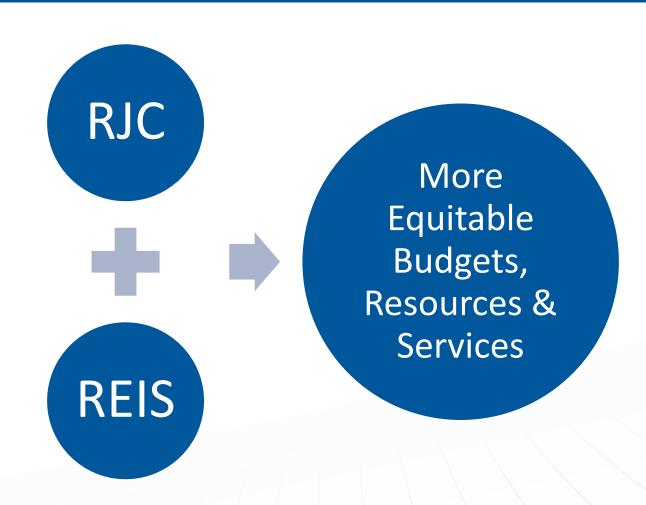
**ORS 291.206:** "As supplemental information, each agency request budget shall include a racial impact statement, which must be developed in consultation with the Racial Justice Council.

The racial impact statement must describe the impact of programs, policies and budget modifications on Oregonians who are Black, Indigenous or other people of color.

[Amended by 1969 c.173 §1; 2016 c.117 §15; 2021 c.612 §4]"

- Progress report for the 27 agencies who submitted an REIS the prior biennium
- OCC Analysis integrated into CFO Budget Analyst recommendations

# Learnings



- RJC presentations & feedback:
  - Meaningful, with some agencies revising their program approach because of the feedback.
  - Big time commitment for both agencies and the RJC.
- Agencies submitted REIS statements, but the quality and information provided varied greatly.
- DEI practitioners completed the REIS portion (if an agency has one). It was not usually a collaborative effort.
- There is room for improvement on how the REIS is used for budgetary proposals.
- Budget analysts have asked for support in reviewing REIS'.
- More clarity around the goal or outcome of an REIS process is needed (e.g. analysis tool to help shape a budget proposal; tool to review budgets and programs, etc.).
- Agencies need more support in REIS development.

## Racial Justice Council Legislative Priorities

Codified into law in 2021, the <u>Racial Justice Council (RJC)</u> is composed of six committees, with individuals from across Oregon consisting of people with unique backgrounds and life experiences. The aim of the RJC is to build a way for the state to better engage with, listen to, and support Oregon's Black, Indigenous, people of color, Tribal members, and immigrants and refugees. The RJC has been a critical partner and advisor to Governor Kotek, helping to align priorities and the state's policies and operations with a racial justice and equity framework.

## **RJC Legislative Priorities Endorsement Voting Process**

Like the advocacy letters process, the RJC will vote on whether to endorse the themes and priorities presented by the six RJC Subcommittees as a Council. Voting on the priorities identified by the RJC Subcommittees will be as follows:

- Committee Co-Chairs will present their theme and priorities to the Council membership at the September 18 RJC Meeting.
  - Members will have the opportunity to ask questions and engage in discussion upon the conclusion of each committee presentation.
- Approval requires agreement from 2/3 of all committee members present at the September 18 RJC Meeting.
  - o If 2/3 agreement is not reached, the Council will have further discussion on specific items of disagreement.
  - o After all items have been discussed the Council will vote to approve.
  - o If 2/3 agreement is not reached after the reconsideration discussion, the item of disagreement is dropped from further consideration.
  - The package then returns for a full vote on the remaining items. To pass the recommendation must receive 2/3 approval.
- If the priority achieves the 2/3 agreement it is considered officially endorsed and the position of the RJC.
