## Additional clarification:

For letter (a) – 4 reports are categorized as "other" because they would not fit criteria for above definitions but were initially reported as sexual misconduct – examples include: conduct not covered by Title IX such as race-based comments, other inappropriate comments such as "retard", other uncomfortable interactions, etc.

For letter (i) – A total of 247 students either transferred, withdrew, or took a leave of absence in the 2024-25 academic year. *Note: other students may have left the institution without notice.* Based on available known information, 3 students who were named in a sexual misconduct report or formal complaint process left the institution. However, the Title IX Office cannot definitively state that any student left the institution for this specific reason.

For letter (j) -38 refers to the number of students or employees who were either unresponsive to outreach, or requested supportive measures only, or requested no further action. Of the 39 total reports received, 1 formal complaint was filed and resolved through alternative resolution.

For letter (k) - 2 reports received during the 24-25 have recently been reopened. 1 formal complaint was filed on 8.13.25, requesting a formal investigation. The other was filed on 9.18.25, requesting alternative resolution.

A third formal complaint was filed on 9.11.25 for alleged behaviors that occurred during a summer '25 research program (May 2025 to August 2025), requesting a formal investigation.

The initial report was not filed until September 2025 so it is not counted in letter (a) but it is counted in letter (k).
