CHANGES TO LCB BONDS

Due to recent legislation, LCB's bond structure will change January 1, 2026, to require ALL landscape contracting businesses to carry a \$20,000 bond, except for Probationary phase holders, which still require a \$15,000 bond.

Deadline Approaching- Avoid Suspension

Contact your bond company to update your bond amount prior to January 1, 2026, to avoid possible suspension of your business license.




CITY OF BEND IRRIGATION CERTIFICATION COURSES

DON'T FORGET TO WORK ON YOUR CONTINUING EDUCATION!

LCP Licensees are required to report continuing education hours (CEH) every two years to maintain active status.

- Courses must be from the <u>Pre-Approved list</u>, or have received post-attendance approval before the license is renewed.
- If you have held an LCP license for 6 years or more, you need to report 8 hours every two years.
- If you have held an LCP license for less than 6 years, you need to report 16 hours every two years.

If you are unsure how long you have been licensed, please call the LCB office.

Reporting CEH every two years:

- If your LCP license number ends in an odd number, submit CEH at your renewal time in odd years (2025, 2027, etc.)
- If your LCP license number ends in an even number, submit CEH at your renewal time in even years (2026, 2028, etc.)
