This report was submitted by the City of Albany to meet the requirements of OAR 660-012-0900(6) for the 2024 reporting year.

In the 2024 reporting year, Albany:

1. Identified code and comprehensive plan changes needed to adopt Albany's Climate Friendly Areas (CFAs) and held open houses regarding the proposed CFAs.
2. Worked with DLCD-funded consultants at MIG to conduct a walkability audit of the city's development code and conducted 4 focus groups for feedback on walkable design standards to comply with Division 12 CFEC requirements.

Albany's 2010 TSP has a planning horizon year of 2030.

There were no amendments to Albany's 2010 TSP in 2024.

Please provide a forecast of future planning activities that may include TSP amendments:

The city and ODOT collaborated on a US Highway 20 corridor analysis from North Albany through downtown. The analysis evaluated future baseline conditions at seven intersections on the US 20 corridor and provided alternative recommendations to reduce traffic congestion and improve bicycle and pedestrian safety. Some of these recommendations will be included in the major TSP update.

TSP Update: The city and ODOT developed a draft scope of work for the TSP update and worked on the RFP to hire a consultant.

Not this year. The city completed an equity analysis in 2023 as part of the process to evaluate candidate Climate Friendly Areas. The analysis was included in Albany's CFA candidate report submitted to DLCDC by 12/31/2023.

The US 20 corridor study evaluated alternative pedestrian facilities and bicycle routes. The alternatives will be selected in the TSP update.

The city will identify -0830 projects that will be evaluated through the TSP update process, which will launch in 2025.
