For exemptions approved by the director as provided by OAR 660-012-0100(7) and OAR 660-012-0900(8)

About This Report

The report provides a summary of exemptions granted by the director as provided in:

- OAR 660-012-0100(7): This provision gives some local governments the
 opportunity to request an exemption from certain requirements in the
 Transportation Planning Rules ("TPR", OAR chapter 660, division 12). This is like
 an existing provision for small-population communities that has been in TPR for
 decades.
- OAR 660-012-0900(8): This provision gives local governments the opportunity to request an exemption from some annual reporting elements that would be too difficult or impossible to collect or report.

This report provides a summary of exemptions granted to date. The department will periodically update this report as more exemptions are requested and granted. There is no deadline for requesting an exemption from the rules, nor any limit to asking for additional exemptions.

Approved Exemptions

A complete summary of approved exemptions is included in attachments A and B to this report. The director has granted exemptions to these jurisdictions since report 7:

- Aumsville
- Bend
- Coburg
- Grants Pass
- Rogue River
