Primary Meeting Objectives:

 - Do the draft rules implement the legislative direction and the Racial Equity Framework?

 - Are there any omissions or places where further refinement or cohesion is needed, including consistency between rule sections and across divisions?

- Discuss connections between rules and what amendments are new since the last versions presented to the TAC
- Hear feedback on desired changes and outstanding questions

DLCD Racial Equity Framework: Restorative Justice

- Do the draft rules in Division 24 provide restorative justice measures for the communities most burdened? If yes, what are they? If no, what would you suggest that are within the State of Oregon's jurisdiction?
- What are some other best practices or examples restorative/transformation justice measures that would address the impact of the draft rules on the most burdened? These examples can be outside the jurisdiction of DLCD, but could provide conceptual idea sharing with Tribal communities, local governments, businesses and culturally based nonprofit organizations.
