Purpose:


- Protect people and property
- Retain eligibility for FEMA mitigation funding
- Not regulatory

Wildfire Hazard Regulations: The Oregon NHMP risk assessment and maps are not regulatory. The Oregon Department of Forestry and Oregon State University developed a statewide wildfire hazard map as required by the Oregon Legislature for use in building codes, defensible space requirements, and grant programs. Chapter 3: Risk Assessment

- Informs the mitigation strategy (goals and actions)
- The risk assessment describes the hazard and extent, historic events and damages.
- Used geospatial tools to understand more about the potential costs and drivers of vulnerability.

Chapter 3: Risk Assessment

FEMA National Risk Index:

- Damages and repair costs
- Disruption, distress, and cost to families and individuals
- Not future conditions

Oregon Natural Hazards Risk Assessment:

- Disruption, distress, and cost to families and individuals
- Socio-economic conditions that create vulnerabilities
- Socio-economic conditions that foster resilience.

Changes in Development

Is development occurring in hazard areas?

- Recent and Potential Development
- Changes in Population Demographics

Chapter 4: State Capability Assessment

State Capabilities are:

- Laws & Regulations
- Policies & Programs
- Building Codes & Enforcement
- National Flood Insurance Program
- Risk MAP Program
- Funding Sources

Chapter 5: Mitigation Strategy

Goals:

- What the state wants to accomplish
- Based on the Risk Assessment
- FEMA requires certain topics

Chapter 5: Mitigation Strategy

Actions:

- Driven by goals
- Must meet FEMA requirements
- Must be prioritized
