Re: Program Change Request OR-2023-1 – Adoption of the Clatsop County Land and Water Development and Use Code; Changes to the Clatsop County Comprehensive Plan including revisions to Goals 16 (Estuarine Resources) and 17 (Coastal Shorelands), and the incorporation of the 2002 Columbia River Estuary Dredged Material Management Plan (Ordinance No. 05-05)

Dear Ms. Phipps,

Thank you for the Oregon Department of Land Conservation and Development's (DLCD's) April 5, 2023, request for approval of changes to the Oregon Coastal Management Program (OCMP) pursuant to the National Oceanic and Atmospheric Administration (NOAA) Coastal Zone Management Act (CZMA) regulations at 15 CFR part 923, subpart H. ¹

NOAA's Office for Coastal Management approves the request subject to the clarifications, qualifications, and exceptions below.

NOAA's regulations require that the state post this decision by the Office for Coastal Management for public notice.² The public notice should state that as of the date of this decision letter the enforceable policies identified in the enclosed Table of Approved Changes shall be applicable in reviewing federal actions pursuant to the federal consistency requirements of the CZMA and its implementing regulations found at 15 CFR part 930.³ Please send a copy of the public notice to the Office for Coastal Management for our records to close out this file.

PUBLIC AND FEDERAL AGENCY COMMENTS

The Office for Coastal Management received one comment on DLCD's program change request. On April 27, 2023, the U.S. Army Corps of Engineers (Corps) submitted comments opposing the incorporation of the 2002 Columbia River Estuary Dredged Material Management Plan (CREST DMMP or DMMP), into the OCMP.

Citing the constitutional principle of sovereign immunity, the Corps states that it is not required to comply with state and local land use or zoning requirements. The Corps asserts that the proposed plans, codes, regulations, and ordinances would restrict the Corps' ability to discharge or place dredged material at various locations. The Corps notes that Congress charged the Corps—not the State or any local government—with maintaining the federal navigation projects. Any insistence that the Corps comply with a non-federal DMMP or dredged material disposal plan could impede the Corps' execution of the full purposes and objectives of Congress' authorization of these projects in Oregon. In instances of conflict, the legislation authorizing the Corps to maintain navigation projects preempts this type of state interference.

The Corps notes that the DMMP states that it is not intended to be an exhaustive list of all possible disposal sites and, therefore, it includes a procedure for the designation of new sites. The plan dictates that any new sites follow a local government procedure to designate new sites, which includes that new sites meet the requirements of their "Dredged Material Disposal Site Selection Policies;" thereby misaligning with the Corps non-discretionary responsibility to maintain the lower Columbia River federal navigation channel by limiting the Corps' ability to site in water disposal sites or transfer sites as appropriate to accommodate dredging needs.

The Corps also asserts that the 20-year projected timeframe for the 2002 CREST DMMP expired in 2022.

In summary, the Corps urges the Office for Coastal Management to reject any proposed updates to the OCMP that purport to impose permit requirements not otherwise authorized by federal law or frustrate the Secretary of the Army's authority to maintain navigation in Oregon.

NOAA Response: The Office for Coastal Management responded to the Corps comment sharing that DLCD's OCMP program change request includes the 2002 Columbia River Estuary Dredged Material Management Plan, which was adopted by Clatsop County in 2005 (Ordinance No. 05-05). Although the stated intention of the 2002 DMMP is to anticipate dredging and dredged material disposal needs over a 20-year period, there is nothing in the DMMP or any other document presented to the Office for Coastal Management that supports the assertion that the 2002 DMMP is no longer applicable. The 2002 DMMP is not being submitted as an enforceable policy of the OCMP but as an informational part of the coastal program that supplements the provisions of the Goal 16 (Estuarine Resources) and 17 (Coastal Shorelands) Elements of the Clatsop County Comprehensive Plan as amended by Ordinance No. 05-05 and the Clatsop County Land and Water Development and Use Code (LAWDUC) provisions pertaining to dredge material management (Section 5.45 Dredged Material Disposal Site Reservation Overlay District). The revisions to the LAWDUC and Goal 16 and 17 provisions have been submitted for approval as enforceable policies. The submission includes an appendix containing a list of sites within the 2005 ordinance where dredge material placement is permissible. The OCMP also has requested approval of these site designations as enforceable policies, which the Office for Coastal Management is approving as an enforceable policy as part of the state's ability to address its interests in its waters and submerged lands. However, as discussed herein, federal agencies, including the Corps might not be subject to these enforceable policies pursuant to the navigational servitude or other federal legal obligations.

As the Office for Coastal Management has previously stated, absent an express waiver of sovereign immunity by Congress, federal agencies are not required to obtain or apply for state or local permits. See the Office for Coastal Management's February 21, 2023, response to comments included in the decision letter regarding OCMP program change request OR-2022-2. Likewise, the Corps is not obligated to apply for amendments to or variances from the DMMP, Clatsop County Compressive Plan, or LAWDUC. ⁴ The LAWDUC expressly recognizes this limitation on state and local authority in Section 2.7000.

The CZMA authorizes states to review proposed federal actions, but does not authorize states to manage or regulate federal actions. However, for federal agency activities, the CZMA does obligate federal agency actions to be "consistent to maximum extent practicable" with the federally-approved enforceable policies of state coastal management programs. As defined at 15 CFR § 930.32, the term "consistent to the maximum extent practicable" means that a proposed federal action must be fully consistent with enforceable policies of state management programs unless full consistency is prohibited by existing law applicable to the Federal agency. In determining whether a proposed federal action is consistent to the maximum extent practicable, one looks to the discretion that a federal agency may have in not only undertaking a project, such as the maintenance or modification of a navigation channel, but also the discretion in how a project is undertaken such as the placement of dredged material.

The Office for Coastal Management recognizes the constitutional doctrine of the federal navigational servitude being dominant to other interests that would interfere with the federal responsibility to maintain navigable waters for the purposes of interstate commerce. However, states, which have both an ownership and sovereign interest in their navigable waters and submerged lands, may exercise control over these waters and lands to the extent that the dominant federal navigational servitude is not interfered with. If the Corps determines that compliance with a state's enforceable policy interferes with the Corps' legal obligations, the Corps can proceed over a state's CZMA federal consistency objection pursuant to the consistent to the maximum extent practicable standard. As such, with the clarifications, qualifications and exceptions noted below, the Office for Coastal Management is approving the 2002 DMMP as a non-enforceable informational component of the OCMP, and is approving as enforceable policies the changes to the Goal 16 and 17 policies within the Clatsop County Comprehensive Plan, and dredged material management provisions of the LAWDUC.

CLARIFICATIONS, QUALIFICATIONS AND EXCEPTIONS

The Office for Coastal Management's review of this program change submission found several issues with various provisions within the LAWDUC that have been proposed as enforceable policies to be applied in the review of federal actions pursuant to the CZMA federal consistency requirements. Below are clarifications, qualifications, and exceptions to the approval of enforceable policies contained in this submission.

- 1. Implementation of CZMA Review Requirements. Section 2.7000 of the LAWDUC (pages II-32-33) describes the CZMA federal consistency review procedures as applied through the LAWDUC. The Office for Coastal Management denies the request for incorporation of this section in its entirety. The CZMA review process is a function of the single state agency designated to conduct such reviews pursuant to 15 CFR §§ 930.11(o), 930.6, and 923.53(a)(1). While local governments can participate in the state CZMA review process, local governments are not authorized to establish any procedural requirements regarding the implementation of the CZMA review process. Any local comprehensive plan or ordinance which asserts such authority should be denied by the state in its review process for local government plans.
- 2. Information Requirements. The information requirements for the CZMA review process are described within NOAA's CZMA federal consistency regulations (15 CFR part 930),5 and may include information related to these requirements or as "necessary data and information" as approved by the Office for Coastal Management. Information requirements beyond those described in NOAA's regulations or previously approved by the Office for Coastal Management are not approvable as enforceable policies. For example, LAWDUC Section 2.9510 Traffic Impact Study; Section 6.2000 Ecola Creek Estuary and Necanicum Estuary Impact Assessment and Resource Capability Determination; and Section 6.3000 Columbia River Estuary Impact Assessment and Resource Capability Determination include informational requirements that are not enforceable policies. These studies and determinations would potentially: (1) subject a federal agency or applicant for a federal authorization to local government decisions or determinations as part of the state's federal consistency review; and (2) require an applicant to fund or conduct a project that is not part of the proposed federal action – as noted above, for CZMA federal consistency purposes, states review proposed federal actions, but cannot manage or regulate the proposed federal action. However, a state may request additional information that the state asserts is needed to determine consistency with its enforceable policies as part of its CZMA review, and may object on the basis of lack of information pertaining to its applicable enforceable policies if the information is not provided.
- 3. Procedural requirements. The Office for Coastal Management's review of comprehensive plans for the county found several instances where the designated enforceable policies for CZMA federal consistency review purposes did not meet the criteria for approval at 15 CFR § 923.84(b)(2) due to the lack of a standard. For example, Section 5.5350 pertains to the procedures for conditional use requests. There are no substantive standards within Section 5.5350 (page V-96) and it is not approvable as an enforceable policy. These exceptions to the approved enforceable policies are noted in the enclosed Table of Approved Changes (with changes from "Yes" to "No") to the designation of certain sections that were requested to be approved as enforceable policies.

- 4. Compensatory mitigation. The definition of "mitigation" within the LAWDUC at Section 1.0500 (page 1-31) includes "(5) compensating for the impact by creation, restoration, or enhancement of wetlands and aquatic areas to maintain their functional processes, such as natural biological productivity, habitat, and species diversity, unique features and water quality." Compensatory mitigation is discussed in several other places within the LAWDUC, e.g., Section 6.4150. Although the Office for Coastal Management recognizes that compensatory mitigation is one of the means that state and local permitting programs use to accommodate development projects while offsetting impacts, compensatory mitigation requirements cannot be applied as enforceable policies for CZMA review purposes. Enforceable policies are not mechanisms for redefining proposed projects or requiring federal agencies or applicants to conduct or fund a new project. It may be that mitigating for coastal effects will include compensation as negotiated by the state and the federal agency or applicant, but required compensation cannot be part of an enforceable policy, a condition of concurrence, or a basis for an objection. A state could still object because mitigation is not adequate to meet the application of an enforceable policy, but could not object because the federal agency or applicant did not pay funds or create a new project. The CZMA does not contemplate a situation in which a state could require a federal agency or applicant to propose a new project that may in and of itself be subject to federal consistency review. In addition, for federal agency activities under subpart C, such requirements could, among other things, cause Anti-Deficiency Act issues and possibly trigger supplemental review under the National Environmental Policy Act. As noted above, compensatory mitigation requirements can be applied through the state and local permitting processes. These requirements are approved for incorporation into the OCMP so long as it is understood that the requirements are not approved as enforceable policies and cannot be used as enforceable policies for CZMA review purposes.
- 5. The DMMP and dredged material site designations. As noted above, the 2002 DMMP is not being submitted as an enforceable policy of the OCMP, but as an informational part of the DMMP and the Office for Coastal Management is not approving the DMMP as an enforceable policy or enforceable component of the OCMP for CZMA federal consistency review purposes. Regarding the list of sites within the 2005 ordinance where dredge material placement is permissible, the Office for Coastal Management is approving the list as an enforceable policy as part of the state's ability to address its interests in its waters and submerged lands. However, as noted above, federal agencies, including the Corps may not be subject to these designated sites pursuant to the navigational servitude or other federal legal obligations.
- 6. *Incorporation by Reference*. As a standard qualification applying to all program changes, states may not incorporate enforceable policies by reference. If an approved enforceable policy refers to another statute, regulation, policy, standard, guidance, or other such requirement or document, the referenced policy must be submitted to and approved by the Office for Coastal Management as an enforceable policy in order to be applied under the CZMA federal consistency review provisions. No referenced policy may be applied for CZMA federal consistency review purposes unless that policy has been separately reviewed and approved as an enforceable policy by the Office for Coastal Management.
