Appendix D. Funding

This appendix provides an overview of selected federal funding programs that may support implementation of actions identified in the Lincoln and Lane County Estuary Resilience Action Plans (ERAPs). Programs listed here offer resources for habitat restoration, climate adaptation, infrastructure resilience, flood mitigation, and related natural resource management activities. While not exhaustive, this compilation highlights opportunities from multiple federal agencies that align with the goals of the ERAPs. Funding availability, eligibility, and timelines may vary; local partners are encouraged to consult the administering agencies for the most current information.

Note: Some of the programs listed were created or expanded under the Infrastructure Investment and Jobs Act (IIJA) and the Inflation Reduction Act (IRA). As a result, certain funding opportunities may have expired, become inactive, or may not be renewed. The current and near-future federal funding landscape remains uncertain, and applicants should monitor agency announcements and updates closely. See Appendix A in the Lincoln or Lane County ERAPs for a reference table of acronyms used below.
