
# TRANSPORTATION AND GROWTH MANAGEMENT PROGRAM TSP ASSESSMENT

TGM, a joint effort of the Oregon Department of Transportation and Department of Land Conservation and Development, provides grants to help communities:

- Provide transportation choices
- Create communities
- Support economic vitality and growth
- Save public and private costs
- Promote environmental stewardship



# TGM TRANSPORTATION SYSTEM PLAN ASSESSMENTS



A Transportation System Plan (TSP) is a long-range planning document to guide coordinated land use and transportation planning for communities. These plans prioritize transportation investments. Over time, these plans need to be updated to meet the needs of growing and changing communities.

TGM TSP Assessments help cities and counties evaluate their existing plans. TGM will identify the TSP's strengths and weaknesses, discuss the need for and timing of a potential update, and help develop a scope of work.

TGM TSP Assessments are helpful for cities and counties considering a TSP update. While TSP Assessments are helpful for cities and counties anticipating applying for a TGM Grant to complete a TSP update, an assessment may be done at any time and is not required to apply for a TGM Grant.

## RECENT TSP ASSESSMENTS

TGM has completed TSP Assessments for both cities and counties. In the past few years, TGM has completed assessments for the cities of Albany, Amity, Aurora, Florence, Keizer, La Grande, Myrtle Creek, St. Helens, and Wasco County.



# IS TGM TSP ASSESSMENT RIGHT FOR YOU?

A TSP Assessment is right for communities that have an existing, adopted TSP that is at least a few years old, and may be considering updates to the TSP. Communities with more change in population, growth and development, or other factors may have a need for more frequent TSP updates than communities with fewer changes.

Cities and counties requesting a TSP Assessment should be prepared to spend some time discussing the local TSP and any changes in the community with TGM staff, and to provide materials to TGM staff if necessary.



# WHO CAN APPLY

Eligible applicants are cities and counties with an adopted local Transportation System Plan.

# **APPLICATION TIMELINE**

TGM does not require a formal application to initiate a TSP Assessment. A city or county should contact TGM staff listed on the website to indicate interest in an assessment. TGM staff will work with the city or county to determine if the community is a candidate for an assessment. If selected, TGM staff will work directly with the community to develop the assessment.


