### Join the State Library of Oregon's LSTA Advisory Council

The State Library of Oregon is looking for four new members in 2021 to serve a three-year term on our **Library Services and Technology Act (LSTA) Advisory Council**. The Council advises staff and makes recommendations to the State Library Board on any issues concerning Oregon's federally-funded **LSTA program**. Incoming council members will also play a role in evaluating Oregon's current **LSTA Five-Year Plan** (PDF), and will also help shape Oregon's next LSTA Five-Year Plan for FFY2023-2027. This Advisory Council consists of 13 members representing library users and entities in Oregon, including public, school, academic, and special libraries. The upcoming vacancies are: Public Libraries Representative; Library Users Representative; School Libraries Representative; and Representative for Underserved & Under-Represented Persons.

Nominations will be accepted **using this form** through **October 9, 2020.** The State Library Board will appoint new Advisory Council members in November for terms beginning January 1, 2021. Please contact **Ross Fuqua** with any questions.

## LearningExpress Library will Continue as Statewide Online Resource

EBSCO Learning Express Library

The State Library has been working with the Statewide Database Licensing Advisory Committee (SDLAC) on a request for proposal (RFP) to update the state's contract for an online resource for skills-building and test preparation.

After evaluating two proposals, EBSCO was chosen as the successful proposer and the SDLAC has recommended that the State Library pursue a new contract for **LearningExpress Library**.

The committee has also recommended that in addition to the Job & Career Accelerator and Computer Skills Center add-on products that are in the current state subscription, PrepSTEP (Academic and High School) and Personal Success Skills Center also be added to the new contract. This contract is currently anticipated to be in place by November 1, 2020.



**Niche Academy: New Tutorials for Staff Development** 




#### Library Staff Training Tutorials



# State Library Staff Implement Inclusive Cataloging Practices

We believe that respectful language choice in access points is one way to work towards antioppressive librarianship. A good action is choosing language that people use to describe
themselves. Recently we have taken steps in our cataloging work to be more considerate about
the subject headings used for two classes of people: undocumented immigrants and LGBTQ
people. We looked beyond **Library of Congress Subject Headings** (LCSH) terms to see how
we could improve access with inclusive terms.

We are using "Undocumented Immigrants" from the ERIC Thesaurus of Descriptors as an alternative term for "Illegal aliens" and related LCSH terms. One example is where previously the heading was "Illegal alien children -- Education -- Government policy -- Oregon," that concept is now covered by "Immigrant children -- Education -- Government policy -- Oregon" and "Undocumented Immigrants" as paired headings. For further reading, we suggest the recent Report of the SAC Working Group on Alternatives to LCSH "Illegal aliens" [PDF].

We are also employing updated supplemental terms from the **Homosaurus** Vocabulary, which enhances discoverability of LGBTQ resources. These terms often include the acronym LGBTQ. A few examples of terms we have used are "LGBTQ people," "Civil rights (LGBTQ)," and "Youth (LGBTQ)."

We hope that we can continue to improve access by finding and using respectful terms from controlled vocabularies that best represent the communities and individuals they describe. For more information, contact the Cataloging Services Librarian, Heather Pitts, at heather.pitts@state.or.us.
