- (a) Any party may request, pursuant to ORS 103 30, 10 M '89 that an appeal be transferred to the circuit court SECRETARY OF STATE county in which the appealed decision was made, in the event the Board determines the appealed decision is not reviewable as a land use decision as defined in ORS 197.015(10).
- (b) A request for a transfer pursuant to ORS 197.230 shall be initiated by filing a motion to transfer to circuit court not later than ten days after the date respondent's brief is due under OAR 661-10-035(1).
- (c) If the Board determines the appealed decision is not reviewable as a land use decision as defined in ORS 197.015(10), and a motion to transfer to circuit court is filed as provided in section (10)(b) of this rule, the Board shall not dismiss the appeal and shall transfer the appeal to the circuit court of the county in which the appealed decision was made.
