## NATURE OF THE DECISION

Petitioners appeal a city ordinance that establishes a new effective date for a previously enacted city ordinance.

## DISMISSAL

- These appeals were suspended on January 19, 2011 at the request of the parties. On August 14, 2013, the Board requested by letter that the parties advise it of the current status of the appeals within 21 days, and advised the parties that if the Board did not receive a response from the parties within 21 days of the date of the letter, the appeals would be dismissed.
- The city responded that as a result of our decision in *Gunderson, LLC v. City of Portland*, 62 Or LUBA 403 (2011), the appeals are moot, and requested that the appeals be dismissed. Petitioner Schnitzer Steel Industries, Inc. responded that it agrees with the city's request to dismiss the appeals. Petitioner Gunderson, LLC did not respond.
- The appeals are dismissed.
