Model Rule for OHA COVID Rules Enforcement: Discussion regarding Governor's recommendation for Health Boards to adopt a temporary rule to enforce the OHA rule mandating vaccination for health care professionals. Discussion regarding the specificity of the OHA vaccination mandate rule; discussion regarding the policy decisions surrounding Board regulation of OHA vaccine mandate. Discussion / comparison regarding Board temporary masking rule. Discussion regarding supporting licensees, Governor Brown, OHA vaccination mandate as a Board.

Motion: Dr. Walter – moves for OBNM to adopt a temporary rule enforcing OHA vaccination mandate. Dr. Gibbons  $2^{nd}$ .

Vote: 6 yes / motion carries

AAG JTD left public session after above vote.

<u>Guest Dr. Matthew Hicks / Formulary / Ketamine:</u> Request / discussion to modify formulary / rules regarding the administration of ketamine by Oregon NDs. Discussion regarding using Ketamine to treat depression / trauma through sublingual method. More effective to treat through injection due to more accurate dosing. Expanding the formulary to afford more avenues of treatment / provider types would allow for more effective and cost-efficient treatment in Oregon. Suggestion to regulate by dose rather than administration – 3mg per kg a safe boundary.

Question regarding availability of training for practitioners. Rise in use and training due to the rise in psychedelics in mental health treatment. Many schools / trainings exist already in California (injection), AZ (injection), Washington (sublingual), and Dr. Hickes is working to put together a training in Pdx / Oregon. It's not a high risk or complicated treatment – 10 hours would be sufficient for NDs to administer the drug. Several clinics in Portland do infusions for solely a drug for treating depression. Evidence based treatment. NDs in Oregon are mostly interested in an integrated approach to partner with / involve use of psychotherapists to get the full spectrum of treatment possibilities. Important to have options.

Dr. Erfling initiated discussion / suggestion for the Board regarding whether it would be advantageous / possible to add Ketamine injection treatment to our new / emerging IV / Injection therapy rules. Injections of ketamine would be administered subq / same as a vaccine. Trainings would be focused on competence and safety, as well as the psychotherapy. Right now, those states that allow Ketamine injection for general primary care / psychiatric care do not require additional CE. Discussion regarding whether trusting NDs to do their due diligence to administer this drug safely, rather than have a rule mandating training, as with other treatments. Benefit of training is more the treatment than the administration of the drug.

Discussion regarding risk profile: Injection is the most common form. Nasal inhalation requires a significant amount of liquid and most goes down the back of the throat and dosage is difficult. Sublingual also presents a dosage problem, and it has an undesirable taste. Both nasal and sublingual are delayed reaction time, while injection is almost immediate. Risk profile same across administration.

NDs / physicians are looking to use Ketamine for additional uses; ALS, chronical pain syndrome. Ketamine is a safe and commonly used drug. Collaborative efforts across medical fields / associations to move Ketamine for depression from off label use to approval for depression. Ketamine treatment for off label use for depression / psychiatric use is common in the medical field.

Discussion regarding context of Ketamine on the formulary. Prior concerns of the formulary – dosage and atheization; proliferation of "pop-up" clinics, bias against due to psychedelic effects. Landscape has changed with the emergence of psilocybin. Board recommended to bringing this recommendation for change to the formulary for

<u>HB 2078 – Pain Management Education</u>: Board reviewed submitted draft rule language for mandatory pain management. Must be adopted by Jan. 1; but not effect NDs until 2022-23 renewal cycle.

Dr Walter / Dr. Erfling (2<sup>nd</sup>) Motion to submit draft rule for public comment. Vote: 6 yes / motion carries.

### **Review Proposed Rule Changes:**

- A. OAR 850-030-0035(1b): Criminal History Check Fee Change. Reviewed rule, discussion regarding need for it to be a temporary rule / effective immediately for this renewal cycle.
