Discussion regarding the availability of required CE – in particular two hours of required ethics. MB. Baptista will reach out to Dr. Zefland & Dr. Hicks regarding availability of ethics CE and report back at the February 2023 meeting. Looking forward to potential Board rules when OHA psylocibin rule is effective, Board members discussed changing the language in the rule to allow ethics CE in psychedelic and or dissociated state for compliance with the ketamine ethics CE requirement. Discussion regarding sending the rule back for public comment to make the Ethics course changes and provide ND's time to complete the CE requirements rather than requiring completion of the CE requirements as of Jan. 1 when the rule would go into effect. Board weighed the benefits / drawbacks the delay those changes would cause in implementation of the rule and whether the benefits of implementing Jan 1 - allowing licensees who have already completed the education and training required to prescribe injectable ketamine immediately vs. resubmitting a revised rule for public comment and adoption later this year.

Board member Dr. B. Walter made a motion to approve OAR 850-060-0210 & OAR 850-060-0223 as written. Board member Dr. R. Minarik seconded. Board approved.

Director's Report:

December Legislative Days: E-board only, OBNM did not have bills in front of E-board.

Governor-Elect Kotek priorities to work proactively and collaboratively with state agencies and ensure transparency.

New business Board member Dr. B. Walter asked about the IV therapy rule requiring training for upper body injections before being allowed to train / engage in lower body injections. Asked whether three was a scientific/medical reason for that requirement / the order the training was structured. Board Member Dr. R. Minarik explained that the subcommittee required the order of

injection because it perceived it as the order of complexity. The Board has received a few questions regarding the order of injection site in the rule and has responded on a case by case basis. At some point we will bring up this issue to determine if the rule should be changed.

The Board thanks Dr. T. Erfling and Dr. R. Skarperud for their contributions/service over 6 years on the Board.
