Thank you for your message Dr. Black. Unfortunately, there is misinformation being spread about this issue.

There is no standard practice in Oregon among health related Boards, other than discipline documents are public documents, and there is a high expectation from the Governor's office that each Board conducts Board business with the utmost transparency for the protection of the public.

Please know I checked in with my colleagues at other Boards, and nearly all health related medical boards post discipline on the Board website. Understandably, the manner in which each board has the discretion to post, may result in search engines indexing those discipline orders differently.

Dr. Cooper asserts that OBNM posts discipline in a manner that google indexes higher than other Boards. This may or may not be true, as multiple google searches on MDs and nurses (and others) have shown their discipline high on the google search as well. But unlike many other health boards, we only post the discipline on our website for five years. The Board disciplines approximately 8-10

licensees a year – less than 1% of the licensee base. The majority of licensees who are disciplined are on probation for 2-3 years.

The mission of the Board is protection of the patients and the public. Therefore it is imperative that the public is able to access that information in the most transparent manner possible. This issue is on the agenda for discussion at the meeting on Monday.

Dear Mary Beth,

I am writing to you because a fellow physician recently contacted me and brought to my attention how physicians with consent orders are listed on the OBNM website — and how these listings are picked up directly in Google searches.

While this has not significantly impacted my own established practice, I can see how this could seriously affect newer physicians who are just starting their careers. I have been in practice for 23 years, and for the past nine years, I have lived with a consent order publicly posted — an order that was not related to direct patient care or harm.

Having that information prominently appear in search results can become a lifelong professional burden, especially in today's digital age where online information is so easily amplified. For those new to practice, this could inhibit their ability to build trust with patients from the outset.

I believe public transparency is essential, but many other boards have adopted more balanced methods — for example, making disciplinary information accessible through a searchable database rather than directly indexing names and consent orders via public web pages. This allows due diligence without unnecessarily overexposing sensitive information in general web searches.

I encourage the Board to consider revising the current system to align with these more standard practices. A searchable tool would continue to protect the public interest while offering physicians a fairer chance to move forward professionally.
