## 3. Board Discussion For Public Member Appointment / ND Board Member Appointment:

- Reviewed Governor's statement regarding Board participation and her commitment to ensuring that all Boards and Commissions represent the growing age, racial and gender diversity of the state. https://www.oregon.gov/gov/Pages/board-list.aspx
- Board review of public member application for recommendation for nomination to the Board. Public member vacancy re/appointment necessary/required because Wright filled the seat left vacant when prior public member resigned mid-term.
  - O Board Vote 5-0 Recommendation for Nomination: re-appointment of current public member Kate Watkinson Wright, Oregon City, and a native Oregonian. Kate Watkinson Wright has served as a public member of the Board since December 2023. She holds a Bachelor of Science degree from Standford University and earned her Juris Doctorate at University of Oregon. Ms. Watkinson Wright has practiced employment law for nearly 20 years.
- Board reviewed all applications submitted by Oregon licensed naturopathic doctors to fill
  the upcoming vacant ND seat on the Board. Discussion regarding the current make-up of
  the Board and recommending applicants for nomination who were best suited to diversify
  and raise the efficacy of the Board; including years of experience practicing naturopathic
  medicine, filling practice gaps / expand the practice areas represented among the ND

members on the Board, enhancing inclusion of non-majority populations and geographic representation.

- Board Vote 5-0 Recommendation for Nomination: Dr. Shehab El-Hashemy, ND, Eugene/Lane County. Dr. El-Hashemy has a Bachelor of Medicine and Surgery degree (MBChB) from the Faculty of Medicine at Cairo University (Egypt), a Doctor of Naturopathic Medicine degree (ND) from the Canadian College of Naturopathic medicine (Toronto, Canada) and a 2-year postgraduate residency certification in family practice. He currently serves as a primary care physician for the Federally Qualified Health Centeres of Lane County. His clinical experience includes 13 years as a generalist healthcare provider focusing on Integrative Medicine and Developmental Pediatrics (Ontario, Canada), followed by 6 years as a primary care provider in Patient Cenetered Primary Care homes (Oregon, USA). He authored two books on Naturopathic family medicine and Integrative primary care.
