The Board of Naturopathic Medicine (Board) is the state agency responsible for licensing, regulating, and disciplining naturopathic physicians in the State of Oregon, pursuant to Oregon Revised Statutes (ORS) chapter 685 and Oregon Administrative Rules (OAR) chapter 850. Dr. Francis Lee Poe, N.D. (Licensee) is a licensed naturopathic physician in Oregon and is subject to the jurisdiction of the Board.

2.

The parties wish to resolve this matter informally, without any hearing, appeal or judicial review, by entering this Settlement Agreement and Consent Order, pursuant to ORS 183.417(3) on the terms set forth below. The Board finds, Licensee does not admit, but stipulates to the following:

- a. Dr. Francis Lee Poe has been licensed as a naturopathic physician in the State of Oregon since January 14, 2019.
- b. On or about May 11, 2022, Licensee refilled prescribed medication to Patient A that was outside of the scope of practice.
- c. Dr. Poe's prescribing outside the scope of practice constitutes conduct in violation of ORS 685.110(10): Prescribing or dispensing drugs outside the scope of practice.
- d. Licensee is subject to a reprimand.

- a. Licensee enters into this Settlement Agreement and Consent Order voluntarily and without any force or duress. Licensee states that the Board and Board staff have not made promises or representations not stated herein to induce Licensee to sign this document and agree to issuance of the Order.
- b. Licensee acknowledges that Licensee had the opportunity to seek the advice of legal counsel. Licensee further acknowledges that Licensee understands and agrees to the terms of this Order.
- c. Licensee understands that Licensee has the right to a contested case hearing under the Administrative Procedures Act (ORS Chapter 183), and fully and finally waives any and all right to a hearing and any rights to appeal or otherwise challenge this Settlement Agreement and Consent Order.
- d. Licensee acknowledges that this Settlement Agreement and Consent Order is a public document.
