**SETTLEMENT AGREEMENT AND
CONSENT ORDER**

1.

The Board of Naturopathic Medicine (Board) is the state agency responsible for licensing, regulating and disciplining naturopathic physicians in the State of Oregon, pursuant to Oregon Revised Statutes (ORS) chapter 685 and Oregon Administrative Rule (OAR) chapter 850. Wilson, N.D. (Licensee) is a licensed naturopathic physician in Oregon, and is subject to the jurisdiction of the Board.

2.

Licensee and the Board desire to settle this matter by entry of this Settlement Agreement and Consent Order. Licensee understands that he has the right to contested case hearing under the Administrative Procedures Act (chapter 183), Oregon Revised Statutes. Licensee fully and finally waives the right to a contested case hearing and any appeal therefrom by the signing of, and entry of, this Order in the Board's records. In lieu thereof, the parties wish to resolve this matter informally, without any hearing, appeal or judicial review, by entering this Settlement Agreement and Consent Order, pursuant to ORS 183.417(3) on the terms set forth below.

SETTLEMENT AGREEMENT

The Board finds, and the parties agree to enter the following agreement for the purpose of settlement:

3.

Dr. Wilson began treating Patient A in 2014. Patient A's chief complaint was chronic pain. Patient A was opiate dependent when he began treating patient.

4.

Dr. Wilson prescribed Patient A both extended release Morphine Sulfate and Oxycodone HCL, at varying levels, from February 2017-December 2018.

5.

Dr. Wilson conducted a urine drug screen in 2014 at the beginning of their clinical work, but not thereafter.

6.

Dr. Wilson did not regularly check Patient A's Prescription Drug Monitoring Program (PDMP) report.

7.

An MD prescribed Patient A Suboxone on July 11, 2018, through December 2018.

8.

Patient A told Dr. Wilson they were not taking Suboxone. Dr. Wilson did not suspect Patient A was diverting medication and believed they had an honest doctor- patient relationship.

9

Dr. Wilson acknowledged that taking Suboxone, Morphine and Oxycodone together are contraindicated and outside standard practice. Had Dr. Wilson checked PDMP or conducted regular urine drug screens he would have seen that Patient A was prescribed Suboxone from another provider and been alerted to the possibility that Patient A was either taking all of these drugs together or was diverting some of her medication.

10.

The Board finds that Dr. Wilson's prescribing practices for Patient A violated OAR 850-050-0010(1)(c)(A).

Licensee agrees that the Board may enter the Consent Order set forth below, including the following terms and conditions: Reprimand


- A. Licensee enters into this Settlement Agreement and Consent Order voluntarily. Licensee state that the Board and Board staff have not made promises or representations not stated herein to induce to signing this document and agreement to issuance of the Order.
- B. Licensee understands that this Settlement Agreement and Consent Order is a public document.
- C. This Settlement Agreement and Consent Order shall take effect on the date it is signed by the Board.
